FAMILY HISTORIES: Selection for use will be based upon documentation of data, clarity and presentation of material as well as general interest.


ARTICLES: Selection will be based upon general interest, documentation and presentation and must pertain to Middle Tennessee people or places.

TOPIC: Early Middle Tennessee Land Records - The Military District

The best kept secret in all of Tennessee research is the early Tennessee land records. At the May meeting, Irene Griffey will share some of the facts she has learned about these records. Some of the subjects discussed will be the purpose and boundaries of the military district, the process of receiving a military grant, who received the grants, where and how the records were kept and why the records are so difficult to understand and use. THE FAMILY HISTORY LIBRARY

The Family History Library, located in downtown Salt Lake City, Utah, opens its doors Monday through Saturday at 7:30 A.M. and remains open on Mondays until 6 P.M., Tuesday through Friday until 10 P.M. and Saturdays until 5 P.M. It is owned and operated solely by the LDS (Mormon) Church, although everyone is welcome to use the library free of charge. A typical day in the summer will see well over 5,000 people visit the building.

Each of the four floors open to the public have microfilm and microfiche machines, work tables, restrooms and a self-serve copy center. Xerox copies are five cents per copy for letter, legal and ledger size copies. Microfilm and microfiche copies are twenty cents each and can be made using a variety of lense magnifications.

The library has a small snack room with vending machines selling sandwiches, ice cream, fruit and soft drinks. One needs to go elsewhere for coffee. There are a variety of fast food restaurants, cafes and elegant dining opportunities within two blocks of the library. The downtown area is considered safe for walking all night long.

Salt Lake City has easy access by major highways from all four directions. The SLC International Airport in only ten minutes west of downtown and is served by shuttle busses and hotel vans as well as taxis. Amtrak has one of its major stops in SLC. Double-decker trains arrive daily from the west coast and from Chicago via Denver. The leisurely trip through the high mountain canyons and tunnels offers spectacular relaxing scenery and allows the genealogist ample time to organize files both before and after a trip to Salt Lake City.

If you need a break from reading microfilms, or happen to bring non-genealogists along with you, there are many ski resorts within an hour's drive of downtown. They offer many opportunities both winter and summer. Park City has both the old and the new and the evening Summer Theater at Robert Redford's Sundance Ski Resort is a real treat of outdoor mountain pleasure and enjoyment.

Fifty years ago a microfilming project was begun in an effort to preserve many kinds of genealogical records by sending Mormon missionaries on microfilming missions throughout the world. This effort has now grown into an extensive project that adds over 60,000 rolls of film to the collection annually. There are 35 crews filming in the United States every day and about 100 other crews filming in foreign countries. Microfilms are also purchased directly from many state archives and other organizations.

The films are processed in granite vaults located in the Wasatch Mountains just east of the city. The original microfilm is left for storage in the vaults and a copy is sent to the library downtown. Copies can be ordered by Branch LDS Libraries around the world as well. The main library now has over one and a half million rolls of microfilm, on both 35 mm. and 16 mm. film. The library is equipped with about 500 microfilm readers on the four floors that are open to the public. There is also an additional floor that is used only by the cataloging department.

The microfilms in the collection contain a variety of types of records from many sources. Some records come from private collections, from organizations and societies, such as the Daughters of the American Revolution and Sons of the American Revolution.

Copies of church records from the Colonial period, often into the 1900's are often filmed for many denominations, including, the Quakers, Congregational, Dutch Reformed, Lutheran, Presbyterian, Methodist and Baptist Churches. Oftentimes many churches have published volumes for various anniversaries of their parishes and congregations and many of these are in the library in book form, microfilm or both.

The bulk of the microfilms in the FHL are the public court records from a substantial percentage of the county court houses from around the country. These include deeds, mortgages, wills and probates, guardianship papers, naturalizations, tax records, birth, marriage and death records and a variety of other records that pertain to the various states and counties.

Due to rights of privacy acts, when microfilming began, the records in the court houses were filmed from the beginning of existing records through about 1900. Filming was begun in the eastern states which had the oldest settlement, the largest population and a great amount of genealogical material. Today, the FHL collection of court records covers basically all states east of the Mississippi River, plus a rapidly growing collection for the states of Minnesota, Wisconsin, Missouri, Texas, Oklahoma, Iowa, Arkansas, Utah and California. Records for other states also exist in the collection, although not to the same extent.

The Family History Library has one of the largest collections of family histories in the country. Thousands of volumes are kept on the main floor, alphabetized by the main surname in the book. Many family histories are on microfilm. One of the best genealogical indexes in the library is the "Surname Index" which indexes all family histories in the collection, not only by the title of the book, but also by the secondary surnames within the histories. A geographical location is usually included.

The old card catalog is now history. The index to the collection is now only on microfiche cards, except for the catalog to oriental records. The primary index for the library collection is under a geographical listing. For American records, the researcher needs to look first for the desired state, then under the county. Within a given county, records will be listed under the type such as Biographical, Census, Church, Court, Land & Property (deeds). Military, Naturalization, Probate, Vital (birth, marriage, death, cemetery), etc.

Upon locating the records desired from the Locality File, you will be given either a book number, microfilm number or microfiche number along with the floor where the records are housed. You locate the books and films yourself from the shelves and cabinets and may use them all day, if you wish. The books are kept on open stacks so that browsing all materials for a particular county or state is possible. Record Attendants are available to help locate materials when necessary. General Reference consultants can assist anyone with individual research problems.

All public U. S. census records from 1790 through 1910 are available on microfilm for all states as well as all existing census indexes. Besides being listed in the microfiche catalog, there are separate registers for easy access to film numbers. The 1920 census and its soundex index will likely be made public in two or three years. Several individual states have taken their own censuses at various times and many of these are microfilmed and available for use at the library. Content varies.

A major collection in the library is the passenger list collection for all major ports in the U. S. Included are the ports of New York City, Philadelphia, Baltimore, Miami, New Orleans, San Francisco, Seattle and many other smaller ports on both coasts. Most of these ports have records from about 1820 and are microfilmed well into the twentieth century. Some ports have indexes. There is also a list for all border crossing points, beginning in 1894 for persons immigrating to the U. S. through Canada.

Military records are especially useful to the genealogist. They contain not only military information, but also can give birth dates, places, residences throughout one's life, other relatives and endless miscellaneous information. Both service and pension records for the Revolution are microfilmed. Indexes of other wars, including the Spanish-American War and World War I are also available. The actual records and pensions are currently being filmed for the War of 1812 and the Civil War. Many states, as well as the federal government, have separate records that have been filmed and are in the FHL.

Some examples of larger collections, often on a state-wide basis are vital records for Connecticut, Kentucky, Illinois, Wisconsin, Oregon and California. A comprehensive naturalization index for the six New England states dates from 1790 to the mid-1900's. Tax records date from the 1790's to about 1900 for the counties of Kentucky. Colonial records, such as those for North Carolina, include the equity and probate packets. Telephone directories or phonefiche, for a current date, are available for most of the U. S. and Canada as well as many foreign countries.

One important collection currently being filmed in the National Archives is the World War I draft registration cards. These are on 5" x 7" cards and were recorded in mid 1917. They list virtually all men in the U. S. who were born between 1870 and 1900, whether a citizen or alien. The exact date and place of birth are recorded along with current employer, dependents, general physical description and current address. The registration cards are filed by first letter of the surname and are usually kept on a county basis, except for larger cities. This collection is being filmed alphabetically by state and the project is now just nicely under way.

The court records, including vital records, are filmed for nearly every county in Ohio and Michigan to at least the early 1900's. Some county records are filmed to the 1970's. These two states have excellent county records, including deeds, probates, guardianships and naturalizations, plus some scattered state census and tax records. The microfilming in Indiana and especially Illinois is rapidly being completed. These states are important to the Midwestern researcher.

Besides U. S. records, the Family History Library has a large foreign collection of books and microfilms. The Canadian collection is maintained on the second floor with the U. S. collection. The bottom floor, the Second Basement, of the library is for the British Isles. The British records include most parish registers for the Anglican Church as well as non-conformists parish registers, testaments, maps, local histories, family histories, reference books and a rapidly-growing collection of court records. The Irish collection, on the same floor, is less extensive because of major losses of records in Dublin Archives in the 1920's.

The Scandinavian and Continental European countries are housed on the First Basement Floor. All Scandinavian countries have an excellent collection for parish records, probates, census and military records, plus minor types of records. This collection is probably the best in the library.

Although not quite as complete as Scandinavia, other European countries have substantial collections, such as Holland, France, Belgium, Germany, Hungary, Italy, Spain, Portugal, Switzerland and others. The Mexican collection, also kept on the same floor, is very complete and after the United States, has more films than any other country.

A person or group planning a trip to the FHL from out-of-state is advised to be aware of what types of records are needed for one's individual research and which of those records are preserved in Salt Lake City before arriving. This will save valuable research time.

The Family History Library has its own accreditation program and accredits professional researchers. A list of accredited researchers is available. Researchers are listed by their speciality of geographical region. Their skills and rates vary as do their systems for sending reports to the clients. Research can be done by correspondence. Many of the professionals are willing to work with individuals visiting the library to maximize one's time and results.

Timothy Laitila Vincent, partially of Finnish background, is a professional researcher. Having been born in Michigan, he was educated at Mid-Michigan Community College in Harrison, Michigan, the University of Helsinki, Finland and Brigham Young University. Mr. Vincent is the only Lutheran to become an accredited researcher in the LDS Family History Library. He specializes in Finnish, Swedish and American research.

SOLDIERS KILLED AT THE BATTLE OF FRANKLIN. TN

LOUISIANA

Pvt. Benjamin T. Atkins, [], Co. A. 12th Louisiana, (mw&c). Died 1-3-1865 Nashville Prison Hospital. Buried Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. Trissillian Bullock, [], Co. I. 12th Louisiana, (mw&c). Died 2-5-1865 Louisville. Kentucky Prison Hospital. Buried Cave Hill National Cemetery. Confederate Section. Louisville, Jefferson County, Kentucky. Grave #25R62.

Pvt. James M. Keiger, [], Co. H. 12th Louisiana, (mw&c). Died 2-6-1865 Nashville Prison Hospital. Buried Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County. Tennessee. (Unmarked).

Sgt. Ralph S. Law, [22], Co. F. 12th Louisiana, (mw&c). Died 1-18-1865 Nashville Prison Hospital. Buried Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County. Tennessee. (Unmarked).

Pvt. James M. Rise [], Co. H. 12th Louisiana, (mw&c). Died 2-2-1865 Nashville Prison Hospital. Buried Mt. Olivet Cemetery, Consederate Circle, Nashville, Davidson County. Tennessee. (Unmarked).

Pvt. E. M. Tims, [], Co. H. 12th Louisiana, (mw&c). Died 2-11-1865 Nashville Prison Hospital. Buried Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County. Tennessee. (Unmarked).

NORTH CAROLINA

Pvt. Alma Peterson, [25], Co. G. 29th North Carolina, (mw&c). Died 5-8-1865 in Nashville Prison Hospital. Pvt. Peterson was mortally wounded late on the night of November 30 when his regiment arrived on the battlefield and occupied the captured trenches. Pvt. Peterson is buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County. Tennessee. (Unmarked).

ARKANSAS

Pvt. William B. Cone []. Co. D. 9th Arkansas, (mw). Died Buried Rose Hill Cemetery, Confederate Section, Columbia, Maury County, Tennessee. Grave #75.

Ord. Sgt. Henry B. Cornelius, [24], Co. H. 1st Arkansas (Mounted Rifles), (mw&c). 1-3-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle. Nashville, Davidson County, Tennessee. (Unmarked).

- Pvt. E. F. Creed, [], Co. D. 9th Arkansas, (mw). Died December 1864. Buried in Rose Hill Cemetery, Confederate Section, Columbia, Maury County, Tennessee. Grave #76.
- Lt. T. C. Farley, [], Co. a. 2nd Arkansas, (mw). Died December 1864. Buried Rose Hill Cemetery, Confederate Section, Columbia, Maury County, Tennessee. Grave #68.

Pvt. James W. Johnson, [25], Co. H. 19th Arkansas, (mw&c). Died 5-27-1865 Nashville Prison Hospital. Pvt. Johnson was severely wounded in the right leg which required amputation by Surg. Ruskin, C. S. A. on December 1st, 1864 in Franklin, Tennessee. Pvt. Johnson is buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. John Ruth, [32]. Co. H. 6th Arkansas, (mw&c). Died 3-26-1865 in Nashville Prison Hospital. Both of Pvt. Ruth's elbow joints were fractured by an artillery shell and on December 1st, Surgeon Cooper, C. S. A. amputated his left arm. On January 2, 1865 his right arm was amputated due to gangreen. He died due to exhaustion and is buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

GEORGIA

Pvt. Benjamin Franklin Causey, [21], Co. F. 46th Georgia, (mw&c). Died 3-8-1865, Nashville Prison Hospital. Buried Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessec. (Unmarked).

Pvt. Seaborn J. Collins, [], Co. F, 46th Georgia (mw&c). Died 3-1-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked)

Pvt. James M. Elliott, [], Co. F. 46th Georgia, (mw&c). Died 1-20-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. Richard D. Feaster, [], Co. H. 25th Georgia, (mw&c). Died 3-4-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Cpl. John G. Garrett, [], Co. B. 65th Georgia, (mw&c). Died 3-7-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle. Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. Charles E. Hancock, [], Co. I, 30th Georgia, (mw&c]. Died 4-6-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. Adsalom O. Hardy, [22], Co. G. 30th Georgia, killed while carrying the regimental colors. Buried in Noah's Ark Cemetery, Henry County, Georgia.

Pvt. Jackson Holmes, [], Co. G. 37th Georgia, (mw&c). Died 1-19-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. Timothy Lanier, [], C. I. 29th Georgia, (mw&c). Died 1-5-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemetery, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

- 1st Sgt. William T. Phillips, [], Co. H. 46th Georgia, (mw&c). Died 4-19-1865 Point Lookout Prison. Buried Prison Cemetery, Point Lookout, Maryland.
- Col. George A. Smith, [], 1st Georgia (Confederate), moved from Georgia Section of the Franklin Confederate Cemetery, Section 77, Grave #1 at an unknown date. Reinterred in Rose Hill Cemetery, Macon, Bibb County, Georgia.
- Sgt. James E. Wright [19], Co. F. 46th Georgia, (mw&c). Died 2-1-1865 Nashville Prison Hospital. Buried in Mt. Olivet Cemeter, Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

SOUTH CAROLINA

Pvt. Allen Busby, Co. K. 19th South Carolina, (mw&c). Died 12-19-1864 Nashville Prison Hospital. Buried Mt. Olivet Cemetery Confederate Circle, Nashville, Davidson County, Tennessee. (Unmarked).

Pvt. William J. Crapps, [33], Co. D. 24th South Carolina, (mw&c). Died 3-11-1865 Nashville Prison Hospital. Pvt. Crapps was wounded at Franklin by a musket ball, which entered the external lateral aspect of the left ankle fracturing the inferior end of the fibula and opening the ankle joint. He was taken prisoner and admitted to Hospital No. 1 at Nashville, four weeks after receiving the injury. On February 17, 1865, his leg was amputated at the lower third by Surgeon B. B. Breed, U. S. V. At the time of the operation Pvt. Crapps was much exhausted and suffering from obstinate diarrhea. Pvt. Crapps is buried in Mt. 
CARNTON - NATIONAL HISTORIC LANDMARK HOUSE AND CONFEDERATE CEMETERY Franklin, Tennessee

Carnton and the cemetery are at the end of Carnton Lane, which is off Lewisburg Pike (U. S. 431) one mile southeast of Franklin. After the Battle of Franklin, Mr. and Mrs. John McGavock donated two acres adjoining the family graveyard as a cemetery, and in April 1866 this plot became the peaceful resting place for 1,481 Confederate soldiers who died at Franklin and whose bodies were removed from temporary graves on the battlefield.

Carton was built more than a century and a half ago by Randal McGavock. The mansion was completed in 1826. The house is being restored to its original grandeur by Carnton Association, Inc.

The night of November 30, 1864, found the rear lines of Stewart's Corps on the lawn at Carnton and in "McGavock Grove." A steady stream of dying and wounded was brought to the house throughout the night. Dawn found all but one room filled with wounded, the floors soaked with their blood and the bodies of five Confederate Generals stilled in death and lying on the long back porch.

ROOTS III USERS INTEREST GROUP WORKSHOP

The ROOTS III Users Interest Group held its first workshop in the Micro Computer Laboratory in Swayne Hall at David Lipscomb University in Nashville on March 25, 1989. Fourteen members attended this "hands-on" workshop conducted by Mr. Brian Harney of Lexington, Kentucky. The workshop began at 8:30 a.m. and concluded at 4:45 p.m. with a thirty minute "bring your own sandwich" lunch break.

Using the Kennedy Family tutorial included in the ROOTS III package, Mr. Harney addressed the basics of the ROOTS III software. The students' wide range of understanding of both computer expertise and the ROOTS III software dictated a rather slow elementary instructional approach. Each student had his/her own computer and each two students shared an Epson/IBM printer. While all of the basics were covered some of the more esoteric features of ROOTS III software were left to be addressed at later meetings of the interest group.

At the conclusion of the workshop those in attendance indicated that they would like future Interest Group meetings on a regular monthly/bi-monthly basis to be held on Saturdays in Nashville. Perhaps eight two and one-half hour sessions per year held in those months in which the MTGS does not meet should be considered as a starter and later adjusted to meet the needs of the RIG.

DEFINITION

Many times reference is made to "Administrator de bonis non" in estate settlement records. The definition is given in Abraham Caruthers' <u>History of a Lawsuit</u> (Cincinnati: The W. H. Anderson Company, 1888; revised 1919) as follows:

"De bonis non. Concerning (or, of) goods not (administered). If an administrator dies before finishing the administration, his successor is called administrator de bonis non, i.e., he is to administer on that part of the estate not administered by his predecessor. If such a person succeeds an executor, the words cum testamento annexo (with the will annexed) are added."

1840 CENSUS WHITE COUNTY, TENNESSEE

This concludes the publication of the 1840 White County, Tennessee, census contributed by Byron and Barbara Sistler, Nashville, TN. The format is being changed for clarity of print. The Sistlers have also contributed the 1840 Census of Robertson County, Tennessee, which will be published in succeeding issues of <u>Middle Tennessee Genealogy</u>.

The figures following each name represent composition of the family by age and sex. Each digit stands for a number in the column on the original schedule (zeros omitted after the last number inserted).

Columns on the schedules are, in order, males 0-5 years, males 5-10, males 10-15, males 15-20, males 20-30, males 30-40, males 40-50, males 50-60, males 60-70, males 70-80, males 80-90, males 90-100, males over 100. To the right of these are 13 identical columns for females.

A household with figures as follows:

120001-103001001

means it was composed of 1 male under 5, 2 males 5-10, and 1 male 30-40; 1 female under 5, 3 females 10-15, 1 female 30-40 and 1 female 60-70.

This transcription does not include statistical detail on Blacks, either free or slave, though "free colored" are shown by name where they were heads of household. You will notice a number of names followed by 0-0. These are Blacks who fit the "free colored" category.

Supreme Court Records, Box 135, Middle Tennessee, 1859 James W. Gee vs Henry Graves

At a court of chancery at Nashville for the county of Davidson, TN on 1 November 1858 the following proceedings were had in said court in the cause wherein James W. Gee and others are complainants and Henry Graves and Susan Graves are defendants.

Bill of Complaint filed 18 March 1857.

To the chancellor of the Middle Division of Tennessee, James W. Gee, Laura L. Gee, Rosannah Gee, Henry Case and Marietta his wife, late Marietta Gee, Josephine Gee and John Taylor, citizens of Davidson County, TN, complainants bring this their bill of complaint against Henry Graves and Susan his wife, late Susan Harris, daughter of William Harris, late of Davidson County, TN dec'd defendants...and say that they the said James W. Laura L., Rosannah, Marietta and Josephine are the children and heirs at law and devisees

and legatees of Wm. W. Gee late of Davidson Cty., TN dec'd. and the said John Taylor is his administrator de bonis non with the will annexed. That on the 13th day of April 1839, the said William W. Gee made...his last will...in which he gave to his children all the residue of his estate...that the said William W. Gee died on the 15th day of the same month of April 1839 and left surviving him and entitled to his estate, his widow, Mary the mother of your orator and your orators except said John Taylor...

Supreme Court Records, Box 137, Middle Tennessee, 1859 High, admr. of M. Perry, vs. High

...at a chancery court held at Carthage for Smith County, TN on 8 August 1859 ...that on 31 December 1858 Mitchell Perry admr. of James High, dec'd., filed his bill of complaint in the chancery court at Carthage against John High and others, which is in the words...as follows:

...The Bill of Complaint of Mitchell Perry filed as admr. with the will annexed of James High late a resident of said county deceased, and also in his own right as one of the residuary legatees mentioned in the said will -- against Winston High John High and William High brothers of testator, Elizabeth Clay, sister of testator, Robert Knight and Charity Warrin, nephew and niece of testator and son and daughter of Ruth Knight a deceased sister of testator, Rufus Perry, Winston Perry, Gabriel D. Beasley and Sarah his wife, Samuel Sullivan and Rebecca his wife and William C. Sypert and Permelia B his wife; also nephews and nieces of testator and sons and daughters of Mary Perry dec'd sister of testator, Robert [blank] Roe Hunt, James A. Crews and Martha his wife _[?] and Monty his wife also sister of testator; Rufus High, Jas. T. High, John C. Bridgewaters, Sampson McClenan and Charity H. his wife. The said Rufus High Jas T High Charity H and John C. Bridgewaters, being legatees named in said will. Complt. is a citizen of Smith County. TN; said William High, Rusus High, Winston Perry and Sypret and wife are citizens of the state of Texas; said James T. High is a citizen of Kentucky; said Robert Hunt, Crews and and wife are citizens of the state of North Carolina and said John High, Winston High, Rufus Perry, Gabriel D. Beasley and wife, John C. Bridgewaters, McClenan and wife, Robert Knight and Charity Warrin are citizens of said county of Smith. Tennessee; said Elizabeth Clay is a citizen of Wilson County, TN; said Sulivan and wife are citizens of Macon County, TN....that the said Jas. High dec'd, departed this life in the month of February 1858 in said county of Smith possessed of a large estate in real and personal property that he died single and without child or children...

Supreme Court Records, Box 135, Middle Tennessee, 1859 Vaughn et al vs Johnson et al

...on 21st December 1857 there was filed in the office of the clerk and master of the chancery court at Smithville and State of Tennessee, a bill...

The bill of complaint of Claborn Vaughn, Francis Hencely[?] Martha Smith and Mary T. Johnson who sues by her son and next friend the said Clabourn Vaughn, against John Johnson a citizen of DeKalb County, and Joseph Johnson a citizen of Putnam County, TN...that complainant Mary T. is the wife of defendant John, that her name before her marriage to defendant John was Mary T. Vaughn that she and her present husband were married in what was then Warren County, TN in the year 1835 that before aforesaid marriage complainant Mary T. was the owner and had in her possession six valuable Negroes...



COPYRIGHTS IN QUESTION

A recent ruling regarding copyrights states that public record books do not contain enough original authorship to qualify for copyright. The National Genealogical Society has expressed concern over this ruling which they believe may discourage compilers from publishing such materials. NGS is urging its members to contact their Senators and Representatives, based on the information that the Subcommittee on Libraries and Memorials (House) will be holding oversight hearings pertaining to this problem sometime this spring.

JOURNEY TO PENNSYLVANIA by Gottlick Mittelberger. Edited and translated by Oscar Handlin and John Clive. Published by the Belknap Press of Harvard University Press, Cambridge, Massachusetts, 1960, 102 pp.

While reading this book, genealogists whose research has led them through Pennsylvania and the port of Philadelphia back to Wurtemberg, Durlach, Palatine or Switzerland in the 1750's will receive a vivid description of the hardships and sufferings experienced by their ancestors. More than thirty thousand Germans came into Pennsylvania between 1749 and 1754 under the conditions described in this book.

Gottlick Mittelberger accompanied musical organs purchased by the Reverend Henry Melchior Muhlenberg from Germany to Pennsylvania in 1750. He was so shocked by the contrast of the actual travel conditions he experienced with that pictured by the Dutch traders (called Newlanders) who solicited and arranged travel for the immigrants that he vowed to return home and publish the truth to his remaining countrymen contemplating emigration.

In this book, Mittelberger describes the exorbitant expense of traveling down the Neckar and Rhine to Rotterdam in Holland, a trip that took four to six weeks. The Rhine boats passed by thirty-six different custom houses between Heilbronn and Holland. From Rotterdam he sailed with approximately four hundred others across the North Sea to Cowes where he experienced a delay of nine days. The entire trip lasted from the first of May until the end of October.

Of necessity, most of the immigrants upon arriving in Philadelphia were forced to indenture themselves for years to pay off their debt of travel. Many families were permanently separated and never saw each other again.

This book will make the lives and environment of the reader's German ancestors appear real.
