Also Shirley Wilson has agreed to talk to the group which meets at 10 a.m. that morning in the Tennessee State Library and Archives Auditorium on "Land Records in the Public Land States." Also she is willing to answer questions so come, listen, learn and then ask your questions.




BARBARA SISTLER

Supreme Court Records, Box 137, Middle Tennessee, 1859 John Jones vs James Dement (Judgment rendered 5 April 1858 in County Court of Rutherford County)

John Jones, Clerk and Commissioner for the use of R. W. Willett, Samuel A. Cartwright, William Cartwright, Thomas Cartwright, Baldwin Cartwright, Thomas Thisell(?) and wife Ann, William R. Hadden and wife Julia, Artamissa Scott, Leah Winn, C. Ashford and wife Emerilla, William Magruder, Greenberry Magruder, Ashton Garrett and wife Ann, S. Moreland and wife Caroline, distributees of Sarah Wade, dec'd.

James T. Dement, Thomas Kirkpatrick, and H. A. Drennan

...this cause came on to be heard...25 January 1859 upon the transcript from the County Court of Rutherford County where it appeared that there is no error in the proceeding had in this cause nor in the judgment rendered in this cause on the 5th day of April 1858 against the defendants for \$961.83 and costs of the cause. It is therefore considered by the court that said judgement of the County Court of Rutherford County be in all things affirmed and that said John Jones, Clerk and Commissioner, for the use of etc., recover of James T. Dement, Thomas Kirkpatrick, and H. A. Drennon the sum of \$961.83 and the cost of this cause in the Court ...

Supreme Court Records, Box 140, Middle Tennessee Bates vs Sewel et al

(Original Bill filed in Cannon County on 2 April 1860)

Be it remembered that at a court of Chancery began and held for the County of Cannon ...the second day of April 1860...

The Bill of Complaint of Ulyses P. Bates, William L. Bates and Lucy Ann Bates, citizens of Cannon County, TN, who are children and minor heirs of William Bates, deceased, and who sue by their regular guardian, Samuel R. James against

Francis M. Sewel and wife Abigal, Susan Bates, residents of the Western District, in said State; Harmon St. John and wife Martha who are non-residents of this State and supposed to be residents of the State of Texas; A. W. Smith and wife Elizabeth who are residents of the State of Alabama; Samuel N. Burger, a resident of Coffee County, TN; and Abraham Burger, a resident of Cannon County, TN, Defendants.

Complainants ...state that their father William Bates died in Cannon County several years since intestate, and David M. Jarett was duly appointed, gave bond and qualified as Administrator of the estate of said deceased by the County Court of said Cannon County, and has long since paid all the debts of said deceased and fully wound up and closed his said administration. Complainants would further show that the said deceased left a widow and your complainants and defendants Abigal wife of Francis M. Sewel, Susan Bates, Martha wife of Harmon St. John, Elizabeth wife of A. W. Smith his children and heirs at law. Complainants will further show that said deceased at the time of his death was the owner of a large real and considerable personal estate that after the payment of all the debts of said estate the residue of the personal estate have been distributed amongst those entitled according to law....

Supreme Court Records, Box 140, Middle Tennessee Massey vs McConico

Sarah B. Massey by etc. vs Lemuel B. McConico

On the 18th day of March 1848 Lemuel B. McConico intermarried in the county of Bedford in this State with Priscilla R. Judkins who then was and had been for several years previously a resident of said County of Bedford. Immediately on such marriage she moved home to his residence in the County of Williamson and the petitioner Sarah B. Massey one of her children by a former husband came to live with her. The said Priscilla was at the time of such marriage the guardian in the County of Bedford of the said Sally B. and in the year 1850 Lemuel B. McConico having been appointed by the County Court of Williamson her guardian, the guardianship was removed from the County of Bedford to the County of Williamson. Sarah B. Massey from the time of her mother's intermarriage with McConico resided in the family of McConico in the County of Williamson except when absent at school. She was placed by him at school in Columbia and John R. Massey without his knowledge or consent took her from thence to the County of Lincoln and shortly thereafter and on the 1st day of October 1857 procured himself to be appointed her guardian by the County Court of Lincoln. On the 1857 she by her next friend exhibited her petition to the County Court of Williamson to have her guardianship removed from the said County of Williamson to the said County of Lincoln upon the ground that her half-brother and half-sister resided there and she wished to live with or near them....

Supreme Court Records, Box 140, Middle Tennessee, 1860 Waters vs Barton et al (Cannon County, TN)

Clem R. Waters and wife Elizabeth J.

V:

Wm. Barton, James R. Taylor, and others Bill and Cross Bill

Complainant is the only heir of David A. Barton, dec'd., who died in Robinson County, Republic of Texas, intestate in December 1844, leaving a widow and complainant who was an infant not one year old surviving him; the widow died in May 1845, the child Complainant Elizabeth Jane only surviving. This bill was filed to recover two negroes one by the name of Henry now in the possession of Defendant Wm. Barton, the other by the name of Mark in the possession of Joseph Ramsey, and hire for said negroes from November 1845 to the present time. Complainant claims title to said negroes through her father, she being the sole heir, under the following circumstances, David A. Barton was a son of Joshua Barton, dec'd., and brother to defendant William Barton, Hannah Ramsey and Elizabeth Taylor. David A. being a young man went to Texas in the year 1837 and carried with him a negro boy by the name of Dan that his father had gave him, and in 1839 sent the negro back to his father in Cannon County, TN, and in 1842 D. A. Barton married in Robinson County, Texas and returned to Tennessee that year for his property and marriage portion and returned in October 1842 to Texas, carrying with him the two negroes Henry and Mark. David A. Barton, during the time he had the negroes in his possession up to his death claimed the negroes as his own property, saying that his father had given him Mark and he had swapped his boy Dan to his father for Henry. After the death of D. A. Barton's widow, Samuel B. Kelough the administrator of D. A. Barton took possession of said slaves and held them as the property of said estate until they were taken out of his possession by an order of the district court of Robinson County, Texas and placed in the hands of Elizabeth McGrew, the grandmother, and regular guardian of Elizabeth Jane who kept said negroes in her possession claiming them as the property of her ward until sometime in November 1845. The negroes were clandestinely taken out of Mrs. McGrew's possession, brought to Tennessee and delivered to Joshua Barton, now deceased, William Barton's testator...

Supreme Court Records, Box 140, Middle Tennessee, 1860 Barton vs Barton

(Original Bill heard in Cannon County)

At a court of chancery began and held for the County of Cannon1 October 1860....original bill: Elizabeth J. Barton, a citizen of the state of Texas and County of Limestone, a minor under the age of 21 years, who sues by her next friend J. L. Fare(?), a citizen of DeKalb County, TN, Complainant

against

William Barton, Administrator with the will annexed of Joshua Barton, dec'd. and William Barton, James R. Taylor and his wife Elizabeth Taylor, citizens of Cannon County, TN and Joseph Ramsey and wife Hannah citizens of Bedford County, TN, and David Ramsey, Sr., a citizen of Warren County, TN, Defendants.

Complainant Elizabeth J. would respectfully show unto the court that her father David A. Barton died in Robison County, Texas in the year 1844 intestate, leaving a widow who died in the year 1845 and leaving complainant his only distributee after the death of his widow. Complainant will further show that one Samuel B. Kelough was duly appointed by the Probate Court of Robison County, Texas Administrator of the estate of the said deceased D. A. Barton.....

Supreme Court Records, Box 141, Middle Tennessee, 1860 Reece Porter and others

J. W. Greer and others

(Original Bill in Bedford County Chancery Court, 3rd Monday October 1860)

The Bill of Complaint of William Porter, Reece Porter, Stephen Porter, Elizabeth Porter and Sarah Porter, all of whom reside in the State of Texas, filed in the Chancery Court at Shelbyville

against

John W. Greer, Thomas S. Mayes, and William Carlisle, who reside in Bedford County, TN, and Reece Porter and wife Elizabeth Porter and John Talliaferro who reside in the State of Texas.

Will of Benjamin Taliaferro:

State of Tennessee Bedford county

In the name of God, Amen, I Benjamin Taliaferro of the state aforesaid being low in body but sound in mind and memory do make this my last will and testament in order to the closing of all worldly business.

First: I give my body to the dust from whence it was taken, and my soul to God who gave it. I give to my beloved wife Adria Taliaferro negroes to wit: Handy, Harry, Creasy, and David, together with ninety acres of land including the plantation whereon I now live with the dwelling house and outhouses, also fifty acres of land that I purchased of Newton Cannon, also four beds, bedsteads and furniture, a bureau, two trunks and clock, also two horses beasts her choice, four milk cows and four head of dry cattle her choice and fifty head of hogs, twenty-five geese, ten head of sheep and all the crop of corn and fodder on the premises also all the kitchen furniture with 8 chairs, all to be at her disposal.

Next, I leave for the benefit of the heirs of my son Richard four negroes, to wit: Reddick, Sylvey, Eliza, and Dolly, to be sold on a twelve months' credit to the highest bidder and the money arising therefrom put to interest by my executors until they respectively come of age or marry at at which each one to draw their proportionable part. I also deposit in the hands of my executors fifty acres of land whereon my son Richard now lives who are directed to be him the said Richard to remain on said land if he thinks proper to do as rent free until his youngest child becomes of age at which time I wish said land sold on twelve months' credit and the proceeds equally divided between the heirs of my said son Richard. But should he the said Richard Taliaferro choose not to continue thereon my executors as aforesaid are directed to put the same [to rent?] until the youngest child as aforesaid becomes of age, then to be sold and divided as above stated.

I next leave to my daughter Sarah Brown four negroes, to wit: Marian, Polly, Mariah, and Sally, who is to have possession immediately after my decease, also I give her no land, her legacy by valuation to be made equal out of the proceeds of that part of my estate which will be sold.

I next leave my son John four negroes, to wit: Samuel, Esther, Milly, and Charlotte to have possession at my decease, also fifty acres of land where he formerly lived and has now rented out.

I next leave to my son Charles three negroes, to wit: Bill, Bonaparte and Harriet, also fifty acres of land more or less, adjoining my plantation on the West, Alfred Balick on the South, Alexander Ray on the East and of John Taliaferro on the South, possession at my decease.

I next leave for the benefit of the heirs of my daughter Elizabeth Porter four negroes, to wit Susannah, Giles, Levi and Nanney, to be sold on a credit of twelve months to the highest bidder and the money arising therefrom put to interest by my executors until they respectively become of age or marry at which time each one to draw their proportionable part, also I deposit in the hands of my executor fifty four and three quarters acres of land whereon my said daughter Elizabeth Porter now lives, who are directed to let her the said Elizabeth remain on said land if she thinks proper to do rent freee until her youngest child comes of age, at which time I wish the said land sold on a credit of twelve months and the proceeds thereof equally divided between the heirs of my said daughter Elizabeth Porter, but if she should not choose to continue thereon my executors as aforesaid are directed to put the same to rent until her youngest child as aforesaid becomes of age then to be sold and divided as above stated.

I next leave my daughter Frances Greer four negroes, to wit: Thomas, Fillis, Stephen, and Patrick, who is to have possession at my decease also sixty dollars out of the proceeds of that part of my estate which will be sold as I give her no beast.

The balance of my estate both real and personal to be sold on a twelve months' credit and the proceeds therefrom to pay all my just debts, the balance will be for equalling of their several legacies heretofore given. It is my wish that immediately after my decease each of the legacies of my children be received and made equal by the aforesaid proceeds arising from the sale.

Lastly I constitute by appointing my beloved wife Adria as executor with my son John Taliaferro and my friend Melchizedek Brown executor to this my last will and testament revoking all others. In testimony whereof I have hereunto set my hand and seal this fourteenth day of February in the year of our Lord eighteen hundred and twenty three.

(signed) Benjamin Taliaferro.

Witness: Henry Moore

Codicil or Verbal Will:

I want my son Richard Taliaferro to have in his possession the land and negroes given to his children immediately after my decease. Dolly, a little child died of their lot, I value at fifty

dollars to be paid to him out of the money arising from the sale to be made by my administrator.

I want my daughter Elizabeth Porter and children to have in their possession the land and negroes I have allotted them immediately after my decease.

I want my daughter Sarah Brown to have one and fifty dollars paid to her by administrator out of the money arising from the sale of that part not disposed of by me as her girl Sally died out of her lot of negroes.

I certify that the above codicil was read by me to Benjamin Taliaferro, dec'd. in his lifetime when he was in his proper mind and acknowledged it as being part of his last will and testament in presence of me, Melchizdek Brown, Thomas Norsworthy.

Supreme Court Records, Box 142, Middle Tennessee, 1860 Fitzgerald heirs vs Joseph Jared (Original Bill heard in Putnam County)

Be it remembered that at a Circuit Court began and held in and for the sixth Judicial Circuit in the County of Putnam and said state in the court house in the town of Cookeville on the fourth Monday of August it being the 27 day of said month in the year 1860...

In the suit of Mary Ann Fitzgerald, Eizabeth P. Fitzgerald, Phebe B. Fitzgerald by next friend L. C. Hall

against

Felix N. Patterson, Polly Marcum, Holly Markum, Matilda Fann, Elizabeth Markum, Moses Whitehead and others in an action of Ejectment.

We, Holland Denton and B. B. Columns on the schedules are in order, males 0-5 years, males 5-10, males 10-15, males 15-20, males 20-30, males 30-40, males 40-50, males 50-60, males 60-70, males 70-80, males 80-90, males 90-100, males over 100. To the right of these are 13 identical columns for females.

A household with figures as follows: 120001 - 103001001

means it was composed of 1 male under 5; 2 males 5-10; and 1 male 30-40; 1 female under 5; 3 females 10-15; 1 female 30-40; and 1 female 60-70.

This inscription does not include statistical detail on Blacks, either free or slave, though "free colored" are shown by name where they were heads of household. You will notice a number of names followed by 0-0. These are Blacks who fit the "free colored" category.

MINUTES OF THE SUPERIOR COURT OF NORTH CAROLINA AND MERO DISTRICT (PART ONE 1788-1798)

MATTHEW WALLIS #W 1519 REVOLUTIONARY WAR RECORDS

Matthew Wallis was enrolled on the Bedford County, TN Pension Roll on 4 March 1831. He served as a private and sergent in the company commanded by Captain William Alexander. He enlisted in Mecklenburg County, North Carolina. He served about three months in the summer of 1779. He entered the service again he thinks in Captain Samuel Flanagan's Compny in the upper part of South Carolina but he does not recollect the name of the county. After this tour, he went home to Mecklenburg County, NC. In April 1781, he went into service again as a volunteer with Captain William Alexander's Company

Matthew Wallis was born on the 1st day of March 1762 in <u>Pensilvania</u> but he does not remember which county. He has no recollection of his age but saw it in his father's family Bible in Mecklenburg County, NC about three years ago [ca 1828].

When called into service, he lived in Mecklenburg Co. NC and continued to live there for almost twenty-five years. After the war, he removed to Murry County in Tennessee and lived there eight years then removed to Bedford County where he lived when application for a pension was made. Joseph Rosson and Ezekiel Cherry certify they believe Matthew Wallis to be seventy years, eight months and eleven days of age and that he is reputed in the neighborhood where he resides to have been a soldier in the Revolutionary War.

On August 2, 1839, Mildred Wallis swore in Marshall County, TN that she was a resident of Marshall County, TN and the widow of Matthew Wallis. She stated they were married on 12 May 1785 and that her husband Matthew Wallis died on 6 February 1837. She was not married to him prior to his revolutionary service. She has no record to show the births of their children who are not named. She stated Matthew Wallis was formerly a resident of Bedford County now Marshall County.

Mildred Ragsdale swore on 31 July 1841 that she was 37 years old and that in the year 1821 she saw Matthew Wallis give to his son Matthew S. Wallis his family Bible and heard Matthew Wallis say at that time that he had written a true copy of the ages of his children; that he would retain a copy in case said Bible should be destroyed as Matthew S. Wallis was then preparing to move to Alabama, which he did; that Matthew S. Wallis is since dead & his wife also and their children bound out; that her marriage took place in 1822.

A list of the children are: Ezekial Wallis, born 9 February 1786; Prudence Wallis, born 5 May 1787; Sarah Wallis, born 30 January 1789; Margaret Wallis, born 1 May 1791; William Wallis, born 28 June 1796; Matthew S. Wallis, born 25 January 1799; Mildred Wallis born 25 March 1801. [Editor's Note: It appears the list of children came from daughter Margaret Wallis Ragsdale.]

JAMES HALEY #S 4316 REVOLUTIONARY WAR RECORD

James Haley was born in 1757 in State of Virginia and reared in Lunenburg County, Virginia. The names of his parents are not shown.

While a resident of Lunenburg County, James Haley enlisted about March and served until September 1st (year not given) as a private in Captain Robert Dickson's Company under Colonels Charles Lewis and Haynes Morgan in the Virginia troops. He marched to North Carolina, then to Gwyn's Island where Lord Dunmore had gone but was not in the engagement at that place although in sight of it. He enlisted again August 18, 1781, to go against Cornwallis, served as a private in Captain Roberson's company, Colonel John Holcombe's Virginia Regiment, but was furloughed before he reached Yorktown; length of his service not stated.

In 1797, he moved from Lunenburg County, Virginia to Rockingham County, NC and in 1806 to Tennessee. He was allowed pension on his application executed October 25, 1832, while living in Davidson County, TN; was granted pension for service of six month.

James Haley died October 27, 1841, place not stated. There are no data as to his family.
