JOURNAL ARTICLES and ANNOUNCEMENTS are to be sent directly to the Editor at the address shown below. Include a postcard or SASE if you wish to be notified a manuscript has been received. There is a minimum of four months lead-time prior to publication for announcements and other dated material.

It is the submitter's responsibility to secure permission from any person or company who may own the original record or publication rights. The Society or Editor cannot assume responsibility for errors of fact or infringement of copyrights by contributors.

Please make sure handwriting is legible or the document is typed. Include your name, address, and phone number on the manuscript. If using a computer, save the file in the ASCII [.TXT], or WordPerfect 5.1 word processing format and enclose the disk, along with a hard copy of the article. The disks can be either 5-1/4" or 3-1/2" size. References/footnotes should be indicated as such and placed at the end of the article. The Editor will arrange for the placement of footnotes or end notes in the final layout. Material should be limited to a published length of approximately five typeset pages. The right to edit material for presentation, grammar, and form is reserved by the editorial staff, and all material submitted becomes the property of the Society.

PROMINENT MIDDLE TENNESSEANS IN ROBERTSON'S COLONY OF TEXAS

The History

Robertson's Colony in Texas had its beginnings in Middle Tennessee, with many of the founders and settlers from Nashville and the surrounding area. Sterling Clark Robertson, born in Nashville, Tennessee, Oct. 2, 1785, became a principal character in colonizing an area in Central Texas between Austin and Fort Worth. Robertson was the son of Elijah Robertson and nephew of Nashville's founder, General James Robertson. He died March 4, 1842 near Nashville, Milam County, Texas, buried in Austin, and was known then as Impresario Robertson.

Robertson's Colony was known as the Texas Association 1822-1825, Leftwich's Grant from 1825-1827, the Nashville Colony 1827-1831, and the Upper Colony 1831-1834, and the project finally bore the name Robertson's Colony from 1834-1835. After Texas won its independence in 1836, the area was divided into 30 counties as shown by the accompanying map.

A direct descendant of Sterling Clark Robertson, Malcolm D. McLean, compiled and edited a multi-volume set entitled Papers Concerning Robertson's Colony in Texas (Arlington, Texas: University of Texas-Arlington Press, 1974-1993) and an Introductory Volume, Robert Leftwich's Mexico Diary And Letterbook, 1822- 1824 (Arlington, Texas: University of Texas-Arlington Press, 1986), after it was discovered. This is a very complete history of Robertson's Colony and the area, and is the text used for this brief history.

The first Spanish governor of the Province of Texas, Domingo Teran de los Rios, blazed the Old San Antonio Road (also known as the Camino Real or the King's Highway) in 1691. This expedition named the Texas rivers as they crossed them traveling eastward. After several expeditions, the Spaniards founded a presidio and three missions on the San Gabriel River which was their greatest accomplishment in the 18th century. The Old San Antonio Road later became the southern boundary of Robertson's Colony.

The French explorers entered the scene in the middle and late 1770's, followed by the Anglo-Americans interest in Texas in 1791. Phillip Nolan was the first Anglo-American to map Texas. After many expeditions, a false Texas Platinum rush on the Brazos River (which turned out to be lead rather than platinum), the Mexicans declared their independence in 1810 but were not able to confirm their independence until Sept. 27, 1821 when Agustin de Iturbide entered the national capital at the head of his army and rode to the Convent of San Francisco where Ayuntamiento presented him with the golden keys to Mexico City on a silver platter.


The Memorial

As soon as word reached Nashville, Tennessee, during the last days of February 1822, a large number of prominent citizens of both Tennessee and Kentucky swung into action and on March 2, 1822, they had drafted a "Memorial" addressed to "the Independent Gov-

ernment of Mexico" congratulating them on having won their independence and asking for permission "to settle in the jurisdiction of that part of your dominions contiguous to the United States, for the purpose of supporting and maintaining our families by the cultivation of the soil." There was room for 70 signatures with spaces for the names of the commissioners who were to carry this petition to Mexico and the place for the day and the month left blank. The names of the commissioners were written in later as Andrew Erwin, Robt, Leftwitch, John A. Cheatham and the date was entered as "this 2d day of March 1822." The group did not give itself an official name, referring to the signers as "Citizens of the United States of America." It later became known as the Texas Association and flourished as such from 1822-1825.

The "Memorial" was then taken to Mexico by a group headed by Andrew Erwin of Nashville who was the spokesman for the group. The boundaries for the land to grant to settlers was "the land included between the Navasota and Brazos Rivers and that situated to the northwest of the Brazos River between the said river and the range of mountains which divides the waters of the Brazos and Colorado Rivers, or rather, between the said mountain range, the San Antonio Road (or the northern boundary of the land requested by Stephen F. Austin), the Brazos River, and the road of the Comanches." They obligated themselves, within nine months after date of concession, to effect the emigration of 100 or more families, within 18 months of 200 more families, and if permitted to increase the number, to promote emigration up to 500 families within three years.

Nelson Patterson of Giles County, Tennessee, was the prime mover and most enthusiastic promoter of the Texas Association.

Others who signed the Memorial included James McLaughlin from Louisiana, Charles Douglass, James Patteson of Giles Co., Tennessee, Amos Edwards, Daniel Comfort, George Brown, and Thomas W. Stockdale, all of Russellville, Kentucky, Daniel M. Heard, Robert Leftwich, all of Logan Co., Kentucky. The Governor and Secretary of State of Tennessee both signed the document.

Leftwich Letterbook, Dated 1822-1824, Discovered in Franklin, Tennessee.

Robert Leftwich's diary and letterbook was kept by him in Mexico City between 1822 and 1824. Leftwich was sent to Mexico City by the Texas Association to get permission for them to establish a colony in Texas, which at that time, was still a part of Mexico.

Robert Leftwich, son of Augustine Leftwich, Jr. of Bedford Co., Va., had a brother, Jesse Leftwich who moved to Maury Co., Tennessee, and from there to Austin's Colony in Texas where he was received as a colonist in April 1830. Robert left Pittsylvania Co., Virginia, moving to Rockingham Co., North Carolina, then to Logan Co., Kentucky, then to Nashville, Tennessee.

Robert Leftwich's diary and letterbook was discovered in the home of Mr. & Mrs. Robert Albert Bailey, Sr., "Beechwood Hall" in Franklin, Tennessee, about 6 miles south of Franklin off Carter's Creek Pike. The property was sold by the family in the 1940's. The granddaughter of the Bailey's, Miss Minnie Carter Bailey, saved the manuscript volume along with other books from the sale and kept it for 25 years until she was preparing to move to Birmingham, Alabama. At that time, she deposited it for safe-keeping in the Tennessee State Library & Archives where it was discovered in 1985. Miss Bailey then removed it and later sold it to the Robertson Association of Texas.

One Texas Settler

Many settlers from Middle Tennessee "went to Texas," among whom were Jesse Benton, brother to U.S. Senator Thomas Hart Benton, originally from Williamson Co., Tennessee.

Another settler was John D. McAlister, son of Charles and Elizabeth McAlister and step-son to Charles G. Olmstead, attorney in Franklin, Tennessee, in the 1820s - 1850s and one of the signers of the Memorial.

The following letters, written by John D. McAlister to his step-father in Franklin from the Robertson's Colony area, give his viewpoint. Charles G. Olmstead owned shares Nos. 353-360 of the stock in the Texas Association issued October 15, 1825 (McLean, *Papers Concerning Robertson's Colony in Texas*, Vol. IX, 1982, pp. 67-68.) The original letters are in the Probate File of John D. McAlister in the Williamson County Preservation of Records, Franklin, Tennessee.

Letters from John D. McAllister, Member of the Texas Association, to his Step-Father, Charles G. Olmstead, in Franklin, Tennessee

"Brazonia Oct 17, 1834

Dear Father

I recd your letter dated in March, some-time in the latter part of August inclosing a draft of \$500. also about your claim in Robertson's Colony my opinion is that Robertson will act the long-tailed puppy if he can do it. I formed this opinion of him whilst I was with him in the upper part of this colony. To be more certain I have employed Mr. Archer a lawyer of this place to attend to it and who will go up to see Robertson in a few days upon business of his own. When Archer returns he will give me the necessary information in regard the different Leagues situation etc. The country is in confusion. No laws. The Legislature that gives Robertson his right to the colony is broke up The governor is broke by a mob. No law. J.D. McAlister."

Letter addressed to "Charles G. Olmstead, Franklin, Ten"

"Brazonia Dec^{mbr} 2 1834 * Dear Father

As the Schooner San Felipe is about to sail for N. Orleans and not knowing when I may again shortly have an opportunity of writing I seize upon the present chance to communicate what information I have so far obtained in regard to the colony belonging to the old N. company. There is no doubt but what the titles under the N. company are good, in the 2nd place the members of the Co. have to comply with the Colonization law that is either to settle themselves

or to settle a family upon each one of their leagues and to make an improvement thereon. They forfeit their league or leagues in case of failure. The family so settling are to swear allegiance to the Mexican government and to become a member of the Roman Catholic church. There are several other things required to make the title good. Staying in the country a certain number of years paying government fees, commissioners fees, etc. etc. I have heard from league No. 19. It is situated on the Brazos River Thirty or forty miles below the falls and is said to be a first rate league of land well timbered but bad water he said at the present time it ought to be worth fifty cents an acre, as to the other league I have taken the necessary steps to have it searched out and as soon as it is possible after the 15th of the present month I shall go up my myself and place things upon a firm footing put families upon both leagues which may cost all expenses included about \$250 each. I shall have good titles before I leave there. As I have not enjoyed a good days health since the 25th of last May I shall shortly return when I shall expect a full settlement and as to property sell - sell with five likely negroes in this country and five hundred dollars a fortune is certain. I wish to begin to do something for myself and I can not do it upon nothing.

Yours affectionately Jno. D. McAlister.

P.S. Give my respects to Mark all of the Tennesseans in good health but myself - my health is wretched. McAlister.."

Letter addressed to "Charles G. Olmstead, Franklin, Ten."

"Brazonia Dec^{mbr} 5, 1834 Dear Father

Since my last to you I have consulted with a lawyer of this place Mr. Jno. A. Wharton who advices me to go immediately to Robertson's Colony and show him your letter to me and place a family on league No.19 in good faith with Robertson that the scrip-certificates etc. shall be sent out forthwith = Also if I am to manage these leagues the title must be placed in me for no one but a citizen and a Roman Catholic can hold land in the country. Robertson calls upon the N. Co. to come forward before the 1st day of April with their families to settle their leagues if they fail to do so he will not respect any longer the portion of the country that has been set aside for them but give it to immigrants as they move in. Send out papers in full empowering me to act. Also appoint me your agent to collect those Swiney notes as he refuses to pay them because they are not endorsed over to me. He is a d-n rascal. God dont and will not let him prosper. The Agueand fever has left me within the last few days. I wish you to write and answer this letter immediately.

"Brazonia June 18 1835

Dear Father

As to the claims in Robertson's Colony they are doubtful. He has

sold his interest to Jesse Benton for what or how much I do not know. Sam Williams is at Mondora using all his powerful influence to regain the colony or at least to overthrow hands. The status of Chihuahua and of Cohicha & Texas are opposed (the only two) to his rapid strides to dictatorial power. The people of Texas have been called

on to furnish troops for the fight the battles of the interior but they will not be there in the hour of need. The present Executive have removed from office (Political Chief) Henry Smith exqr. who is undoubtedly the first man in Texas which has been done through the influence of Williams in a word the men that are in office are opposed to Robertson. I give the script to Dr. Archer who is now in Robertson Colony to attend to and arrange so that there will not be a doubt about the title. On the 26, of next month 100 volunteers will start out for the prairies to give the Indians a chastisement for the depredations that they been commencing on the frontier. I may go it depends on circumstances. The central committee of Texas has called upon the people of Texas to have a convention, form a state government at all hazards and to be prepared for the worst that follows. For everyone that is acquainted with the disturbances of Mexico and with the situation and the wants of Texas with jealousy on one hand and utter contempt on the other must know that the hour is not far distant before there will be wars and rumors of war in this country. If the news came tomorrow I would not be surprised. 
More Info

A COMPILATION OF SOME MIDDLE TENNESSEE SETTLERS, 1779-1780

By Robert A. McGaw, 1979

With the interest generated by the State Bicentennial and the "First Families of Tennessee" project, your editor searched for material relative to this subject which would be of help to readers in locating their ancestors during this time period.

Mr. McGaw compiled the following data for a program celebrating Founders Day in Nashville, December 23, 1979, and has graciously given us permission to print the material herein. He drew his list from several old accounts and rearranged them in alphabetical order. McGaw stated, "... this is not a complete list of first settlers. It is a compilation, undertaken with due care but not infallibility, from five published sources, as follows: (1) John Haywood, The Civil and Policial History of the State of Tennessee Nashville, 1823. Second edition 1890, reprinted 1915. (2) A. W. Putnam, History of Middle Tennessee, or, Life and Times of Gen. James Robertson. Nashville, 1859. New edition Knoxville, 1971. (3) Harriette Simpson Arnow, Seedtime on the Cumberland. New York, 1960. (4) Three Pioneer Tennessee Documents. Nashville. 1964. (5) The State Records of North Carolina. Volume XIX. Raleigh.

Explorers and Hunters

At one time or other during the dozen or so years before the Nashville area was settled, an unknown number of explorers and hunters, certainly more than fifty and perhaps as many as a hundred all told, came for a while to these lands along the midsection of the Cumberland River. Some came again and again. Some became first settlers, among them these twelve whose names were recorded by Haywood or by Arnow or by both:

Preliminary Plantings

In the spring of 1779, two parties of men came with the objective of planting corn that, if it lived and matured, would help feed the settlements. Kasper Mansker, with others whose names were unrecorded, planted for the station he would build where Goodlettsville now is. James Robertson led the party of eight, plus an unnamed Negro slave, who planted corn near the Big French Lick where Nashville was to be. The names, from Haywood, page 95:

All except Hanly are known to have become first settlers.

The Overland Journey


James Robertson was the acknowledged "Founder of Nashville" and "Father of Tennessee," and he led the largest of the parties (or companies, they were called) that came overland in the late fall and winter of 1779/80 to settle the Cumberland country. There is no roster of Robertson's company.

When the travelers reached their destination "all the companies amounted, it is supposed," wrote Haywood (page 98), "to two or three hundred men, many of them young men without families." Of the two or three hundred, fewer than forty are identified by name in Haywood's book or Arnow's, and most of those whose names wre recorded began the journey in companies other than Robertson's and met up with him en route. In Robertson's own company were two of his brothers, Mark and John, and his eldest son, ten-year-old Jonathan. The names that follow are found in Haywood or in Arnow.

John Donelson's Journal

At about the time Robertson's overland travelers reached the future site of Nashville in December of 1779, a flotilla of about thirty flatboats led by Colonel John Donelson began a thousand-mile voyage down the Holston and Tennessee rivers and up the Ohio and Cumberland to the same destination, arriving April 24, 1780.

According to Arnow (page 236), the boats carried about three hundred people the women, children, and servants of about fifty families and

enough men to handle the boats. A lower estimate was made by Putnam (page 80), who "supposed the entire party must have amounted to one hundred and sixty." Donelson's famous journal of the voyage is in the collections of the Tennessee Historical Society. It names only forty of the travelers.

Except for rearrangement in alphabetical order, the names that follow are as printed in Putnam, pages 69-76.

Although women, children, and slaves outnumbered the white men aboard, few of the women's names and none of the children or blacks are found in either Donelson's journal or Haywood's book. Haywood wrote (page 235), that on the Stuart boat were "blacks and whites to the number of twenty-eight souls." According to Arnow (page 235), Donelson's boat alone carried thirty blacks and fifteen whites.

Cumberland Compact

The Cumberland Compact, or form of government adopted by the first settlers in May 1780, is in the handwriting of Richard Henderson, North Carolina lawyer, judge, and land speculator who in 1775 had bought from the Cherokee Indians their claim to most of Kentucky and the part of tennessee drained by the Cumberland River the Transylvania Purchase. The Compact set forth terms for the settlers to buy land when Henderson's title should be confirmed. It never was; the

legislatures of both Virginia and North Carolina disallowed the Transylvania Purchase.

Beginning May 13, 1780, there were 255 signatures affixed to the Cumberland Compact. Not all the first settlers signed it, and not all who signed it stayed. The original document is in the collections of the Tennessee Historical Society.

Except for rearrangement in alphabetical order, the names that follow are as printed in Three Pioneer Tennessee Documents, published in 1964 by the Tennessee Historical Commission, pages 18-21. Note that seven names appear twice (Edward Bradley, John Drake, James Freland, Isaac Johnson, Daniel Johnston, Samuel Moore, James Ray). Whether father-son, otherwise kin, or duplications might be ascertained by study of the actual signatures. Other names (Dukham/Dunham, Jarot/Jarrott, Ragsdell/Ragsdil) are so alike as to raise questions. One name is undecipherable, therefore this list contains 254.

North Carolina Assembly Act of 1784

In May of 1784 the North Carolina Assembly approved a "Petition of the Inhabitants of Davidson County" naming 151 persons and granting each 640 acres of free land in the Cumberland country as reward for their establishing and defending Nashborough and its neighbor settlements.

Except for rearrangement in alphabetical order, the names that follow are as printed in *The State Records of North Carolina*, Volume XIX, pages 572-573, in three groups. The first group of 68 were still alive in 1784. The second group of 63 were men who had been killed by Indians; the land was granted to their heirs.

All in the first and second groups had been in the Cumberland country by May of 1780. In the third group of 20, some had arrived "soon after" May of 1780 and some were there by then but "were under age."

MINUTES OF THE SUPERIOR COURT of NORTH CAROLINA and MERO DISTRICT

Abstracted and annotated by Dorothy Scott Johnson

At the time the Mero District was organized it included most of what is now Middle Tennessee, and North Carolina claimed ownership of the region. Thus the original name of the Court was "Superior Court of North Carolina, including Mero District." This court convened from 1788 until 1809.

In the 1930's the WPA Writers' Project transcribed minutes of this Court and entered them in four books which were then placed in the Tennessee State Library and Archives. What happened to the originals of these minutes seems to be unknown; they cannot be found at the State Library today, eighter in original or microfilmed form. Occasionally someone will erroneously cite the Davidson County Court minutes of the period as belonging to the Mero District, but perusal of those minutes prove conclusively that they are not the same. As a consequence, when publishing the Mero District court records we are limited to copying the WPA books instead of the originals.

All legal definitions are taken from *Black's Law Dictionary, Fifth Edition* and will hereafter be referred to as "Black's." Many abbreviations in this work are not in Black's and appear to be the original clerk's own brand of legal shorthand. Since no log exists explaining the meaning of these abbreviations it is necessary to use them as they are written.

The page numbers given here are the pages of the WPA typed material, not the original page numbers unless so stated.

Lewis, yeoman, late of the town of Nashville, Mero District, assaulted Lardner Clark, a Justice of the Peace for Davidson County while Clark was executing his duties. Lewis did beat, wound, and ill treat Clark so that his life was greatly despaired of, plus "other wrongs," to the great damage of Clark.

The reason behind the beating was that \underline{K} ato, a negro owned by Lewis, was on trial before

Clark on a charge of felony. Lewis wanted <u>Cato</u> to evade sentencing and assaulted Clark thereby preventing Clark from pronouncing sentence. Said assault was "against the evill [sic] example of all other persons in like case offending and against the peace and dignity of our said Territory."

[Black's: Appellee: The party against whom an appeal is made. Appellant: The party who makes an appeal from one court or jurisdiction to another. (Note: In this case it is unclear whether George A. Sugg is appellee or appellant.)]

WEALTH IN 19TH CENTURY WILLIAMSON COUNTY

Since 1799, Williamson County has ranked as one of the richest counties in Tennessee. That wealth came largely from the fertile soils found along the four rivers and many streams flowing through it. The best lands were claimed by the early settlers who came with large land grants and a desire for wealth. Using Williamson County tax records, now housed in the Preservation of Records Office located in the Old Post Office at Five Points, in Franklin, Tennessee, it is interesting to compare the wealth of our past.

Revolutionary War soldier Colonel Hardy Murfree was the county's richest citizen during his lifetime. Though he died in 1809, his estate in 1813 was listed with 12,742 acres in Williamson County and 55 slaves plus twelve thousand acres in other Tennessee counties.

Nicholas Bigbee Perkins, the richest citizen during his lifetime, died in 1848 leaving a large family and fortune. His estate was estimated at half a million dollars and included over 6,000 acres, two iron furnaces, eight town houses and lots in Franklin, a tanyard, and 310 slaves.

The following tax lists identify the leading planters and the obvious connection of land and slaves to wealth. The once numerous Perkins family increased and concentrated their wealth by marrying cousins and other wealthy Williamson County families. Marriages between the McGavock, Pointer, Reece, Puryear, DeGraffenried, and Watson families also strengthened their holdings within the county.

Those interested in social history might notice that these well recognizable 19th century Williamson County surnames are today only names found in the Afro-American community. Few descendants of these once influential families remain in the county. Of the twenty-five men worth over \$50,000 in 1860, only nine have homes still standing in 1994. Interesting, only the homestead of Samuel Fielding Glass, Jr. remains in the family. The Lysander McGavock family sold Midway within the last five years. The Nicholas E. Perkins family sold Meeting of the Waters in 1990.

The year 1837 was the first year that land, slaves and total wealth were listed in the tax rolls. and the leading planters identified are given here.

THE FOLLOWING post-Civil War tax record points out that not all Williamson Countians were destroyed financially by the conflict. Slaves were important financial investments in 1860 and their loss during the war was runious to many families. A few wealthy citizens had investments in railroads and businesses other than farming. Some Williamson Countians were suspected of trading with the Federal Army and thereby profitted from the war. However, most of those citizens listed in 1860 with wealth over \$50,000 managed to keep their farms intact by changing form slave labor to sharecropping or tenant farming.

FOUNDING OF NASHVILLE

"APRIL SESSION, 1784.1

"An Act establishing a Town on the Cumberland River, at a place called the Bluff, near the French Lick.

"Be it enacted by the General Assembly of the State of North Carolina, And it is hereby enacted by the authority of the same that the directors or trustees, hereafter appointed, or a majority of them, shall, so soon as may be, after the passing of this act, cause two hundred acres of land, situate on the South side of Cumberland River, at a place called the Bluff, adjacent to the French Lick, in which said Lick shall not be included, to be laid off in lots of one acre each, with convenient streets, lanes, and alleys, reserving four acres for the purpose of erecting public buildings, on which land so laid off, according to the directions of this act, is hereby constituted, erected, and established a town, and shall be called and known by the name of NASHVILLE, in memory of the patriotic and brave General Nash.

"SEC. 2. And be it further enacted by the authority aforesaid, That from and after the passage of this act, Samuel Barton, Thomas Malory, Daniel Smith, James Shaw, and Isaac Lindsay be, they and every of them, are hereby constituted Directors and Trustees, for erecting and laying out, and carrying on the said Town, and they shall stand seized of an indefeasible estate in fee of the said two hundred acres of land, to and for the uses, intents and purposes hereby expressed and declared.

"The lots contained each one acre, valued at four pounds, and drawn for as in a lottery. James Robertson, Esq., had first choice of four lots, for which he paid the same amount.

"Water street was laid off in 1786. At the same time a lot was appropriated on the Public Square for the Methodist Episcopal Church, and the same liberal policy was extended to other Churches, as soon as they might be ready to build.

"An order was passed for the building of a market-house in 1801. The first warehouse was built by John Harman, on the land of John McNairy, Esq., near the mouth of the Lick Branch.

"An act was passed, in 1806, to incorporate the inhabitants of the Town of Nashville. After this, the jurisdiction of the Town passed from the State of North Carolina to the board of mayor and aldermen of Nashville."

1996 NATIONAL GENEALOGICAL SOCIETY CONFERENCE IN NASHVILLE

There will be a computer learning lab with 12 computers loaded with genealogy software in addition to two computer labs, a vendor demonstration room and a room for Macintosh computer users. The two computer labs are scheduled concurrently with more than 40 hours of handson activities. Topics are scheduled for beginners, as well as intermediate and advanced computer users. Sessions start at 11:00 A.M. on Wednesday, May 8 and continue through Saturday afternoon. Lab sessions on genealogy software will include PAF, Brother's Keeper, Family Tree Maker for Windows, Family Treasures for Windows, Visual ROOTS, Using Ancestral Quest, Family Roots for Beginners, Everyone's Family Tree, Cumberland Family Tree for Windows, and GED-COM Do's and Don'ts. Those interested in using multimedia should consider "Recording Multimedia Family Memories with Echo Lake." Other lab presentations include "How to Use an Electronic Bulletin Board," and "Lets Dust Off That Modem and Use It! A Look at Telecommunications Programs for Beginners."

Each lab will have 15 computers with two people assigned to each computer. Don't sign up for an advanced lab if you are a beginner or a beginner lab if you are an intermediate or advanced user. This is a real problem when a beginner is paired with an advanced user or one person takes control of the computer and doesn't share it with the other. Perhaps you can get a friend to sign up for the same lab so that the two of you could share a computer. Be aware that a fee is charged for these labs and prior registration is required. However, the Exhibits Area, Vendor Demonstrations, Computer Learning Lab, and Computer Lectures are free.

COMPUTER LECTURES

The Computer Lecture series should be popular with beginners as well as the more experienced computer user. If you are interested in the Internet, then a lecture by Mike St. Clair "Traveling Electronic Trails" will start at 11 A.M. John Whitaker will conduct a session "How Do 1 Do Computer-Aided Research" at 2 P.M. Wednesday. Beginners might be interested in "Don't Be Afraid: It's Only a Computer, " a two hour session with Russ Holsclaw, starting at 3:30 P.M. Wednesday. Later that evening at 7:30 P.M., Carla Ridenour will conduct a session on "Selecting A Windows Genealogy Program."

Sessions scheduled Thursday include "Shortcuts in PAF to Get More Done Faster," at 2 P.M. with Barbara Renick, and Brian Mavrogeorge will follow at 3:30 P.M. with "Genealogical Resources on the Internet Using the World Wide Web." Later that evening, at 7:30, the NGS/CIG Telecommunications Open Forum will

be in session.

Brian Mavrogeorge is back Friday morning at 8 A.M with a session on "How to Use a Bulletin Board System for Genealogy." The 9:30 A.M session is "Go West Young Man! Finding Federal Land Records vis CD-ROM," followed by "Using PAF as a Research Tool" by Barbara Renick at 11 A.M. John Whitaker will start the afternoon session at 2 P.M. with "CD-ROM What You Need to Know," and Russ Holsclaw will follow at 3:30 P.M. with "Hardware and Data Protection Issues."

Russ Holsclaw will also conduct a session on "How to Cite Your Sources Using Any Genealogical Software," on Saturday at 2 P.M.

Register early and plan to attend the computer lectures, maybe enroll in one or more computer labs, visit the computer learning lab, stroll through the exhibits, talk to vendors, meet new friends, share experiences with other genealogists and take advantage of the other scheduled events.

A NEW YEAR AND NEW CHALLENGES

Christmas sales of computers for home use in 1995 was projected at 4 million which exceeds the total purchased by home buyers in all of 1991. New genealogy software makes it easy to do genealogy research and interest in genealogy will increase as more and more people get home computers. A laser printer, scanner, fax, CD's, e-mail and access to the Internet enables anyone to conduct unlimited searches in a matter of minutes without leaving the comforts of home. However, we should be vigilant and not let our quest for new information inundate us with megabits of data that is inaccurate, cannot be documented and is of dubious value to the serious researcher.

Brian Mavrogeorge and Jan Unter address this issue in the July/August 1995 issue of the *NGS/CIG DI-GEST*. Jan Unter is Editor of the Sili-

con Valley PAF Users Group PAFinder newsletter. This group developed PAF Documentation Guidelines, now in its fourth version, and widely accepted as the standard for citing sources within PAF and elsewhere. Some programs such as PAF don't have direct provisions for footnoting. Jan ends his article with a plea: "Just say "No" junk genealogy! and make a sincere effort to include source citations in all your computerized genealogical efforts."

Brian Mavrogeorge thinks genealogists who have resisted technology, are dealing in varying degrees, with "future shock." However, he is more concerned about "future schlock." He describes "bad data" and tells about finding a GEDCOM file on the Internet showing a person with ancestry traced all the way back to Noah. He also raises many interesting questions about how we do research, that we tend to be lazy and ease of use is more important than content. He says "put something on-line-anything-and researchers will love it, whether or not it's right." He thinks we should give as much weight to documentation of sources as we do to the family data but still explore and embrace the use of new technology for genealogy. Emphasis is given to the need for critical review of electronic publishing, correction of mistakes, documentation of sources and rules of evidence. This would serve as a "fair warning" to suspecting genealogists. He ends with a challenge to be "dedicated to genealogy founded on solid research principles - get to the source, explain discrepancies, provide proof, and evaluate evidence." Brian was the speaker for the NGS/CIG banquet at the 1995 NGS Conference in San Diego. He is also the operator of the oldest genealogy bulletin board and will be making a presentation at the 1996 NGS Conference in Nashville.

WINDOWS 95 ISN'T FOR EVERYONE – YET!

Many of you are using genealogy programs such as PAF, Brother's Keeper, ROOTS III or IV, which are DOS programs and you don't really see the need to upgrade your computer or software. If you are satisfied with your system and it does everything you want, then why waste time and money upgrading to a Windows genealogy program or to Windows 95? There is no need to upgrade at this time and you should not do it just because of the publicity associated with Windows 95. At some point in the future however, you could be faced with the need to upgrade whether you want to or not. Running out of disk space on your hard drive or a system failure for example might force you to upgrade or replace your computer. Therefore you should prepare for the worst case scenario. This also applies to anyone thinking of installing Windows 95 now or later.

Failure to properly manage files and directories is perhaps the cause of many disk drive problems and was discussed in the Spring 1995 issue of this Journal. Microsoft suggests you run "chkdisk" or "scandisk" on a regular basis to clean up your hard drive. Fragmented files can slow down disk access time and eventually cause other problems. Once you have cleaned up your hard drive, you should also check to see how much unused disk space you have on your hard drive. Windows 95 needs 35-40 MB of space to successfully install the upgrade over an older version of Windows and DOS. You will also need a minimum of 8 MB of memory, at least a 386DX or later processor running MS-DOS version 3.1 or later, and be running Windows 3.0 or later. A good place to check out your system and see what you have is to "maximize" program manager, and double click on the "System Information" icon. The screen will display categories of information including processor type, memory, space on hard drive, and applications running. Windows 95 will not install properly if TSR's (Terminate & Stay Resident) are running. This information can be printed and used as a reference when talking to someone about your computer.

Well I finally did it! I installed

Windows 95 and ended the year with a different view of how a computer works, or should work. After seeing demonstrations, talking to friends, reading unending press reports and magazine articles, I purchased the upgrade software package for Windows 95. According to my sources, this would be a simple exercise if I got the CD-ROM version, which I did. As they say, the rest is history. A few mouse clicks later and the setup routine took over. The CD was spinning, screens would come and go, then after only a few minutes, Windows 95 was upand running. A click on the "Startup". button and a series of windows appear allowing you to select familiar icons, folders, files or programs to run. There are other nifty things you can do, such as hiding an open file in the tool bar and then when you want to open it again, just click on the icon and it is there. The upper right side of the screen on all open files has three icons, one that looks like a minus sign, a frame and a box with an X in it. Click on the X to close a file, or click on the frame icon to get a full screen. Click on the minus sign and it clears the screen and an icon for that file appears in the tool bar next to the start button. I was able to run all my DOS programs without any problems and was beginning to feel comfortable with the way things worked except for one thing. I had removed the mouse from my computer and installed a tablet with a pen, which is indispensable when retouching photographs or preparing artwork. Windows 95 did not recognize it and would not let me install it. Back to the mouse. After a few days of complaining and no obvious solution to my problem in sight, I reluctantly removed Windows 95 from my computer. The process is simple and easy. The control panel has an iconto add/remove programs. Windows 95 was highlighted, a click of the mouse and in a matter of minutes, the computer rebooted. Everything is just the way I remembered and the mouse is disposed of, at least untilnext year.

BOOK REVIEWS

Sumner County Tennessee Court Minutes 1787-1805 and 1808-1810 by Carol Wells. Softback 5 1/4 x 8, 271+80 pp., two complete name indexes, copyright 1995. Cut from Davidson County in 1786, Sumner County covered a large area which was later divided into many other counties. Since the first deed book in Sumner did not begin until 1793, these early minutes include the recording of early deeds not found elsewhere. The minutes record chronologically the history of the county on a day to day basis relating to roads, mills, ferries, probate issues, minor misdemeanors and major crimes.

The type is small, although dark and quite legible. The complete name index is an important addition and is a joy to use. Do be aware of the fact that this publication is actually two books in one. The index for the first volume follows it and precedes the text on the second volume. Those with roots in Middle Tennessee will want to add this helpful book to their library collection. I've already ordered mine!

Annals of a Scotch-Irish Family: The Whitsitts of Nashville, Tennessee by William H. Whitsitt. Spiral bound, 8 1/2 x 11, irregular pagination, complete name index, 1995 reprint of a 1904 publication. This was originally published in 1904 in four issues of the American Historical Quarterly. Born in 1841, the author was the grandson of Rev. James Whitsitt in whose home the Mill Creek Baptist Church was founded in 1797. A tribute to the memory of Rev. Whitsitt written by Robert Boyle C. Howell, D. D. in 1850 is included.

A Xerox copy of the original record, this book is enhanced with a complete name index to all four parts of the book. The index appears in the middle of the book, so be sure to look for it.

Included in this book is the conference business of the Baptist Church under the care of Rev. James Whitsitt, on Mill Creek in Davidson County, Tennessee. There is a list of members from the year 1800 as well as interesting information on various other members.

An every name index has been added at the front of the book. The type is large and the book is easy to read with plenty of white space.

Mill Creek Grange No. 182 of the Patrons of Husbandry Minutes 1873-1874. Spiral bound, 8 1/2 x ll, 60 pp., complete name index, 1995. Order from Friends of Mill Creek Baptist Church Graveyard (see address above). \$10.

The Grange, officially known as the Patrons of Husbandry, is a nationwide organization for farmers founded in 1867. Its purpose was to combat the high prices being charged by the railroad companies to transport farm produce to market. Grange No. 182 held meetings alternately at Thompson's Chapel and at Gethsemane Baptist Church in Davidson County, Tennessee. The accounts of the meetings and social interactions of many of the residents of southern Davidson County represent a treasure house for family historians.

The type is large and easily read with plenty of white space. An added every name index makes this book especially helpful.

Statesville is located in southeastern Wilson County and this history, although billed as a pictorial history, contains much information about the area and its early settlers. The old photographs are plentiful and so very interesting. The book is chock full of family information. Some family names that jumped out in a quick perusal were those of William Bumpass, the Oakleys and the Johnsons among many others.

The print is easy to read and the author has done a commendable job in collecting old photographs. An index would have been an extremely welcome addition to this book. If you have ancestors from Statesville, you will almost surely find

their photos in this huge publication.

This genealogy deals primarily with the York County, Virginia Goodwins beginning with Major James Goodwin who settled there in 1648. The author explored many unconnected branches of the family and included these in his book. Of particular interest to MTGS members will be Appendix I which details the family of George Goodwin born 31 August 1753 in Virginia who settled in Davidson County, Tennessee before 1800.

The type size is small but legible. Use caution with the index which is composed of numerous individual indexes for the various branches of the family.

Formed in 1809 from Livingston County, Ken-

tucky, the County of Caldwell was home to many settlers who came through Middle Tennessee on their way from North and South Carolina and Virginia to Western Kentucky. This book is more than abstracts of wills, containing almost complete transcriptions of wills. Included are several unrecorded and/or rejected wills not found in the recorded county will book.

The print size is legible and the type is dark with bold type used for the surnames. The index is excellent. Those with roots in Western Kentucky will want to add this book to their library collection.

KEEPING THE STARS AND CARS IN LINE¹

Phil of Nashville is seeing stars – in curious formations. "How do the three stars on our flag go? The license plate has it one way and state flags different. Help!"

State law addresses this subject with its usual clarity:

"The arrangement of the three stars shall be such that the centers of no two stars shall be in a line parallel to either the side or end of the flag, but intermediate between the same; and the highest star shall be the one nearest the upper confined corner of the flag."

I have no idea what that means, but the handy pictures we've provided here should help.

It's illegal to make or sell an official state flag

that looks otherwise. But the law doesn't apply to miniatures, souvenirs or novelties. And while the old official car tags featuring the stars should have had the proper configuration, those unofficial tags people often place on their front bumper don't seem to conform to the law.

By the way, those stars represent the three grand divisions of the state, "bound together by the endless circle of the blue field, the symbol being three bound together in one – an indissoluble trinity," flag designer LeRoy Reeves says in Tennessee's Blue Book.

"Indifferent Flour" 1

If you should have indifferent flour of which you cannot get rid, bear in mind that it will sometimes make excellent beaten biscuit when it will not make good light bread. In making beaten biscuit, always put one teaspoonsful of salt, a piece of lard the size of an egg, and a teacup of milk to a quart of flour, adding enough cold water to make a stiff dough: no other ingredients are admissible.

Make the dough much stiffer than for other breads, beat steadily a half hour, by the clock. [their italics] Cut with a biscuit cutter or shape by hand, being careful to have the shape of each alike and perfect. . . .

THE DAVID JEAN, SR. FAMILY of LINCOLN COUNTY, TENNESSEE

Contributed by Glenn Jean

AVID JEAN, SENIOR was born late in 1794 or early 1795 in Stokes County, North Carolina, to Rev. Edmund Jean and his first wife. He died 6 January 1878 near his home "1/2 mile from Brighton, Tennessee." Jean enlisted in Captain John Hauser's Company of Infantry in the 5th Regiment of North Carolina Militia on 28 November 1814 at the age of twenty, and served until 21 February 1815. At his discharge he held the rank of Sergeant. For his services in the War of 1812, David Jean, Senior received Land Grant Warrant #6720 for 160 acres of land and later received a pension.

David Jean, Sr. moved with his stepmother Martha (Patty) Beasly and his half brother John to Lincoln County, Tennessee, between 1815 and 1818. About 1819 he married Grisilla [last name unknown], probably in Lincoln County. For about ten years David and John Jean lived in Washington County, Indiana where they were listed in the 1830 census as "Janes." The 1840 census shows they were back in Lincoln County, Tennessee.

They were nine known children born to David and Grisilla Jean:

- i. William W. Jean, born ca 1819 in Tennessee
- ii. Wiley Jean, born ca 1826 in Tennessee
- iii. Nancy Jean, born ca 1818 in Tennessee
- iv. John Jean, born ca 1832 in Indiana
- v. Joseph Jean, born ca 1834 in Indiana
- vi. Mary Jean, born ca 1836in Indiana
- vii. Wyatt Jean, born ca 1839 in Tennessee
- viii. Sarah Jean, born ca 1842 in Tennessee
- ix. David Jean, Jr., born ca 1845 in Tennessee

After Grisilla's death between 1850 and 1857, David Jean, Sr. married (2) Elizabeth C. Bryant in Lincoln County on 20 November 1857. He was 62, and Elizabeth was 22 years of age. To David and Elizabeth were born four children.

- x. Eliza A. Jean, born ca 1858
- xi. Thomas Jefferson Jean, born ca 1861 (md. Sarah Harris in 1886)
- xii. Wesley L. Jean, born ca 1864
- xiii. Hosea Jean, born ca 1868. Died young.

Lincoln County Cemeteries by Timothy Richard and Helen Crawford Marsh records David, Sr. as buried in the Jean Cemetery, Flintville #11 in

Lincoln County, Tennessee. This cemetery is plotted by the Marshes as about 0.7 miles north of the "T" intersection near Brighton.1 The Harris-Jean Cemetery, Flintville #12 and the Harris Cemetery, Flintville #13 are both within a miles of this sight.2 The sources of information on burials were given as "family records" for the Taylors and "Newspaper" for David Jean who died March 6, 1878. The "1/2 mile from Brighton" statement as the location of David's home and the place where he was married and died is contained in his pension records at the National Archives. At present the burial site is clear of large trees, has twenty or more unidentified sunken graves and the recently installed tombstone of David Jean, Sr. Weeks and low bushes were mowed by Raymond Harris in October 1991. (Raymond is a descendant of Hosea Lee Harris, a son of William Newton "Bill" Harris who married Elizabeth A. Jean, born in 1858.)

The tombstone, provided by the Veterans Administration as part of their program to recognize all veterans of wars, was erected on 12 October 1991. Inscribed on the new stone is: "David Jean, Serg. N. C. Militia, 5 N.C. Militia, War of 1812; 1795-1878." About twenty-five persons attended the informal erection and dedication of the tombstone. Among those there were David Jean, Jr. and his son, David Jean III of Chapel Hill, Tennessee, and David Jean, Sr. of Nashville, Tennessee. David Jean, Sr. was the sixth child of Arthur Glenn Jean, a son of David Jean, Jr. who was a Civil War pensioner and is buried at Lone Oak Cemetery in Lewisburg, Tennesse. If Arthur Glenn Jean had been named David, the present David Jean III would have been David Jean VI.

To reach the David Jean, Sr. gravesite from Fayetteville, Tennessee, go 11 miles east on the Winchester Highway to the Flintville turn-off; turn right and go 1/2 mile to the first intersection and look for a stone storm cellar on the left (south) side of the road at the intersection; turn right and go about 1/2 mile to the first of two house trailers on the right. Between the house trailers is a driveway to the left (west) which leads to this house. Drive to the left and to the back of the house and look for the tombstone of David Jean, Sr.

BYLAWS OF THE TENNESSEE GENEALOGICAL SOCIETY, INC.

ARTICLE I.

Name.

The name of this non-profit Society shall be Middle Tennessee Genealogical Society.

ARTICLE II. Objectives.

The objectives of this Society shall be to create and stimulate interest in the study of genealogy and family history; to collect, preserve and make available to others genealogical information pertaining to Middle Tennessee; to provide assistance to others in genealogical pursuits through all means available or developed by this Society.

ARTICLE III. Membership and Dues.

SECTION 1. Any person interested in the study and pursuit and preservation of genealogy and family history shall be eligible for membership. Membership shall be granted upon submission of application and payment of dues.

SECTION 2. Dues shall be payable on or before the first day of June each year in an amount set annually by the Board of Directors of the Society.

SECTION 3. No member shall be deemed a member in good standing whose dues shall be in arrears for more than thirty (30) days. The Recording Secretary shall notify the member of the delinquency and advise that the member will be dropped from membership unless dues are paid within thirty (30) days.

ARTICLE IV. Officers.

SECTION 1. The Officers of this Society shall be a President, Vice President, a Recording Secretary, a Corresponding Secretary, and a Treasurer.

SECTION 2. Not less than six months before the annual meeting in May, the President shall appoint a Nominating Committee of five (5) persons, one of whom shall be named as chairperson, to be approved by the Board of Directors. It shall be the duty of this committee to nominate candidates for the offices to be filled at the annual meeting in May. The Nominating Committee shall report at the regular meeting in February. Before the election at the meeting in May, additional nominations from the floor shall be permitted. Each candidate shall have consented to the nomination.

SECTION 3. The Officer or Director shall be elected by ballot to serve for one year or until their successors are elected and assume office. Their term of office shall begin at the close of the annual meeting in May. In the event there is only one candidate for any office, voting on that office may be by voice vote.

SECTION 4. No Officer shall hold more than one office at a time or be eligible to serve more than two consecutive terms in the same office.

SECTION 5. A. A vacancy in the office of President shall

be filled by the Vice President who shall succeed to the office of President for the remainder of the term. B. If a vacancy should occur during the year in any office or directorship other than Presidency, the vacancy shall be filled through appointment by the Board of Directors.

SECTION 6. A. **The President** shall: 1. Preside at all meetings of the association and the Board of Directors. 2. Appoint all standing Committee Chairpersons and such other committees as authorized by the Society or Board of Directors. 3. Be an ex-officio member of all committees except the Nominating Committee. 4. Appoint a member to serve as Parliamentarian. 5. Perform other duties as pertain to the office of President.

B. The Vice President shall: 1. Be an active aid to the President. 2. Conduct him/herself so as to obtain the greatest possible acquaintance with the affairs of the Society. 3. In the event of the absence or inability of the President to perform his/her duties, the Vice President shall perform the duties of and have the authority and privileges of the President. 4. Serve as Chairperson of the Program Committee.

C. The Recording Secretary shall: 1. Take minutes of the meetings of the Society and the Board of Directors; keep a permanent, continuous record of all activities of the Society; make a report of the written record at each meeting. 2. Maintain an accurate list of membership. 3. Perform other duties as pertain to this office. 4. Notify members of delinquent dues per Article III Section 3.

D. The Corresponding Secretary shall: 1. Notify all members of meetings. 2. Conduct the correspondence of the Society as directed by the President or Board of Directors. 3. Perform other duties as pertain to this office.

E. The Treasurer shall: 1. Receive and deposit all funds of the Society in a suitable depository bank. 2. Receive all monies and disburse funds that are proper and reasonable expenses of the Society. 3. Submit a full written report at each regular meeting giving full account of all financial transactions. 4. Maintain a permanent record of all receipts. 5. Submit all financial records for audit upon vacating the office. In addition, the Board of Directors may require a special audit. Audits are to be performed by a committee selected by the Board. 6. It shall be the Treasurer's responsibility to file any federal, state or local tax forms required.

F. The Immediate Past President shall: 1. Serve as a member of the Board of Directors for one year following the term of office as President.

SECTION 7. In the event an Officer or Director fails to attend at least one half (1/2) of the stated meetings without valid reason or just cause, the office held by such person(s) shall be declared vacant and a new Officer shall be elected by the Board of Directors to serve the unexpired term.

ARTICLE V. Board of Directors.

SECTION 1. Four Directors of the Society shall be elected at annual meetings of the Society and shall serve for a term of two (2) years except that, at the first election, one half

(1/2) of the members of the Board of Directors shall be elected to serve for one year and one half (1/2) for two years. Thereafter, two Directors are to be elected annually. Any elected Director who shall have served as much as two terms of two years each shall be ineligible for re-election as a Director for a period of one year immediately following the expiration of such second full term.

SECTION 2. The Officers and Directors of this Society shall constitute the Board of Directors. The Board of Directors shall have general supervision of the affairs of the Society between its business meetings, make recommendations to the membership and perform such other duties as are specified in these Bylaws. The Board shall be subject to the orders of the membership and none of its acts shall conflict with action taken by the Society. The Board of Directors shall meet quarterly, unless otherwise ordered by the Society at a place and time determined by the Board.

SECTION 3. The Board of Directors shall develop annually a budget for approval by the Society at the annual meeting, and shall have authority to expend funds in accordance with the budget. In addition, they may transfer funds from one item of the budget to another and may expend monies not to exceed the contingency fund, without prior approval of the Society.

SECTION 4. It shall be the responsibility of the Board of Directors to develop a policy for answering requests directed to the Society for general information and/or genealogical research and to develop and approve all public releases pertaining to the Society.

SECTION 5. A majority of the Board of Directors shall constitute a quorum.

SECTION 6. The Board of Directors shall appoint one Director to serve on the Board of Directors whose responsibility is to serve as Editor of the Society quarterly publication. This Director is to be a voting member of the Board and is to serve at the pleasure of the Board.

ARTICLE VI. Meetings.

SECTION 1. The regular meetings of the Society shall be held on the third Saturday of May, August, November and February, unless otherwise ordered by the Society or Board of Directors.

SECTION 2. The fiscal year shall begin on the first day of June and end on the last day of May. The regular meeting in May shall be known as the annual meeting and shall be for the purpose of election of Officers, receiving reports of Officers and committees, and any other business that may arise.

SECTION 3. Special meetings may be called by the President or by the Board of Directors or upon the written request of ten (10) members. The purpose of the meeting shall be stated in the call and no other business shall be considered at that special meeting. Except in cases of emergency, at least thirty (30) days' notice shall be given.

SECTION 4. Fifteen (15) members shall constitute a quorum at any regular of special meeting.

ARTICLE VII.

Committees.

SECTION 1. There shall be the following standing committees: Program; Collection and Archives; Public Relations and Membership' Publications and such other committees as may be authorized by the Society or Board of Directors.

SECTION 2. Duties of Standing Committees. A. The **Program Committee** shall: 1. Arrange a program for presentation at each of the quarterly meetings of the Society. 2. Any seminars sponsored by the Society shall come under the direction of this committee. B. The Collections and Archives Committee shall: 1. Receive and process any genealogical information received by the Society in the form directed by the Board of Directors so as to preserve and make such information accessible to the public. C. The Public Relations and Membership **Committee** shall: 1. Actively seek new members for the Society. 2. Publicize information pertaining to the Society as directed by the Board of Directors. D. The Publications Committee shall: 1. Prepare materials, other than the quarterly journal, for publication as approved by the Board of Directors. 2. Assist the Editor of the quarterly as needed. 3. Provide input to the board on matters relating to publication.

ARTICLE VIII. Parliamentary Authority.

Robert's Rules of Order Newly Revised shall be the parliamentary authority for all matters of procedure for this association not specifically covered by its bylaws and standing rules.

ARTICLE IX. Amendment of Bylaws.

These bylaws may be amended at any regular meeting by a two thirds (2/3) vote of members present provided that the amendment has been submitted in writing at the previous meeting or has been mailed to the entire membership at least thirty (30) days prior to the meeting at which they shall be considered.

ARTICLE X. Dissolution of the Society.

To effect dissolution of this Society, these bylaws must be rescinded by a two thirds (2/3) vote of the members present after thirty (30) days notice has been mailed to each member. In the event of dissolution, all assets and holdings of the Society shall be converted into an acceptable form and presented to the Tennessee State Library and Archives.

ARTICLE XI.

SECTION 1. No Society member shall accept remuneration for any research or general information request DI-RECTED to the Society.

SECTION 2. This Society shall be operated as not for profit organization and no part of the assets or net earnings shall inure to the benefit of any private individual.

TENNESSEE AND KENTUCKY: SISTER STATES?

We commonly think of Kentucky and Tennessee as being sister states—areas of similar composition in both population and attitudes. Is this really true?

Certainly they are geographical tied together like Siamese twins, with a very long common boundary. Both are border states between North and South. During much of the 19th century, a period of greater interest to genealogists than the present (or so it seems), the population of the two states remained nearly identical.

A look at the 1850 census of these two states reveals some surprising dissimilarities, however. In that year the population of Kentucky was just under 1,000,000 and that of Tennessee just over 1,000,000. The percentage of free population to the total was 78 in Kentucky and 77 in Tennessee. But look at the number and distribution of foreign born:

The total foreign-born Caucasians were 31,401 in Kentucky and only 5638 in Tennessee. Compared to the total population of these states these figures are indeed small, with the vast bulk of the residents in each case being of U. S. nativity.

The reason for almost 5 to 1 ratio of foreign born in Kentucky as opposed to Tennessee is to be found on the northern border of Kentucky, where the Ohio River washes past the state for hundreds of miles. This was the pathway for a great migration from Europe, which was particularly troubled in the 1840s, first by the potato famine in Ireland in 1846 and 1847, and then by the Revolutions of 1848; the latter was a particular impetus for the departure of Germans to America.

As one would expect, almost all these Europeans who came to Kentucky settled in the counties nearest the Ohio, so that in spite of their small numbers they made a distinct contribution to the ethnic coloration of that part of the state.

We have long imagined that there was much movement of people from Kentucky to Tennessee and vice versa in the early years. Yet in 1850 only 23,623 persons living in Kentucky were born in Tennessee; and only 12,609 of those living in Tennessee were born in Kentucky.
