With accurate material previously unattainable to the average researcher now available, you have a chance to investigate and prepare accurate genealogies. Let us not lose this chance to do our part. Yes, I know it takes longer to do it correctly. But if you don't, who will?

UNIVERSITY OF NASHVILLE MEDICAL SCHOOL GRADUATES, 1851-1909

Historical introduction by James Thweatt, Historical Collections, Eskind Biomedical Library, Vanderbilt University

The University of Nashville Medical School held its first class in the fall of 1851. It represented the culmination of an effort by school President Philip Lindsley to establish a medical school of the highest standards to complement the existing College of Liberal Arts. Established as a proprietary school and headed up by the President's son J. Berrien Lindsley, M.D., the faculty of six physicians had administrative autonomy from the university. With an enrollment of 456 in 1859–1860, the medical school soon gained the reputation as being one of the leading medical institutions in the country. The school continued to function during the Civil War but only with a smaller enrollment and a faculty of four. Only 59 students graduated during the war years (1861–1865) as compared with the 454 for the previous four years. The school managed to survive the war but was not ever able to regain its prewar stature. Its enrollment remained small averaging about 150 students per year from 1862–1874.

In 1874 the School of Medicine entered into an agreement with the newly established Vanderbilt University for a joint program in medical education. Under this peculiar arrangement, students could receive their diplomas from their institution of choice, or—for an extra fee of \$25.00—both. Citing a lack of control of the Medical Department, Vanderbilt University withdrew from this arrangement in 1895. The University of Nashville Medical School carried on independently until 1909 when it joined the medical school of the University of Tennessee which moved to Memphis in 1911.-JT

Notes by Journal editor: Of the 3,694 names given in "Alumni, Medical Department, University of Nashville, Including Graduates of 1909," less than one-half, or 1,586, were listed from various parts of Tennessee. Because of the space limitations and our narrow scope of interest, only these 1,586 Tennesseeans were abstracted for this series.

If a graduate's address was unknown in 1909, the address denoting the senior year in college was given in italics. If the current address was known in 1909, it was given in regular type. An asterisk (*) indicates a person who was known to be deceased by 1909.

STATEMENT OF JOHN GATES, WILLIAMSON COUNTY, TENNESSEE, 1826, REVOLUTIONARY WAR SOLDIER

Abstracted by Mary Sue Smith

November Term 1826 State of Tennessee -Davidson County -Circuit Court

Personally appeared in open Court John Gates, late a private soldier in the Virginia Line of the Continental Army, 67 vears, resident in Williamson County in said State of Tennessee: being first duly sworn, doth declare that he served in the revolutionary war, that he entered the service on the 10th day of February 1778, under the command of Capt. Wm. Fowler in the 5th Virginia Continental regiment, commanded by Col. Joseph Parker, in which he served for twelve months, received his discharge, not being at headquarters when that term of service expired; That in a few days after the expiration of said term he entered again into the service at Williamsburgh in the State of Virginia, in a company commanded by Capt. Opie Devinporte, the number of the regiment not remembered. but commanded by Col. Charles Dabney; that he continued thereafter in the service without interruption until the 20th of Sept. 1781, when he was discharged in the city of Richmond, State of Virginia; the whole term of service being about three years, seven months. He is in his sixty eighth year. has no other evidence of his services but the accompanying discharge: that he is poor and in indigent circumstances; has received no pension, either from the General government or any of the States of the Union; that he was a resident citizen of the United States on the 18th of March 1818. and has not since that time by gift, sale or in any manner disposed of property, nor has any person in trust for me, nor have I any income other than that which is contained in the schedule hereto annexed; my occupation is a farmer, but from age and infirmity I am unable to pursue it - [p. 9] I have a wife and five children... said petition certifies his wife is about the age of himself and not healthy: his children have all married and left him, and are just able to take care of themselves.

Schedule of property: 2 head of cattle, one be & furniture, 8 or 10 hogs, a few common cooking utensils.

Bryan has drawed said warrant as I am informed and was impowed by another family of the Coopers but the man I did purchase of is the only heir to it. I proved the heirship by Capt. William Edwards of Sumner County, near Gallitin (sic), who brought sd John Cooper, the only heir from NoCarolina, Bertie County about 30 years ago and said Edwards raised him from a child, as he has swore to the same. Genl Bryan, I expect, did not know of said heir. He the heir does now live in Maury County. I can convince Bryan so soon as I see him that he did not get the claim from the proper heir. I do not know whether Bryan has purchased said Wt. or not, but he has drawed it. I proved even the Capt. that John Cooper enlisted with & served with which was Capt. John McGlaughan of Bertie, so if the warr'. does come forward. I wish to have the matter investigated. Genl Bryan I am informed is in this state. The said John Cooper, the only heir is the

son of Thomas Cooper, and only brother and all the heir to sd John Cooper decd soldier, afores^d. Capt Edward is a man of undoubted Character and was raised in the neighbourhood where sd John Cooper deed was & knows all the facts relative to it. I shall be down within a week or two I expect. I am your etc.

A Checklist for Searching Middle Tennessee Before 1820

Compiled by Carol Hughes Gipson Edited by Charles A. Sherrill

For more than twenty years now I have been chasing Robert Hughes, one of those elusive ancestors who left very little evidence of his existence. He came to Tennessee from Virginia in the early years of statehood, a time period which can be difficult to search. I was often at a loss where to look. Recently, I ran into the same difficulty compiling documentation for my First Families of Tennessee application on ancestor William LeFever. As a result, the following checklist was put together for my own use. It is a compilation from many sources: books, notes, charts, and lectures, and is used in my Beginning Genealogy course which has been offered at the Nashville YWCA. By no means is this a complete list of all the resources available for the period before 1820, but it has helped me immensely in my research.—CHG

Prior to 1820 there are not a lot of comprehensive resources available on middle Tennesseans. It can make the search for pioneer ancestors quite a challenge since records from various and sundry places must be accessed. Many early records are available on microfilm, and others have been published. Some cover the entire state, while others must be searched county by county. The information is out there, it's a matter of knowing where to look.

Census

The earliest U.S. census available for Tennessee is the 1820.

Histories

For the broader picture, there are a good many early histories of the state and some of middle Tennessee that include:

Court Records

In early Tennessee, from 1796-1809, minor cases were heard in each county's Court of Common Pleas & Quarter Sessions; larger cases and appeals were heard in the Superior Courts of Law and Equity. Middle Tennessee was covered by the Robertson, Mero, and Winchester districts of the Superior Court. Of those, only the Mero District has a significant body of surviving records. In 1809 Circuit Courts were established to hear criminal cases in each county, and the state Supreme Court was formed. Case files of some Supreme Court cases can be found at TSLA. Microfilm copies of many counties' Circuit and Common Pleas minutes are also available.

At the state level, minutes of the Mero District, Superior Court of North Carolina, which was held in Nashville, are available through 1809 in a 10-volume set of typescript copies:

Published local records are available for each county, including the Works Projects Administration (WPA) transcripts. TSLA has miscellaneous local records on microfilm.

A vast amount of miscellaneous genealogical records, such as Bible records, personal diaries and journals, genealogical papers, and church records, have been donated to libraries and archives. Many have been microfilmed. At the TSLA these are available in the manuscripts section. Other published resources to check are:

Records found at the county court houses are a valuable resource but must be accessed individually. Middle Tennessee researchers are fortunate in that the Tennessee State Library and Archives has the majority of them on microfilm in one central location, and for the rest of the country, the Family History Library (LDS) has the same records available for reading at many local branch Morman libraries. If the county you are searching was not formed until after 1820, or if it burned, you may want to check the parent county from which it emerged. Counties in Middle Tennessee in order of date formed appear in the chart which follows.

Middle Tennessee County Chart⁴

Washington County was formed in 1777. It covered the present state and was parent to many counties including Sullivan (1779), Davidson (1783), Greene (1783), and Carter (1796). Present day Washington county is located in eastern Tennessee. The county seat is Jonesboro.



The Winchester and Alabama Railroad

This Railroad was incorporated in 1850 as a feeder line of the Nashville & Chattanooga Railroad and was proposed to run from Winchester, Tennessee, to Alabama, in the direction of Huntsville. When it



was disclosed that the Nashville & Chattanooga Railroad would not pass through Winchester [the county seat], a connection of the Winchester & Alabama Railroad with the Nashville & Chattanooga

line failed and work was suspended. Finally, it was reorganized in 1857 and completed from Dechard through Winches-

ter to Fayetteville that same year.

Sewanee Mining Company Railroad

This road, built as another connection with the Nashville & Chattanooga Railroad, extended from a point near the Nashville & Chattanooga Railroad tunnel in Franklin County to the coal mines in the neighborhood of present Tracy City [in Grundy County].

The Sewanee Mining Company, capitalized in 1855 with one and one-half million dollars, owned 18 acres of mineral and timber right and planned to supply coal to the region between Nashville and the South Carolina and Georgia ports. Nashville has been dependent upon the shipment of coal on the Ohio and Cumberland Rivers, which was uncertain because of frequent low water, and at time had to pay as high as twelve dollars a ton for its coal.

With the completion of the Sewanee Mining Company's nineteen miles of railroad in 1855, Nashville was in a position to profit from cheaper and more dependable supplies of coal. This lead to a new corporation that was chartered just before the outbreak of the War Between the States. At that time the railroad title was changed to the Tennessee Coal, Iron Railroad Company which was eventually sold to the Nashville & Chattanooga Railroad Company. 1

During this time period, horses that had strayed from their property onto other land were taken up and held by the persons who happened to have found them. Notices were subsequently placed in newspapers for owners to claim these lost horses.

The following abstractions include the person's name, place of residence, type of horse, and date of newspaper in which the notice was placed. The only information excluded is the full description of the horse and estimated value. All were taken from *Murfreesboro Courier and Miscellaneous Papers*, 1820-1904, microfilm [no roll number given], Tennessee State Library and Archives. The exact reference is given in the endnotes.

BOOK REVIEWS

Tennessee Convicts Early Records of the State Penitentiary, Volume 1 1831-1850 by Charles A. and Tomye M. Sherrill.

Softback 5 1/4 x 8 1/4, 350 pp., index. \$30 plus \$3 shipping from author, 1023 Water's Edge Circle, Mt. Juliet, TN 37122. TN residents add \$2.50 sales tax.

A wealth of information on those incarcerated in Tennessee prisons can be found in this book. Data on each individual normally includes a physical description, notation of where born and raised, a brief family history that often names various relatives, the individual's migration pattern, and the death date if died in prison or the release date. For example, in 1836 Jesse Moore was imprisoned for stealing a mare in Lincoln Co., TN. He was born in Laurens County, SC. He has a wife and 9 children In Lincoln County and a mother, two brothers and two sisters in Laurens Co., SC and two more sisters in Jackson Co., AL, all of whom are named.

The every-name index includes more than 3,000 names. The introduction to life in a penitentiary is fascinating to read as are the individual entries. This may be one instance where you actually don't want to find your ancestor; but, if you do, you'll find a real treasure of information.

Montgomery County, Tennessee 1798 Tax List by James L. Douthat. Spiral bound 81/2 x 11, 32 pp., index. \$8 from Mountain Press, PO Box 400 Signal Mountain, TN 37377-0400.

The arrangement of this tax list is by militia district. Information included with the list is the name of the person, the quantity of land and/or free polls, the situation or location of the land, number of black polls, stud horses, town lots and total personal property. A name and place index is a most welcome addition to this publication.

This tax list has been previously published in other mediums, but if you don't have access to it this will be helpful information and the price is quite moderate. Tennesseans before 1800, Davidson County by Marjorie Hood Fischer. Hardback 81/2 x 11, 406 pp., c1997. \$49.50 plus \$4 shipping from Frontier Press, PO Box 3715, Suite 9, Galveston, TX 77552. TX residents add \$4.41 sales tax.

Fischer has created an alphabetical name index to records in Davidson County prior to 1800 using a format similar to her previously published work on Washington County, Tennessee, The extracted records include inventories, court minutes, wills and deeds. All names were extracted and each entry includes name, type of record, source information and microfilm reel number. A truly welcome and important addition to this volume is the inclusion of the year of the record.

Davidson County was formed in 1783, the first county in the Middle Tennessee area. At that time it included much of what is now considered Middle Tennessee. Thus, those with early Middle Tennessee ancestry will enjoy using this exceptional finding aide. It will be of major genealogical value to researchers and a book they won't want to miss!

John Theophilus Thompson, (1750s–1826) Some Ancestors and Descendants in Frederick County, Maryland, Orange County, North Carolina and Bedford County, Tennessee by Elizabeth Thompson Schack. Spiralbound 81/2 x 11, 134 pp., footnotes, index. Available from author, 49 East 73rd Street, NY, NY 10021-3564.

This publication has been divided into two sections. The larger front section includes a narrative history of the family as described in the title. The second section includes a computer generated listing of the descendants of John and Sarah Thompson and those of the Sledge and Cary families.

Although billed by the author as "not intended to be a scholarly work or an orthodox family history," Schack has done a creditable job of research. The book includes numerous footnotes as well as map illustrations, newspaper clippings and copies of old photographs. Don't miss the index that is sandwiched in between the two portions. Tennesseans with Thompson roots will find this book of great interest.

Blount County, Tennessee Chancery Court Records 1866-1869 Including Divorce Proceedings 1860-1937 and Monroe County, Tennessee Chancery Court Records 1832-1852 Mentioning Blount County by Albert W. Dockter, Jr. Softback 5 1/4 x 8 1/4, 269 pp., index. \$24 plus \$4 shipping from Heritage Books, Inc., 1540-E Pointer Ridge Place, suite 300, Bowie, MD 20716.

The title of this publication accurately depicts the information contained in it. Property disputes, divisions of estates, creditor's claims naming parties involved and many relationships are among the records of interest. Chancery Court minutes are always of special interest to genealogists and it is a pleasure to see them published with a good index. Searching them otherwise is a very tedious process. Those with ancestors in Blount and Monroe counties will want to include this book in their libraries.

The Wataugah Land Purchases by Troy R. Keesee. Spiral bound 8 1/2 x 11, 104 pp., bibliography, index, map, c1997. \$25 plus \$3 shipping from author, 151 Skyline Lane, Powell, TN 37849. TN residents add 8.25% sales tax.

Primarily, this publication contains reproductions of the surveys from Wataugah Purchase Book, Old Book A. The information includes item #, name, date, type, description of land, and the plat drawn from the legal description. The author's map in an envelope in the cover of the publication locates the surveys, based on USGS topographical maps with water courses.

The Treaty of Sycamore Shoals and the

Wataugah Purchase are included in the book as well as an alphabetical listing of NC land grants found in the Wataugah Purchase Book and a list of probable squatters who were named in the surveys.

Keesee has done an excellent job of compiling this book and has included many helpful tools for genealogists seeking out their elusive ancestors in this difficult area of early Tennessee research. If you're working in this area, the book is well worth its modest purchase price.

Kinship Treasures from Coffee County, Tennessee by Sandra Lewis Gray. Hardbound 8 1/2 x 11, 83 pp., appendix, photographs, c1997. \$35 from author, 161 County Road 1101, Booneville, MS 38829.

Families included in this genealogy are Winnett, Butler, Dunkin, Davis and Crow of old Warren County, Tennessee. Many family records were found in Coffee County, established from part of Warren County in 1846. Many of the families migrated westward to Mississippi, Missouri and Texas.

Gray has quite obviously lovingly and carefully researched and compiled this family history which will surely be treasured by descendants. There are several family photographs that enhance the book. Although it contains no source information, there are copies of some documents in the Appendix at the rear of the book. Gray chose to use her own numbering system which is normally not a wise decision, but in this case her system works in the limited amount of generations available in this book.

What is regrettable in a book where so much care has been taken in its compilation is the lack of an index. On p. 63 there is an Index to family names which helps one locate the major players in the book. This is not an index to the book nor does it even begin to substitute for one.

he Bible has the spellings Harkarader, Harkrader and Harkreader. In the Wythe and Montgomery Co., VA. deeds and other records, the name is spelled Harkarader, Harkrader, Harkrider, and Harkreader. When Jacob Harkreader and family moved from his home in Wythe Co., Virginia, to Wilson Co., Tennessee, in 1832, they began using the spelling "Harkreader" exclusively and it has remained as such to the present time.

Jacob Harkarader

born: 25 May 1783 Montgomery Co., Virginia, raised in Wythe Co., VA.

son of: Conrad Harkarader

grandson of: John Harkarader

died: 15 May 1858 Wilson Co., Tennessee, or Robertson Co.,

buried: Harkreader Cemetery, Beckwith Road, Wilson Co., TN. marr: 14 April 1808 to Sarah Halsay (Halsey, Halsy) in

Nashville, TN. occupation: Millwright

It would appear that all of the Harkreaders were in Montgomery Co., Virginia, first until it was cut off to form Wythe County and then they were automatically residents of Wythe County. From the deeds, they all lived on the waters of Sally Run, a branch of Stoney Fork of Reed Creek.

Jacob was in Nashville in 1808 when he married Sarah Halsay. Possibly one reason for this was that he was seeing to property in Kentucky for his father and himself, or visiting his brother, John Harkarader, who lived in Robertson Co., Tennessee, (note that Jacob's Letters of Estate are recorded in Robertson Co., Tennessee, Will Book 16, p.635, indicating he may have been living with a family member or visiting there when he died as he died without a will. Jacob's home was in Wilson Co. but he may have become ill and moved to Robertson Co. to be with a family member). Jacob's father, Conrad Harkrader of Wythe Co., Virginia, sold to his son, Jacob, his 1/7 part or 189 and 2/7 acres of land in Jefferson Co., Kentucky where Louisville was built. Conrad later gave Jacob his power of attorney to sue. prosecute and recover if a suit was necessary his 1/7 part of the land in Kentucky on 5 May 1818. The total acreage in Kentucky was 1,325 acres on the Ohio. Jacob could have been in Nashville in 1808 on a trip to Kentucky to see about the said property for his father and himself when he decided to get married. There were no Harkreaders in Nashville at that time that can be documented. Sarah Halsay could have been visiting a married relative as there were no Halsays in Nashville either. Jacob's brother lived in Robertson Co., Tennessee. in 1820 and later moved to Marion County, Kentucky, and then moved to Wilson Co., Tennessee, where he died. Otherwise, it is a mystery what Sarah and Jacob were doing in Nashville when they married, as young women didn't travel by themselves at that time.

Jacob was christened, baptized and a member of the St. John's Lutheran Church in Wythe Co., Virginia. When he moved to Wilson Co., Tennessee, he became a member of the Methodist Episcopal Church since there were no Lutheran Church in the area. He purchased 71 acres on the Stones Creek in Wilson Co., Tennessee, on March 13, 1832. He was a Mason in Wilson Co. His original home was a large log structure which burned. A frame house was then built on the same site and that is the home the later Harkreaders lived in and where Sidney "Fiddlin Sid" J. Harkreader was born.

Sarah Halsay was also christened, baptized and a member of the St. John's Lutheran Church in Wythe Co., VA.

The Wythe Co., VA. deed indicate that Jacob purchased a total of 554 acres between August 1800 and Aug. 1813. Jacob Harkerader and Jacob Hederich, both of Wythe Co. purchased a total of 104,169 acres in Wythe

Co. on 10 August 1815 for a total of \$125.07 as the land was sold at the courthouse for non-payment of taxes. Jacob and his wife, Sarah, sold on 11 April 1836 when living in Tennessee, property in Wythe Co., VA. The deed is in the Wythe Co., Virginia, Order Book 1833-1837, p.409 but I have not read the actual deed so the number of acres is unknown.

In 1850, Jacob and Sarah lived in District 1 of Wilson Co., Tennessee, and had 1 slave.

Jacob & Sarah named two of their children for Sarah's sister and her husband, Catharine Halsey who married Absolum Gleaves (Methodist preacher in Wilson Co., Tennessee) Jacob's two children were Catharine Harkreader who married Dr. John C. Logue and Absolum Gleaves Harkreader. The other names of Sylvanus and Stephen appear to be Halsay names while all the others were in the Harkreader family.

Sarah Halsy

born: 4 March 1787 probably in Montgomery or Wythe Co., Virginia

daughter of: James Halsay and wife, Sarah Hildreth

died: 25 April 1854 Wilson Co., Tennessee

Curtis Grubb died 21 March 1830 in Wythe Co., Virginia (Jacob Harkreader Bible). They evidently had a child, William Grubb who died on 2 May 1837 in Wilson Co., Tennessee, as the Jacob Harkreader Bible shows his death date.

2d marr. to Baker on 27 Dec. 1832 prob. in Wythe Co., Virginia, as that is where Sarah Grubb lived and the first Baker child was born in Wythe Co., Virginia. (Jacob HarkreaderBible shows marriage date). Possibly Bakers name was John or James, Sarah Baker moved to Wilson Co., Tennessee, between 1833 and 1834 as her first Baker child, Sarah, was born in 1833 in Virginia. and the second Baker child, James, was born in 1834 in Tennessee, The other children she had by 1850 were Mary b. 1836 in Tennessee, and John born 1839 in Tennessee, Sarah lived in District No.1, house no.11 in 1850 as shown by the Wilson Co., Tennessee, census p.624. Sarah also appears on the 1840 Wilson Co., Tennessee, census as head of household. So, Sarah (Harkreader) Grubb Baker was a widow by 1840.

It is from this line that "Fiddlin" Sid Harkreader descended. "Fiddlin Sid" was a member of the original Grand Ole Opry when it began in 1925.

Tirzah (Turza) Harkarader

marr: James W. Hardy 23 Feb. 1841 in Wilson Co., Tennessee, (Wilson Co., TN. Marriages 1802-1850, trans. by E.R. Whitley, p.177; and Early Middle Tennessee Marriages vol. 2, Brides by Byron Sistler p.236)

died: by 15 Aug. 1900, probably in July, in Wilson Co., Tennessee, Tirzah Hardy's will is recorded 15 Aug. 1900 in the original Wilson Co., Tennessee, Wills and Inventories 1896-1900, pp.406-407 as recorded in Wilson County, Tennessee, Deeds, Marriages and Wills 1800-1902, comp. by Thomas E. Partlow, 1987, p.74. The will was recorded on 15 August 1900.

Tirzah's heirs in her will were daughters Margaret A. Sanders and M. E. Sherrill, and the children of her deceased daughter, Sarah C. "Dovie" (Hardy) Baird, to wit: Pansy K., Annie S., Tirzah S., James H., and Ed M. Baird. Sarah C. "Dovie" Hardy (2 Oct. 1842- Sept. 1890) married Dan W. Baird (29 July 18__-7 Feb. 1913). Their 5 children were: James (Jim), Ed M. Baird who married Vallie D. Wright 2 Sept. 1894, Tirzah S. who married Luke Russel & had no children, Ann S. (unmarried), and Pansy K. Baird (unmarried). One of Ed M. Baird's children, Martha, married Wallis Gutridge and they had one child, Sandra. Mrs. Martha Baird Gutridge lived in Lebanon, Tennessee, until her death in 1997. Margaret A. Hardy was an attendant in her first cousin's wedding, that of Margaret Tirzah (Maggie) Logue to Dr. Orville Calhoun Omohundro on May 13, 1868,

husband: James W. Hardy was born 27 May 1815 and died 3 March 1883.

buried: James W. Hardy and wife, Tirzah Harkreader, Dan W. & Sarah C. "Dovie" Baird, and Ed M. and Vallie D. Baird are all buried in the Cedar Grove Cemetery, Lebanon, Tennessee, (In addition to the marriage records, etc., Mrs. Martha Baird Gutridge wrote a letter to Mrs. Virginia Gooch Watson Aug. 30, 1983 with the data on the Hardy-Harkreader- Baird-Gutridge families and tombstone inscriptions from the Cedar Grove Cemetery in Lebanon, Tennessee.

Catharine Harkarader

born: 22 Jan. 1820

died: 30 Sept. 1906 Wilson Co., Tennessee

buried: Suggs Creek Cemetery, Wilson Co., Tennessee marr: 16 May 1846 to Dr. John C. Logue in Wilson Co.,

Tennessee.

The couple lived on Stewart's Ferry Pike, Wilson Co., Tennessee, in the Logue home which is still standing today. Dr. Logue and Catharine are buried in the Logue lot in the Sugg's Creek Cemetery about 1/4 mile from their home. See the biographical sketch on the Logues in the compilation by Mrs. Virginia Gooch Watson, "History of the Logue Homes in West Wilson Co., Tennessee" comp. in 1986. Copy in the Tennessee State Library & Archives. Mrs. Watson has an oil portrait of Catharine (Harkreader) Logue and a pastel portrait of Dr. John C. Logue.

Elizabeth W. Harkarader

born: 6 March 1822

marr: 26 July 1848 to Rufus A. Rozell in Wilson Co., Tennessee, (Early Middle Tennessee, Marriages vol. 2, Brides, comp. by Byron Sistler, p.236 and Marriages of Wilson Co., Tennessee, 1802-1850 by E.R. Whitley, p.222) died: after 1860 in Williamson Co., Tennessee.

buried: Mt. Olivet Cem., Nashville, Tennessee.

husband: Rufus A. Rozell was born 17 Nov. 1810 in Tennessee, the son of Solomon Rozell.

Rufus's brother was Ashley Bascom Rozell (born 11 June 1811 in S.C.) who was ordained as a Methodist minister in 1822 and served various churches in the Tennessee Conference until he retired from the ministry in 1833. Although retired from the ministry, Ashley was instrumental in the founding of the Brentwood United Methodist Church. When Ashley died on 26 Nov. 1886 at his home "Mountview" in Brentwood, TN., he was a very wealthy man owning 1,640 acres in Ark., 110 acres in Memphis lots and large holdings in Texas in addition to his Brentwood holdings. Ashley purchased Mountview in 1865 and it remained in the family until 1925 when Charles P. Wilson bought it. Ray Bell, Nashville contractor purchased it in 1980 and he has sold it recently in late 1997 or early 1998.

The 1840 Rutherford Co., Tennessee, census shows Ruford A. Rozell with his 1st wife and 3 females under 5, his brother, Ashley B. Rozell living in District 1 of Rutherford Co. He lived on Stones River in Smyrna near the Sam Davis residence and also close to Dr. John Claiborne Gooch. When Ashley came to Franklin to purchase a home and stopped at Mountview in 1865, Ashley purchased Mountview immediately.

Rufus and his first wife lived in Wilson Co., Tennessee, in 1840. Rufus and his 2d wife, Elizabeth W. Harkreader, lived in Wilson Co., Tennessee, in 1850 with 5 children from Rufus's 1st marriage and their first child, Ruford A., (or Rufus A.) aged 1. This first child of Rufus and Elizabeth was born April 19, 1849 and died July 2, 1850 and is buried in the Leeville Cemetery, Leeville, in Wilson Co., Tennessee, (Annotated Cemetery Records of West Wilson County area of Tennessee, pub. by the Mt.Juliet-West Wilson County Historical Society, p.75) R.A. Rozell purchased 133 1/2 acres from the estate of Ezekial Cloyd on Stoner's Creek on July 1, 1853 (Wilson Co., Tennessee, Deed Book Z, pp.327-328). Between

1853 and 1860, Rufus and Elizabeth moved to Williamson Co., TN., 15th District to the Rozell home on Franklin Pike known as Mountview.

Rufus A. Rozell was dead by 1886 when his brother died as Ashley reserved a burial ground on his extensive farm at the southwest corner of what is now Murray Lane and Franklin Pike in Brentwood, Tennessee, Ashley's brother, R.A. Rozell and Ashley's granddaughter, Zula A. Murray, were already buried in the cemetery. Rufus A. Roazell's wife, Elizabeth (Harkreader) was probably buried there but it is not known whether she died before or after her husband, Rufus. Ashley left funds to erect a stone wall around the cemetery and head and foot stones over his own grave and those of Rufus and Zula. All of the Rozell family buried in the cemetery were moved to Mt. Olivet Cemetery in Nashville Sept. 23, 1892 in Section 15, Lot 2. The large Rozell monument in Mt. Olivet has 13 names inscribed on it. Rufus A. Rozell's death date was never filled in but he was dead by 1886. Elizabeth (Harkreader) Rozell was not on this monument nor on either of the two footmarkers on the lot. She could have lived beyond 1886, perhaps with one of her sisters or children and could have died in another state. The 1880 Williamson Co., Tennessee, census does not show Rufus A. and Elizabeth living with Ashley or as head of household. However, it is known that Elizabeth's niece, Lillie Forrest Harkreader, daughter of Absolum Gleaves Harkreader, used to visit her aunt "Betty" Rozell in Mountview when she was going to school at Maplehill Seminary in Lebanon and Ward Seminary in Nashville. Lillie entered Ward Seminary in 1884 and graduated in 1886, so she visited sometime during the early 1880's or perhaps the late 1870's. Lillie used to talk about it to her daughter, Mrs. Mary Omohundro Gooch and her granddaughter, Mrs. Virginia Gooch Watson.

Elizabeth and Rufus Rozell had two known children, Ruford A. Rozell born 19 April 1849 and died 2 July 1850; and William C. Rozell born 1858.

Absolum Gleaves Harkarader

Absolum was a Planter and large land owner. According to his daughter, Lillie (Harkreader) Omohundro's papers, Absolum left home at age 10 and got a job, where he was a close student of both law and medicine reading it by firelight and being a man of untiring energy. At his death in 1895, he was the largest land owner in Mississippi. Absolum moved to Miss. in 1868 after the Civil War where he raised race horses, bred Percheron horses and bred a rare breed of Jacks and Jennets traveling to Spain often to purchase them. Absolum joined the Confederate Army as a private in the 7th Tenn. Infantry under Capt. Hatton, and rose to rank of Major; later joined Nathan Bedford Forrest's cavalry

and was captured at Mt. Juliet and sent to prison at Johnson's Island, Ohio, where he was 6 months prior to the war ending in 1865. He was a member of the Verona Lodge No.263 in 1875, later a member of the Ivanhoe Commandery No.10 where he was a Knight Templar. He took his Knight Templar degree in Scotland on one of his many trips there to purchase some of his blooded stock. He was Commander of the Ivanhoe Commandery. He was a Methodist, owned a brickvard in Verona. Miss, with a partner named Paine in 1877: Served in the Mississippi General Assembly from 1880-1882 from Lee County, Miss. Passed the "new railroad law" but refused the offer to take a Senate seat. His home in Verona on Palmetto Road, was still standing in April 1977 and owned by George V. Sample. The Samples changed the interior by adding paneling, etc. but the marbleized woodwork still showed but they had put paneling on some of the walls.

Absolum and his 1st wife had 3 children, and he and his 2d wife had 7 children that lived. Martha had 6 miscarriages totaling 13 pregnancies. It was the 2d marriage that Lillie Forrest Harkreader was born to and named for Absolum's close friend and commanding officer, General Nathan Bedford Forrest.

appear on the 1850 census. They are:

William Brown 27, Margaret 24 (b. 1826) living in Anderson Co., Tennessee, They had a son, Ferrill H., and the H. could have stood for Harkreader.

William P. Brown, 26, Marg 24 (b. 1826) living in Green Co. They had a child, Sarah 1 year old, This child could have been named for Margaret's mother, Sarah.

Reuben Brown 22, Margaret 23 (b. 1827) living in Dickson County.

Thomas Brown 26, Margaret 23 (b. 1827) living in White County.

There were no Brown entries for a M.M., or Mariah or Margaret Mariah. Since the family has no further record of Margaret Mariah (Harkreader) Brown, possibly she did live in East Tennessee rather than Middle Tennessee, or out of the state altogether. The family lost contact with her completely.

TENNESSEE COUNTY was formed in the fall of 1788 and was the third county created in what we now know as Middle Tennessee. The county seat of Tennessee County was Clarksville. The land within this county encompassed what is today known as Montgomery, Robertson, Dickson, Houston, Stewart, parts of Hickman, Humphreys and Cheatham Counties, Tennessee.

The importance of this material lies not only in their early date, but also that many of these are grants for Revolutionary War service.

The Tennessee County deed records are found on microfilm as *Montgomery County, Tennessee, Deed Book A.* Page numbers given here are the actual page numbers found in Deed Book A and on the microfilm. Surname spelling is given as originally written, but the word "registered" is indicated as "reg." in this series. —YGR

MINUTES OF THE SUPERIOR COURT of NORTH CAROLINA and MERO DISTRICT

Abstracted and annotated by Dorothy Scott Johnson

At the time the Mero District was organized it included most of what is now Middle Tennessee, and North Carolina claimed ownership of the region. Thus the original name of the Court was "Superior Court of North Carolina, including Mero District." This court convened from 1788 until 1809.

In the 1930s the WPA Writers' Project transcribed minutes of this Court and entered them in four books which were then placed in the Tennessee State Library and Archives. What happened to the originals of these minutes was unknown until 1997 when they were discovered in a local depository and transferred to the Metro Archives. At this time they are being prepared for microfilming. See MTGS *Journal*, Vol. XI, Number 1, page 36, for the announcement of the discovery.

Occasionally someone will erroneously cite the Davidson County Court minutes of the period as belonging to the Mero District, but perusal of those minutes prove conclusively that they are not the same.

All legal definitions are taken from *Black's Law Dictionary, Fifth Edition* and will hereafter be referred to as "Black's." Many abbreviations in this work are not in Black's and appear to be the original clerk's own brand of legal shorthand. Since no log exists explaining the meaning of these abbreviations it is necessary to use them as they are written.

The page numbers given here are the pages of the WPA typed material, with the original page number in parenthesis.

John Blackamore vs. David Hay, F. Stump & James Shaw.

Action: On motion of defendants' counsel to debate the suit, arguments being heard for and against the motion by counsel learned in the law, the Court will consider and advise.

The Government vs. John Commins

Action: Commins's counsel moved to tax the prosecutor with cost of suit, it being suggested to be a frivolous and malicious prosecution. Arguments being heard for and against the motion, the Court are of opinion that it is both frivolous and malicious and, therefore, ordered that the prosecutor be taxed for the costs.

Andrew McNairy appointed Clerk

Andrew McNairy, clerk of the Superior Court of Law resigns his commission as clerk under the Territorial Government and was reappointed Clerk of the Superior Court of Law for Mero District. He entered into bond in the sum of \$10,000. with William Taitt, John Irwin and William Black, his security for performing the duties of his office and also for his accounting and payment of all tax on law proceedings, fines and amercements [Black's: Fines imposed upon an officer for some misconduct or neglect of duty] and took the several oaths prescribed by law for his qualifications.

WPA p. 208-209. (Orig. p. 177) Mon. 9 Nov. 1796

William Sanders vs. Richard Moore & William White

Case: Attachment. Judgment by default.

Particulars: Richard Moore and William White, executors of John Marshall, deceased, was attached to answer William Sanders. The plaintiff was represented by Bennett Searcy, Esquire. Moore and White in custody.

Sanders claims £212.19.4 sterling money of South Carolina, of value of \$912.71, which Moore and White as John Marshall's executors unjustly detain. On 22 October 1795 Sanders sued Moore and White in a certain plea of trespass out of the Court of Common Please of Ninety Six District in South Carolina and obtained judgment on 1 May 1795. This judgment remains in full force and has not been satisfied, recalled or annulled.

Sanders states that John Marshall was a resident of the State of South Carolina at the time of his death and that the said Richard Moore and William White, executors, are also residents of South Carolina so that the ordinary process of law cannot be served upon them. For this reason Sanders obtained an attachment agreeable to a statute in the case against the estate of Marshall. Moore and White, although often times requested by Sanders, have altogether refused and still doth refuse to pay said amount. Sanders claims damage of \$912.71. Defendants failed to appear and plead and a judgment by default was entered against them.

Elijah Robertson vs. David Allison

Case: Pleas of Abatement [Black's: Objects to place, mode, or time of asserting suit and allows suit to be renewed in another place or form.] Arguments from counsel learned in the law being heard and maturely considered by the Court, they are of

opinion that the Plea in Abatement obtained in a lower court was illegally admitted and that the plea be set aside.

WPA p. 210-211 (Orig. p. 178) Mon., 9 Nov. 1796

Elijah Robertson vs. David Allison

Action: Allison moved to set aside the judgment by default and the Court are of the opinion that it should not be set aside.

Samuel Kerr vs. Reese Porter and William Bovd

Case: Ejectment.

Particulars: Reese Porter, William Edmondson and William Boyd attached to answer Samuel Kerr in a declaration of ejectment as follows:

Territory South of the Ohio [River], Mero District. John Den complains of Richard Fen who is in custody: on 9 Feb 1791, in Davidson Co., Kerr leased a 640 acre farm to John Den for ten years but before the lease was up Richard Fen, with force and arms, ejected him and committed other wrongs, to Den's great damage and against the peace and dignity of our Territory.

Said 640 acre farm, with tenements and appurtenances, was on the head branches of Gibson's Creek and Buckhanon's Spring Branch on the north side of the Cumberland River, and adjoined John Buckhanon, James Scott, Gibson and Swanson.

On 15 February 1791 [six days into the lease], Richard Fen, with force and arms, entered into the tenements and ejected John Den out of the farm. John Den states he was injured to the amount of £100. John Den sues Reese Porter, William Edmondson and William Boyd as they are now in possession of, or claim title to some part of the farm.

Elijah Robertson, the plaintiff in this case, says he is being sued as a casual executor and has no claim or title to the property. He advises Reese Porter, William Boyd and William Edmondson to appear at the first day of the next Superior Court of Law held in Nashville on the second Monday of November, 1796, whereby Robertson asks they be made defendants instead of him.

Robertson states, "Otherwise I shall suffer a judgment to be entered against me and you will be turned out of your possession your loving friend Richard Fen," 11 August 1795. To which ejectment the defendants came into court and entered a plea

of not guilty." Jury:

Verdict: The jury found Willie [William] Edmondson and William Boyd guilty of the trespass as charged and assess the plaintiff damages of Six Cents plus costs. The jury further found the defendant, Reese Porter, not guilty.

Deed from Nicholas Long to John Turner

A deed of conveyance from Nicholas Long to John Turner, for 640 acres of land, the signing, sealing, and delivery thereof was duly proven in open court by the oath of Rhodham Rawlings, one of the subscribing witnesses. Let it be recorded."

Deed from John Eaton to John Coleman

A deed of conveyance from John Eaton to John Coleman for 640 acres of land, the signing, sealing, and delivering thereof was duly proven in open court by Rodham Rawlings, one of the subscribing witnesses. Let it be recorded.

Samuel Kerr vs. Reese Porter, et al

Barkly William Pollock, a witness, proved two days attendance and eight miles travel.

Reese Porter Disclaimer

The defendant, Reese Porter, disclaims all the land contained within the plaintiff's title except that part lying within the grant originally issued to John Ford under whom said Porter claims; said grant bearing date of 16 February 1786.

Samuel Kerr vs. Reese Porter et al

Joseph Love, a witness, proves eight days attendance, and two ferriages. John Walker, Adam Hope, and Joseph Phillips, witnesses, prove eight days attendance and two ferriages each.

WPA p. 212 (Orig. p. 180)

Tuesday, 10 November 1796

John Parks vs. Frederick Stump

Case: Certiorari [Black's: A writ issued by a superior to an inferior court requiring the latter to produce a certified record of a particular case.]

Particulars: Frederick Stump, late of Davidson Co., was attached to answer John Parks in a plea of detinue [Black's: Wrongful detaining of someone else's property], by James Do Hertie, Esquire, his attorney. He states that in 179... he was in possession of his own property, a certain negro boy named Myors of a yellow complexion. Later the negro boy came into the possession of Frederick Stump who knew he was the property of Parks. Parks often asked for the return of the negro but Stump unlawfully and unjustly detains him to John Parks's great damage.

Plea: Frederick Stump, by his attorney John Overton, plead *non detinet* [Black's: He does not detain].

News of Bedford County, Tennessee, 1832 John Shofner's Letter to North Carolina

In the Southern Historical Collection, Manuscripts Department, Library of the University of North Carolina at Chapel Hill, is a series of correspondence entitled *Michael Shoffner Papers*, 1777-1873, which consists mainly of letters to Michael Shoffner from his brothers John and Daniel Shofner. Other undated items are "a list of birthdates, deeds, Michael Shoffner's will, a complaint about Michael's millwork, and two hair samples."

John Shofner (1787-1857) of Bedford County (Duck River and Shelbyville), and Daniel Shofner of Carroll County, Tennessee (Crooked Creek, Huntingdon, and Sandy Bridge) were siblings of Michael Shoffner (d. 1874), a farmer and grist miller in southern Alamance County, North Carolina, (Hartshorn Post Office). Michael Shoffner was married to Sarah "Sally" Shoffner (1788-1862), and was later married to Mrs. Nancy Stafford Spoon.

Their father was Michael[?] Shoffner who died in Tennessee, 30 September 1838, having moved there around 1808 at age 50. The father was survived by one brother Frederick, 74 grandchildren, and 84 great grandchildren (according to letters of 28 August 1834 and 5 October 1838).⁴

The following is one letter from the collection and contains news about a number of neighbors in addition to the Shofner family. 5 The spelling and punctuation of the original is maintained for this transcription. (Note: As a rule the Tennessee relatives spelled the last name with only one "f" instead of two.) —Ed.


[Addressed to "Mr. Michael Shofner, Orange County Holts store Post Office N. Carolina"]

"Bedford County Tennessee June the 2 day 1832

Dear Brother

I onesmore Set down to address you with a few lines at the same time must call you to recollect that this is now the third letter sense I have received one word from you nor have I herde from aney of the friends in north carolina Sense brother Daniel left I have rote twise to George Hufman and onest to Nathaniel Robertson and no answer from none and I wish to here from thare and I will send you this one mor letter and ask you onest more whether you are willing to keepe up a corrispondence with me and if you are not. I must apply to some other sourse as I must here from there. I will now try to give you all the infurmation that I can relative to your connections here.

father and his old lady are in tollerable helth tho father is often weary puney and sickley his occupa-



tion is to rase cotton for markit[.] He also rases more stock then he needes som fine horses he is prosperen: Philip burrow and all his children except Nimrod are living in the district[.] I can't tell how they do but from infurmation none of thame are prosperen much but live free from want that is jenerley have plenty[.] Adam Eulis rases grain and is prospering jererley out of debt and money plenty by him and when ever he seese a bargin he is prepard. he has three daughters maried Span and kimbrey are not dooing much but Jenkins is getting along veary fast and will do well if he has luck.

Brother Christen widdow and children are doing well considrin thare situation I am remarcable pleesed with his children for industrey the finest children that I almost ever saw, none maried. Bill holt is

doing nothing drinks weary hard and of course is always behind his two oldest daughters are married the oldest maried a Jones & the youngest maried red James Holts sone hur cozin nerey one done much. Frederick is prospering his occupation is stilling his two oldest daughters are maried which is [ink blot] [second page] the oldest maried wiley [or Willy] kimbrew sone of John kimbrews[.] the youngest one maried gabrel shofner sone of uncle peters was maried on thursday last had a weary splended wedding and yestereday the infare we was also thare a weary large comopany of people uncle peeter as is usul missed none of his friends nor neighbours and all as free as warte[?] booth famileys had weary costly dinners: John Deen that maried Salley follers stilling for his occupation and keepes about at a stand[.]

Wilson Brown that maried polley his occupation is merchandisen and holds a grabeal of property and from appearence is getting weary rich: Brother Austin is trying to get rich and is getting a long tolerble well in the children way has 5 boys and one girl the last of the familey comes myselfe and I do as well as I can and not much at that I still try to rase cotton for market this year I have about ten acres in cotton that stans well and three more that art to have ten times as much as it has owing to bad seede it did not cum up[.] my crop is samll this year I have twenty acres in corn twelve in wheete and ten in oats and I think if the weather keepes dry a little while longer that I shall make a wonderful crop of oats but if it should bee wet it will lodge as it commonley dose but I shall not bee much disappointed as I sode it for my hogs but shold it stand up I will then try to save all of thame[.]

people here are about to make a pave rode from Shelbyville to Nashville our commersicle sitty about fifty miles it is let out by Sheeres at \$100 a share I have taken one share it is thought that a sum between \$3000 and \$4000 will make a mile on average there is a bout one hundred and fifty thousand dollers of stock but we fear hardley anough to do the rode our cuntrey is till improving but our oldest land is beginning to fale and nearley all the people are sowing red clover for pasterage and to recuit thare land those men that have large fields of clover have the finest cattle and get a bundence of milk and butter[.]

[third page] Joel and Mattildey are living in bidford at this time and are making of a crop but I suppose daniel has informed you before now. Nicolus Antoney and his sone Youngar marking stone ware equal to aney imported— our sirkit cort begins on monday and I am summoned a juror and expect to have to attende

two weeks that is the length of time that a cort jennerley lasts[.] crops in this cuntrey is late in the jenerel owing to the cold spring but old corn is plenty the prise of old corn waries from 50 cents to one collar a barrel: the truth is it can hardley bee sold old wheete is scerse and midlin high but we flatter ourselves that wheete will bee tollerable good this year: Daniels horse archer stands in our neighbourhood and is doing well has at this time I am informed between 70 and 80 [torn] at \$4 dollars the season—

we have [torn]ven children alive as I expect you have [marked through] forgot how maney we have[.] Martha is the youngest she will be three year old in august I shall have to close my letter as it has been so long sense I received a letter from you I feel at a loss how to rite those lines leeves us all well and just as happy as we can bee in the bussle of this world peasant at home and peese a broad and a plenty to live on if it is course and not filled up with the plent of nicknacks it is something like hog and hammoney give our respect to all our friends we remain your affectionate brother and sister til death

A list of murders and depredations committed in Mero district, between the 16th and 23d of January [1793]

KNOXVILLE, February 23-

Jan. 16. Col. Hugh Tinnin was fired on near Clarksville, on the north side of Cumberland, and badly wounded.

Jan. 18. Maj. Evan Shelby. (brother of governor Shelby) James Harry, and a negro belonging to Moses Shelby, killed, and a number of horses taken, on the north side of Cumberland, near the mouth of Red river.

Jan. 19. Two boys of the name of Davidson, were fired on in a canoe, near Clarksville.

Jan. 22. Capt. William Overall and
Burnel killed, on the trace from
Kentucky to the Dripping Spring. The
flesh was cut from the bones of Overall,
and carried off. Nine horses, loaded with
goods and whisky, were taken at the same
time.

Jan. 24. A salt boat from Kentucky, and a French pettianger, were fired on at the mouth of Half Pone, on the Cumberland. In the salt boat Melachiah Gaskins and David Crow killed—Robert Wells and John Melugen wounded, the latter in five places; his life despaired of; St. Clair Pruit shot thro the knee—since dead. In the French boat two were killed and one mortally wounded.

Jan. 26. Thomas Heaton, and Anthony Bledsoc (son of Col. Anthony Bledsoc) were fired on near Nashville, on the north side of Cumberland, and both shot through the body; they are yet living.

It is to be observed, that these murders and depredations were committed after the troops of Washington district, commanded by Captains Christian and Tate (part of Major Sharp's battalion) were withdrawn from the protection of Mero district.
