"Charles Robertson of Early Davidson County, Tennessee" A Critique

An article in *Middle Tennessee Journal of Genealogy & History*, Volume XIV, No. 1, by Mr. Tom Robertson erroneously claims that General James Robertson's younger brother, Charles, was a nephew of Colonel Charles Roberson of Watauga and son of John who was born in Virginia, a son of Israel Roberson. There are no records connecting the two families and, in fact, the evidence disproves a relationship.

THE IMPORTANCE OF THE ROBERTSON FAMILY to early Middle Tennessee history requires a response to "Charles Robertson of Early Davidson County, Tennessee." To distinguish the two Charleses I will adopt State Supreme Court Justice, Dean of Tennessee historians, and noted author Samuel Cole Williams' identification of John Robertson's son – and General James' brother – as "Buffalo Charles" and the other of the same name as "Black Charles."

Felix Robertson and Lavinia Craighead, children of General James Robertson, several times wrote historian Dr. Lyman C. Draper that their grandfather John Robertson was a native of Ireland and married Mary Gower in Brunswick County, Virginia.² They had abundant opportunities to learn about family histories from their parents. Felix Robertson was well educated - a medical doctor, president of the Bank of Tennessee, professor at the University of Nashville, twice mayor Nashville, and president of the Tennessee Historical Society. It is inconceivable that Felix (33 when his father died and 62 when his mother passed away) and Lavinia would not know the birthplace of their own grandfather! It requires strong evidence and factual documentation to demonstrate Felix and Lavinia were mistaken, and the original article in the summer issue of Journal of Genealogy & History fails to dispute the Robertson children's written reports.

Mr. Tom Robertson presents his case that Black Charles was born 24 July 1733 in Prince George County, Virginia, a son of Israel Roberson.³ However, it should not go unnoticed that the grandson of Black Charles, William B. Robinson, wrote Dr. Draper that his grandfather was born in Scotland!⁴ Mr. Robertson believes Black Charles married Susannah Nichols and

lived in Tryon County, North Carolina and probably across the border in South Carolina before migrating to the Watauga Settlement in what later would become East Tennessee. It is true that Israel had another son John, born in Prince George County on 8 May 1723⁵ that the author attempts to prove was the parent of Charles Robertson of Davidson County.

Most Robertson family researchers, including Mr. Tom Robertson, agree that Buffalo Charles' father John Robertson lived for a period in Brunswick County, Virginia, married Mary Gower and that they had children Charles, James, John, Elijah, Sterling, Mark, Ann, and Elizabeth. This Charles married Susannah Cunningham⁶ and died in Davidson County sometime between the date of his 7 July 1805 will and its probate 10 April 1806.⁷

"Charles Robertson of Early Davidson County, Tennessee" tries to link Israel's son John with the father of the Davidson County Robertsons through two records, both of which deserve careful scrutiny since they are the only evidence presented in an effort to tie Buffalo Charles' father to Israel:

- A land title in Granville County, North Carolina wherein Israel Roberson sold 300 acres to a John Roberson⁸
- (2) and the fact there was a John Robertson living next to Matthew Roberson, the eldest son of Israel, on the Roanoke River in Lunenburg County, Virginia.⁹

On 6 December 1749 Israel sold John Roberson land in Granville where he "now lives." 10 John was still a resident "of Granville County" when he sold the same tract on 3 March 1756 to William Barry. 11 It is important to note that this John is not identified as a son of Israel as were transfers of lands to Israel's other sons. Also, it was a sale, not a gift as Israel had made to other children. This, of course, does not mean this John was

not a son of Israel, only it is not proved through the document cited as evidence of a relationship. At any rate, he was not the father of Buffalo Charles.

At the time this John purchased acreage from Israel Roberson in Granville the father of Buffalo Charles was living in <u>Brunswick</u> County, Virginia. (All underlining mine for emphasis.) John Robinson witnessed a deed in <u>Brunswick</u> County on 7 July 1743, and he signed by his "X" mark. 12 It is worth noting that Israel's son, John, would not have been of legal age at this date. On 6 June 1745 John Roberson, identified as of <u>Brunswick</u> County, purchased 351 acres from Richard Huckiby "late of the County of Brunswick" for 50 pounds. 13 On 29 June 1745 John Robinson "of the County of <u>Brunswick</u>" borrowed eighteen pounds from William Broadnax "of Prince George County" and put his 351 acres up as collateral. John signed "X." 14

In June 1748 John Robinson and families that would be connected by marriage to the Robertsons -William Gower, Thomas and George Reeves, William Maclin, and James Clack - are on Sterling Clack's list of Brunswick County voters. 15 On 25 March 1751 William Broadnax still "of the County of Prince George" relinquished title for the collateral property to John Roberson "of the County of Brunswick" after John repaid the eighteen pounds owed. The land is identified as 351 acres "now in possession of said Roberson." 16 These records make it clear that Brodnax who lived in Prince George County in 1745 and 1751 did not occupy the land. John Roberson is identified in both years as residing in Brunswick and had possession of the property. Therefore, Roberson continued to live in Brunswick during the six-year period before he repaid his debt, and Buffalo Charles' father did not live in Granville County, North Carolina in 1749 when Israel sold property to a John Roberson.

Buffalo Charles' father migrated to Lunenburg County, Virginia before 22 January 1754 when John Roberson "of the County of Lunenburgh" and wife Mary sold Mark Harwell 350 acres which was the land mortgaged to Broadnax and title cleared in 1751. Both John and Mary signed with an "X." Land entry, warrant, survey, and eventual title took several years, and on 16 August 1756 200 acres on both sides of Avents Branch in Lunenburg were awarded. (John's son James sold this land 13 September 1767. (John's son James 1754 Buffalo Charles' father John Robinson "of Lunenburg County Virginia" purchased 300 acres on Six Pound Creek from Richard Huckaby in Granville County, North Carolina. (James Roberson and his mother Mary Roberson of Johnston County sold the Six Pound Creek property on 8 May 1764. (21) These records

show that Buffalo Charles' father was living in Lunenburg in 1754 and could not have been the John styled "of Granville" who purchased North Carolina land from Israel in 1749 and sold it in March 1756.

Mr. Tom Robertson also is incorrect in stating that Buffalo Charles' father's property was adjacent to land owned by the oldest son of Israel, Matthew Roberson, in Lunenburg County, Virginia. John Roberson, Junr. received 190 acres on 5 April 1748 on the north side of the Roanoke River bounded by Matthew Roberson and John Eastland.²² On 5 June 1758 John Robinson Senr and wife Mary and John Robinson Jr and wife Elizabeth of Lunenburg County sold 470 acres to James Lewis. The land is recorded as being on the north side of Roanoke River.²³ Clearly the John Robinson living near Matthew on the Roanoke River is different from Buffalo Charles' father who was in Brunswick in 1748 as shown above, married to Mary Gower not Elizabeth, and was not a junior. (The Roanoke River John Roberson's will of 8 April 1773 names a son John among his children.²⁴)

Buffalo Charles' father John died sometime between the date of his will, 20 February 1761, and April of that year when it was probated in the Johnston County, North Carolina Court. John once again signed with his "X," and his wife Mary was named executrix.²⁵

It is alleged in "Charles Robertson of Early Davidson County, Tennessee" that Black Charles was the exclusive trustee, selected by the settlers, to receive the "Wataugah Land Purchase" from the Indians on 19 March 1775. However, in another forum the author writes that Israel's son Charles was engaged in a long series of lawsuits before the Tryon County, North Carolina Court until April 1775. How Black Charles could be in two places, separated by many miles and challenging terrain, at the same time is not explained. To compound the question of place and time is the report that Charles and James Robertson were two of the original magistrates in the Watauga community in May 1772²⁷ when court records place Black Charles in Tryon. ²⁸

It is worth noting that historian Thomas Perkins Abernethy wrote that after James Robertson first surveyed the Watauga lands he returned to Wake County, North Carolina, "....and came west again with ten families of his North Carolina neighbors and kinsmen, including that of his brother Charles." Referring to the Watauga Purchase he continues, "Charles Robertson and his brother James acted, it is said, as agents for the settlers, distributing to them the domain thus secured." Evan Shelby's family operated a trading post on the frontier, "...and among their many customers were Daniel Boone, James Robertson and his brother

Charles..."³¹ On 27 January 1773 Shelby's store has a statement of account with Charles Robertson.³²

Mr. Tom Robertson states that General Robertson's brother does not seem to have owned property in the Watauga settlement. However, Buffalo Charles Robertson had a survey for 213 acres on an east fork of Sinking Creek of the Watauga River on 25 June 1775, adjoining Jonathan Tipton, Cunningham, and Young. 33 This land was granted 19 November 1775. In addition to Charles, his brothers James, Elijah, and Mark also claimed Watauga property in 1775 in close proximity.34 Charles would marry his neighbor Christopher Cunningham's daughter Susannah. Samuel Cole Williams wrote of Buffalo Charles, "The lands of the brother [Charles] were on Buffalo and Sinking Creek near Johnson City's site"35 and "The court's sessions were according to the legislative act to be held at the home of Charles Robertson." A footnote states Charles was a "Brother of James Robertson." 36

On 24 October 1782 by virtue of North Carolina grant #190 Charles Robertson acquired 257 acres in Washington County to expand his holdings on the east branch of Sinking Creek adjoining James Denton, Samuel Henry, and James Henry. The Greene County was established out of Washington County in 1783, and Buffalo Charles appears that year on the new county's tax list. On 23 August 1784 he represented Greene County at the Jonesborough convention of delegates to form a new state.

On 6 February 1786 as a resident of Greene County he sold Joseph Whitson 128-1/2 acres on the eastern branch of Sinking Creek in Washington County next to Jesse Whitson, Samuel Henry, and James Henry. On the same day he sold Jessee Whitson 128 acres on Sinking Creek next to James Denton, Samuel Henry, and Joseph Whitson.⁴⁰ So Charles sold the 257 acres from grant #190 to Joseph and Jessee Whitson but retained his other land on the east fork of Sinking Creek until 22 November 1800 when Charles Robertson of Davidson County, Tennessee appointed Joseph Payton attorney to sell Abraham Byler land "agreeable to the original grant" on Sinking Creek in Carter County (created 1796 out of Washington County) joining Jesse Whitson and Col. Tipton.41 It appears from these records that the first Washington County Court was held at the home of Buffalo Charles rather than Black Charles as claimed in "Charles Robertson of Early Davidson County, Tennessee."42

The first Baptist congregation west of the mountains was organized in 1775 after a religious revival at the home of Charles Robertson on Sinking Creek in today's Carter County.⁴³ Growth of Baptist

churches was sufficient to form the Holston Baptist Association by 1786. A report in the 1791 Sinking Creek Baptist Church records lists officers of other churches in the association, and at Cove Creek (Greene County) are Charles Robertson, William Wall, and Mathias Wall with 36 members.⁴⁴

Mr. Tom Robertson's recitation about Buffalo Charles' lawsuits, absent but represented by attorneys, in Davidson County is essentially correct. Of additional interest is that Charles, probably in anticipation of moving to Davidson County, on 12 February 1796 sold two tracts - one of 317 acres and the other of 300 acres on Cove Creek in Greene County. 45 On 13 February 1797 he is identified "of Davidson County" when he purchased 960 acres from James White on Big Harpeth River at the mouth of Buffalo Creek.⁴⁶ Two days later he bought 50 acres on the south side of the Cumberland River on the waters of Richland Creek adjoining James Robertson.⁴⁷ In November 1798 Charles gave his daughter Elizabeth Evans and her husband Robert Evans 100 acres in Davidson County on the south side of the Big Harpeth River opposite the mouth of Buffalo Creek.⁴⁸ On 9 July 1799 he gave his daughter Nancy Pierce and her husband George Pierce 100 acres on both sides of the Big Harpeth River adjoining Robert Evans.49

By far the most able of the General James Robertson's family researchers is Sarah Foster Kelley of Nashville who contends in her 1987 publication West Nashville - Its People and Environs that Buffalo Charles Robertson "was still in Washington or Greene County just prior to his removal to Davidson County in 1796...".50 Mr. Tom Robertson fails to mention this fact when quoting author Kelley. In this excellent book the writer reports that Buffalo Charles held the title of colonel. However, Mr. Tom Robertson writes that he has found no evidence that this Charles ever was referred to as a colonel. Governor David Campbell wrote Dr. Draper, "Col. Charles Robertson a brother of Gen. James Roberson."51 Hawkins County Senator Joseph McMinn on 10 June 1804 wrote General James Robertson, "...permit me to congratulate you on the happy result of Colonel Robertson's mission to North Carolina, which I presume you will be appraised of prior to this letter."52 Since Col. Elijah Robertson was dead by April 1797 and Black Charles by 1798 this reference could only be for Buffalo Charles. In 1790 Governor William Blount wrote John Gray Blount about an impending visit to Nashville and stated he would have protection from the Indians furnished by a guard and, among others, Colonels Charles and Elijah Robersons.⁵³ The implication by linking the names is that this refers to Buffalo Charles and his brother Colonel Elijah; Black Charles would have been 57, probably too old to provide much protection.

Mr. Tom Robertson believes in a "standard of proof that is necessary to the establishment of a proper genealogy."⁵⁴ This is one point on which we agree!

SOME OF JACKSON'S TENNESSEE MILITIA DEAD IN ALABAMA, COPIED FROM STONES DATED 1813-1814

YEARS AGO a friend of mine who lived in the Coosa-Talladega County, Alabama, area sent me a list of the names on tombstones at Fort William Cemetery. This cemetery is at the mouth of Cedar Creek on the Coosa River in Talladega County. A monument there has this inscription,

"To the Memory of General Jackson and His Tennessee Volunteers While Camped Here, 1814"

While these soldiers, most of whom were from middle Tennessee, were in camp, a measles epidemic broke out and many of the men died. Provisions for the men were scanty as the surrounding territory had few settlers and desertions were many, as the records show.

All of these servicemen were members of the First West Tennessee Militia, Second East Tennessee Militia, or Bunch's East Tennessee Militia. The dates inscribed on the markers cover the period of December 1813 through November 1814.

BRIEF HISTORY OF METHODIST CHURCHES, FAYETTEVILLE, LINCOLN COUNTY, TENNESSEE, 1831-1890¹

THE FIRST AND OLDEST METHODIST Church in Lincoln County we have any record of was organized in 1831. It was called Macedonia Society and the land on which it was located was purchased for the sum of \$1.00 from Marcus Pitts, 5-2/3 acres, deeded to the trustees and successive officers of the Macedonia Society for Divine worship. This land lies on the right


hand side of the Huntsville Highway about eight miles from Fayetteville in the southern part of the County. The deed for this Church was not recorded until October 13, 1836, and can be found in *Book K* at the Register's office from June 13, 1827 to December 27, 1837.

Later this Church was moved a mile further south in 1876 and now stands on land given by John Y. Gill.

The Mulberry Church was organized four months later on November 16, 1831, and land was described as one acre on the east

waters of Mulberry. Other early Churches were Liberty on June 8, 1844, on land bought from Charles H. Edmonson. Fayettevillewas formed in 1845 on land conveyed from William Timmons. Petersburg was organized in 1850.

The largest Church in the County is located at Fayetteville, the county seat of Lincoln. It was really organized between the year 1830 and 1840. Services were first held in the houses of the members. One of the earlier places of meeting was ina little brick shop which was formerly occupied by Mrs. Sam Ramsey as a saddle and harness shop.



block north of the Square. This building was the only Church building left standing after the cyclone of 1851, and stood until the cyclone of 1890, completely destroyed it, and a short while thereafter the present building wa erected. Trustees of the Church at that time were J. A. Lumpkin, I. W. Kirby, W. A. Webb, J. T. Roder, W. J. Stegall, J. S. Vaughn, J. R. Feeney, and E. S. Wilson, clerk. During the Civil War the membership had become scattered and divided and dwindled down to a small number.

Since that date the membership of this Church has grown.

One day Squire C. C. McKinney, now eighty years of age, went down there to attend Sunday School when he was a bare footed boy. He had his pockets filled with three large marbles and when he got there he sought out a back seat and stretched himself out on a bench to take a nap while Sunday School services were going on. After he had gotten himself very comfortably situated the big marbles in his pant's pockets began to run out and much to the delight of the students of the Sunday School and much to his discomfort.

In the County there are at the present time [1930s] eighteen Methodist Churches with approximately three thousand members.

CARING FOR THE UNFORTUNATE

A Partial History of the Davidson County Poor House

by Charles A. Sherrill

N THE NINETEENTH CENTURY MOST POOR PEOPLE WERE CARED FOR BY FAMILY MEMBERS, or loaned a small plot of land where they might eke out an existence. There were a few members of society, though, who had no relatives to rely on and were unable to work. The local government provided funds to care for these indigent citizens. In Tennessee the County Court was responsible for overseeing this public charity. Some counties, like Davidson, erected a Poor House or County Home. A document relating to the Davidson County Poor House was found mixed with unprocessed land grant records at the Tennessee State Library & Archives. Transcribed below, it shows that the county sold the Poor House and its odd assortment of contents in 1818. Ken Fieth, Director of the Nashville Metro Archives, believes there were only a handful of inmates in the Poor House at the time, which may be why the Justices of the Peace decided to close it. The remaining residents were farmed out to private families by the sheriff.

Set[?] I Nathan Ewing Clerk of the Court of Pleas and Quarter Sessions for said County do hereby certify to whom it may concern that the before Recited is True Copies of the Records of the Order & Sale of the Property at the Poor house in said County as the Same Remains in my Office. In Testimony whereof I have hereunto set my hand and affixed the seal of said Count at Office Nashville this 30th day of June in the year of our Lord 1820. [signed] Nathan Ewing.²

The minutes of the Davidson County Court of

January 1818 show that sheriff Joseph Philips was ordered to "let out to the lowest bidder all the poor at the Poor House at the time he sells the chattels, for any sum not exceeding \$60 each, and report of having done so to our enusing court." Philips' report was not found, but the court minutes for the next several months show that Jesse Waller, Fanny Ferguson, Thomas Lovell, Sarah Murrell, Jacob Fudge and Mr. & Mrs. Pierce Guinn were among the poor being cared for at the time.

From 1818 to 1830 the county continued to house the indigent in private homes on the "low bid" basis. Sometimes the poor people themselves were given a direct quarterly payment by the court. A search of the minutes of the Davidson County Court will reveal the names of the poor and (sometimes) the people who took them in. Interestingly, a review of the minutes for 1818 and 1819 show far more orphans than poor adults being bound out to caretakers.

By 1830 this system had fallen out of favor, and in October of that year the county purchased land from William Neely to erect a poorhouse. This location is described in the court minutes as lying between White's Creek and Mansker's Creek.

The 1850 census shows the Poor House in Civil District 22 of Davidson County.⁵ The "Superintendent" was James Porter, a mere 21-year-old and illiterate. Porter, along with his young wife Emily, had the care of 12 souls ranging in age from 28 to 88. The household is listed as follows:

Ithough the state had established a lunatic asylum prior to 1850, it is apparent that some mentally ill people were still being cared for by the Poor House. The distinction between "insane" and "idiotic" was sometimes fuzzy, but it appears that insane referred to the mentally ill, while idiotic was used to describe people who had been low-functioning from birth.

By 1860 the population of the Poor House had grown considerably. The census enumerator included it in the Goodlettsville listings, but it appears still to have been at the same location east of White's Creek. Poor House "Keeper" R.J. Maddox, age 43 and a native of Virginia, lived there with his wife and five children. The other residents were listed as follows and identified as paupers. 6

The number of Irish-born residents in the Poor House was high in 1850 and higher in 1860, reflecting a wave of immigration from Ireland to the United States. These immigrants were less likely to have a network of family members to call on in hard times, and therefore sometimes had to depend on public charity at the Poor House. Problems like this were one factor in the anti-Irish sentiment that was prevalent in America later in the century.

The detailed 1871 map of Davidson County by William Foster shows the County Poor House located north of Nashville just east of White's Creek and north of Ewing Creek. This is probably the location described in the County Court minutes of 1830, when the commissioners reestablished the Poor House. Today, this location would lie east of White's Creek Pike and west of Brick Church Pike, near Knight's Road and Ewing Park Middle School.

After the Great Depression of the 1930s most poor house operations were ceased, and federal welfare programs provided for indigent citizens individually. However, some poor houses and county homes still exist, including one located in Livingston, Overton County. Genealogists should consult the minutes of the County Court in each county for more information about Poor House inmates.

Supreme Court Records, Box 33, Middle Tennessee, 1825

Sevena (a free negro) vs. David Crenshaw

(Original Bill heard in Sumner County Circuit Court)

Sevena, by her next friend Stephen Crenshaw by her attornies, complain of David Crenshaw in custody, etc. of a plea of trespass assault and battery and false imprisonment with force and arms. That the said defendant on the 10th day of February 1825 with force and arms made an assault upon the said Sevena to wit... mistreated her...and imprisoned her without reasonable or probable cause...for ten days...to the damage of the said Sevena \$1,000.00 and therefore she sues, etc.

The repliant said that she is a free person and not a slave the property of the deft. And of this she puts herself upon the country, etc....

Exhibit: ...Deed of Manumission by David Crenshaw: To all whom it may concern know ye that by an act of assembly passed in Virginia May 1782 entitled an act of the emancipation of slaves, therefore I, David Crenshaw of Louisa County from a clear conviction of the impropriety of slavery, do set free the following slaves and their issue, only desire the guardian care of those underage until they become of age:

Roger, Cate, Cain, and Lannon shall go out and be free the first day of December next.

Jerry shall go out the 25th day of December 1796.

Suckey shall go out the 25th day of

December 1802.

Sally shall go out the 25th day of December 1803.

Jack shall go out the 25th day of December 1802.

Stephen shall go out at the age of 21 years, also Charles shall go out at the age of 21 years, entirely free.

...It is hereby observed that four of the above mentioned negroes is disputed in their title to me, of whom namely, Sally Delpha, Viney, and Winney, I only free as to my right and title, given under my hand this second day of August 1794.

8 December 1794. This deed was this day in open court, acknowledged by David Crenshaw to be his act and deed and by the court ordered to be recorded.

Original Bill heard in Bedford County)

On 14 February 1825 Esther Clinton filed a petition to wit: the petition of Esther Clinton respectfully represents that her husband James Clinton was the owner of a tract of land in Bedford county containing 300 acres and by virtue thereof she took quiet and

peaceable possession of a house and tenement thereon on which David Marchant formerly lived. She entered by her late husband's title and not under any other title. Your petitioner states that John Clemmons on behalf of the heirs of said Marchant obtained a writ of forceable entry and detainer...without giving the notice required by law....

Campbell vs. Outlaw (Original Bill heard in Davidson County)

Alexander B. Outlaw, one of the heirs of William Outlaw, dec'd. and guardian of Drew A. Outlaw George Outlaw and Jefferson Outlaw Indiana & Jno Outlaw five others of said heirs for three of whom Ephraim B. Davidson, dec'd. was former guardian; makes oath that said Davidson in his lifetime and while guardian for said heirs did waste the estate of said heirs to a large amount and received of their monies large sums which he applied to his own private use....

Jones & Glass, admrs. of James Jones, dec'd. vs. Craighead, guardian of Martha Goodloe

(Original Bill heard in Maury Co.)

To the sheriff of Maury County, Greeting: You are commanded to take Mary H. Craighead, guardian, and David Craighead in right of his wife said Mary H., guardian of Martha E. Goodloe, if to be found in your county and have them before the next Circuit Court of Maury, on the 3rd Monday in December next, to answer Edward D. Jones and David Glass, administrators of James Jones, dec'd. in a plea that they render to them the following slaves: Tempey, a woman 45 years old; Rhode, a girl 16 years old; Edmund a

boy nine years old; Hannah, a girl seven years old; Patience, a woman 40 vears old: Barbary, a woman 25 years old; Mena, a woman 22 years old; Ephraim, a man 19 years old; Sterling, a boy 18 years old; Philis, a girl 17 years old; Alfred, a boy nine years old; Ned, a boy seven years old; Ferriby, a girl one year old: Bridget, a girl four years old; Mary, a girl one year old; William, a boy two years old: Alexander, a boy seven years old; Amos, a boy about six years old: Solomon, a boy four years old; Jane, a girl two years old; Nancy, a girl three years old; Juda, a girl one year old-being a part of the slaves owned and possessed by sd. James Jones, dec'd, in his lifetime and their increase...

This day comes Benjamin T. Robertson who has married the said Martha E. Goodloe, by his attorney in fact, David Craighead and moves the court that he may be admitted as sole defendant...admits that he has in possession all the slaves that belonged to said James Jones, dec'd. in his lifetime....

Supreme Court Records, Box 34, Middle Tennessee, 1826

Jeremiah Hopson, by James Black his guardian vs. Daniel Brown

(Original Bill heard in Maury County)

On the 8th day of July 1826 the following Bill of Complaint of Jeremiah Hopson an infant by James Black his guardian against Daniel Brown was filed with the clerk of the Chancery Court of Maury County....Humbly complaining sheweth unto your Honor \your orator Jeremiah Hopson , son of Jeremiah Hopson, dec'd, of Maury County, an infant under the age of 21 years, to wit, of the age of five years, by James Black hus guardian of said County of Maury, that your orator's grandmother one Mary Hopson formerly of the State of Virginia (who was widow and relict of one Henry Hopson, dec'd.) having intermarried with one Daniel Brown, Senr. of the sd. County of Maury and being about to settle permanently in the sd. County of Maury....

James Greer vs.
William White et als.
(Original Bill heard in Warren
County)

On the 20th day of June 1827 there was filed a bill in the words following, to wit:

... The bill of James Green, a citizen of Madison County in Tennessee and Isaac Loller of Franklin County against William White, Eli White, Joseph White, ___[blank] Scritch and Ann his wife, Jane White, Elizabeth White, Mary White, James Wilcher and ___[blank], his wife heirs of James White, dec'd....that on 20 September 1783 a certain James White, now deceased formerly of Mecklenburg County, North Carolina, the ancestor of defendants placed in the hands of a certain Isaac Price 219 pounds 18 shillings North Carolina specie claims for the purpose of locating lands in what is now the State of Tennessee and thereupon said Price executed to White his receipt in the following words: "Received of Major James White 219 pounds 18 shillings in specie claims received by me this 20th day of September 1783. Isaac Price." ...That on the 19th November 1783 Isaac Price, Thomas Greer and Robert Erwin formed a partnership in locating lands in the Western Country now State of Tennessee in John Armstrong's office....

Henry Rutherford vs. John L. Wheaton

(Original Bill heard in Madison County)

...your orator Henry Rutherford of Madison County in said State of Teennessee that in the year 1785 he was employed as a deputy surveyor under

William T. Lewis, principal surveyor of the Western District of the State of North Carolina to make surveys in that section of country and amongst others, he made surveys of 97,000 acres of land in the name of Benin. Smith, plats and certificates of which were regularly made out and returned to the Secretary's office of the State of North Carolina and grants issued thereon....but no [funds] were paid of said lands they surveyed for granted to Benjamin Smith were 11 tracts of 5,000 acres each lying on the South Fork of Forked Deer River ... and grants were conveyed by said Smith to Daniel Wheaton... that said Daniel Wheaton many years ago departed this life intestate, leaving Sterling Wheaton and John Lord Wheaton his heirs at law of whom William Wilkerson of Williamson County was their guardian...

"Know all men by these presents that we Henry Rutherford and Leonard P. Cheathma are held and bound unto Mary Wheaton, James Tisdale, Edward D. Tisdale, Sterling W. Tisdale, Daniel Tisdale, Enoch Norton and Deborah his wife, Barney Tisdale, Maria Tisdale, Abijah T. Tisdale, Simeon Tisdale, William Wilkerson and John L. Wheaton in the sum of \$500.00 ...this 18 June 1827...

"The conditions of the above obligation are such that whereas a decree has this day passed in the Chancery Court at Charlotte in a cause wherein the above bound Henry Rutherford is plaintiff and the above obligees are defendants...."

Oliver B. Hays vs.
Griffith J. McKee et al.
(Original Bill heard in Madison
County)

On 4 March 1826 Oliver B. Hays by his solicitors Brown and Hayse came into court and filed his bill of complaint against Griffith J. McKee, William McKee, James F. McKee, and Samuel McKee, heirs of Griffith J. McKee as follows: ...sheweth your orator Oliver B. Hayes of Davidson County that Griffith J. McKee, William McKee, and James F. Mckee, Margaret Ann Morrison and Samuel McKee, heirs at law of Major Griffith J. McKee of North Carolina, dec'd. being entitled to certain land warrants...

...that the said Margaret Ann Morrison departed this life intestate and without issue leaving her said brothers her heirs... That the said Griffith J. McKee afterwards came to this country....

John Bradley & John Wherry vs. Jonas Bedford

(Original Bill heard in Jackson County)

John Bradley, executor and John Wherry in right of his wife Martha Wherry formerly Martha Revis surviving executors of James Revis, dec'd., John Haden the other executor having departed this life, by their attorney complain of Jonas Bedford in custody of the sheriff of Jackson County in a plea of trespass. That on 15 March 1803 at Rutherfordton, Sate of North Carolina the said defendant executed to said James Revis now dec'd. an order in writing on said John Bradley....

George Bell and John McNairy vs. Sterling M. Barnes (Original Bill heard in Davidson County)

Pltff.'s Brief. A Sci Fa was issued against George Bell and Thos. Whiteside, admr. of Jenkin Whiteside, dec'd. as bail fo Anthony Butler. Sci Fa merely recited that a judgment had been recovered against the said Anthony Butler by the said Sterling M. Barnes without showing what kind of judgment it was... The suit was appealed to the circuit court, Bell giving

the said John McNairy as surety for his appeal.

Morgan A. Heard states that he has been long an intimately acquainted with Col. Anthony Butler formerly of Logan County, Kentucky, now a citizen of the State of Mississippi. That about 10 October last he passed within about 75 miles of sd. Col. A. Butler's residence as he came from Texas to this country and saw many of his and Col. Butler's old friends and they informed him that Col. Butler was well and hearty and was then a member elect to the Legislature of Mississippi...

William J. Morton, Post Master and attorney at law told this deponent that he had just rec'd. a letter from Col. Butler from Monticello, Mississippi, this information was given him about the 8th of January last (to wit, 1827)....

John McKenzie & others vs. James Owen, John Owen, and others

(Original Bill heard in Williamson County)

John McKenzie vs. John Owen, James Owen, John Bullock, Joseph Jones, James Jose[?] John Blackburn, John Johnston, James Dobbins, Thomas Owens, Mary Montague and Henry Graves...Bill of Complaint that Thomas Owen formerly of the State of Georgia on the 27th of October 1783 made an entry in the books of the office kept at Hillsborough by John Armstrong, entry taker of the Western Lands of the State of North Carolina. as follows, No. 610. Thomas Owen, 5,000 acres on the south side of Duck River, beginning at the mouth of Rice's Creek, running up both Duck River and said creek for complement....that the land as entered lies in Maury County...that the creek specified in said entry was at and before the date thereof, called and notoriously known by the name of Rice's Creek, but that its name has been since changed and

it is now called Cathey's Creek...

That said Thomas Owen died in said State of Georgia previous to the year 1812, having first made and published his last will and testament, and which has been duly proved and recorded; and by said will devised two thirds of said land as entered to his son George Owen, and the other one third to a certain Mary McKain during her life and after her death to her son William C. McCain and his legal heirs. That afterwards, on 25 May 1812. complainant purchased all right, title and interest of said Mary McCain and her son William in and to said 5.000 acres of land and obtained from them an assignment of their said interest...

That said John Owen and James Owen claim said 5,000 acres of land as heirs of one Thomas Owen, formerly of Bladen County, North Carolina...

Georgia, Green County. "In the nname of God, Amen, I, Thomas Owen fo the county and state aforesaid being in a very advance stage of life but of perfect mind and memory...make and appoint this my last will and testament...

To my daughter Ann Rutledge or her heirs \$25.00;

To my son Glenn Owen or his heirs \$25.00:

To my daughter Jane Musgrove or her heirs \$100.00;

Then it is my will and pleasure from a principal of justice that Mary McCain do have during her natural life one third part of the balance of my estate both real and personal and at her decease to go to her son William McCain and the legal heirs of his body forever but in case of no legal issue it is my will in that case that it shall revert back to my legal heirs and be equally divided among them share and share alike.

The other two thirds or balance of my estate both real and personal I give and bequeath unto my son George Owen, his heirs and assigns forever in fee simple.

I also appoint my son George Owen the executor of this my last will and testament... this 17th June 1805 [signed] Thomas Owen

In presence of William Mitchell, Charles Furlow, J. S. Fannin.

Proven in Open Court in Green County, Georgia by William Mitchell and Charles Furlow subscribing witnesses thereto....

Staples & Larkin vs. Gordon Heirs

(Original Bill heard in Lincoln County)

John Den lessee of John Gordon's heirs, Plaintiffs, vs. Isaac Staples and David Larkins, Defendants. Ejectment.

...on 28th February 1825 there issued from the clerk of the Circuit Court for Lincoln County a writ of Capias ad Respondendum as follows: To the sheriff of Lincoln County...commanded to take the body of Isaac Staples and him safely keep...and have him before ...court on 3rd Monday in March next to answer John Den. lessee of John Gordon, Fielding L. Gor-William Gordon, Bowling Gordon, Powhattan Gordon, Rhueben White and his wife Mary White, Andrew J. Gordon, Richard CJ. Gordon, Louisa Gordon, Dolly Gordon, Senior and Dolly Gordon, Junior of a plea whereupon with force and arms he broke and entered the close of the said John Den and ejected him there from to his damage of \$500.00....

McKinney Pierce et al. vs. John Jett and David L. Mitchell

(Original Bill heard in White County)

To the Coroner of White County, Greeting: Whereas at the December Term 1823 of the chancery court ...McKinney Pierce, Patsy Pierce, Sally Pierce and Clarrissa Pierce, Arthur Pierce, Stockley D. Pierce, Edward Stephens and Nancy his wife, Robert Height and Polly his wife and Leonard Wood and Sally his wife, by the Decree of said court recovered

against a certain James Davis the sum of \$1,705.40 -1/2, besides costs...

Thomas H. and Daniel on the _[blank] day of _[blank] 182_[blank] at Davidson County aforesaid were lawfully possessed as of their own property of certain negro slaves to wit Quacker or Quaco and Lovey his wife, Sylvia and her children, to wit, Mancer Omas Arch Jim Nervy Hany Pressly and Ben, also Polly and her children. to wit, Milberry Peggy Mentlo Lucy Jim Kizzy Nathan Louisa and Claiborne, Chaina and her children, viz: Washington, Lealous [sic], Franky, George Mariah and Sylvia of great value, to wit of the value of \$14,000.00, and being so possessed thereof, they the said plaintiffs afterwards...at Davidson County aforesaid casually lost the said negro slaves out of their possession, and the same afterwards...at the county aforesaid came to the possession of the said Philip Shute by finding....

R. To Philadelphia & this place; please take out, for him, his free papers, and supply him with sufficient means (in gold) to defray his expenses, as I presume some of the proceeds of his property is in your possession, giving him such charges & instruction as you may think necessary.

furnish the desired amount and your
bill on me for same will duly honored.
Begging you to excuse the trouble
& hoping to hear from you soon on

Middle Tennessee Professional People in 1857

The book, Nashville Business Directory Containing The Names, Business, and Residence of all Heads of Families, Business Firms, etc., etc., for the city of Nashville and Suburbs, Vol. III, 1857, compiled by The Rev. John P. Campbell, (Nashville, Tenn.: Smith, Camp & Co., 16 Deaderick Street, 1857), surprisingly contains much material for areas outside of Nashville.

All material that was printed in this 1857 Nashville Business Directory dealing with Middle Tennessee villages is given in this seralized article. As one can see, the material published for the various places is uneven. Some towns have a number of listings while others are abbreviated to the point of not giving a true picture of the area. This unevenness extends to the advertisements, called "cards," which were placed with the listings. Some towns have a number of these advertisements while others show one card, usually for an attorney, or none. A representative selection of these advertisements is given here for illustration purposes, and where the article says "See the card of ..." this means a paid advertisement was included in the original book.

Nashville listings, over 228 pages long, will not be presented in this series because of the space required. Middle Tennessee locations—other than Nashville—give certain occupations with names of the persons holding those jobs and are all presented in this article. There are no "heads of families" listing for anyone outside of Nashville.

This 1857 *Directory*, along with volumes for various other years, may be found at the Tennessee Library and Archives, and a few other large libraries.—Ed.

DORAN FAMILY OF RUTHERFORD COUNTY, TENNESSEE

Contributed by Gail C. Barham

Compiled by Rebecca Waitt Lamar, this manuscript is over 50 years old, (no exact date shown-Ed.). In 1989 Gail C. Barham retyped and updated the information.

Given first are letters written about this Doran family, and then the section of the manuscript pertaining to Rutherford County, Tennessee, group is presented here in a somewhat edited form. It should be noted that the compiler does not agree with all the information contained in the letters, so one should compare the two sections.—Ed.

SECTION ONE

A letter from Rev. Paul E. Doran, Sparta, Tennessee, August 11, 1932 to Professor Lowery Alfred Doran, University of Oklahoma

"I am descended from Robert Alexander Doran, who settled in Hampshire County, Virginia, in 1742 or three. He came from County Donegal, Ireland, in 1741 and lived for a year or two in New Jersey near Englishtown. Not liking life there, he came to Virginia and settled in Hampshire County, now West Virginia. There he reared a family and died there; his wife, according to the record I have, was Sarah Elizabeth Reed. To this union were born among others, William Doran and Alexander Doran. I mention Alexander because this is the one in whom you are probably interested. I am descended from William.

"This Alexander was born in about 1760-5. At fourteen or fifteen he entered the Revolutionary army under General Washington as a teamster, driving a munition wagon. He was cited for bravery under fire and was personally commended by Washington. After the war closed he was an overseer of part of the Fairfax estate and after Washington's death he came into possession of part of the land. Robert Alexander Doran was a man about fifty when the war started and served on Washington's staff. It is easy to see how his son should attract the attention of the General.

"Alexander married Elizabeth, daughter of John Lowery; their children were William, Joseph, John, James, Peter, Elizabeth, Alexander. Joseph settled at Sedan, Va., and reared a family and afterward moved to Ohio. John settled at Blacklick, Ohio, where some of his descendants still live. James also went to Ohio. Peter probably never married. Elizabeth married Joseph Caleb Smith and reared a family in Virginia where many of her descendants still live. Alexander was drowned in North River when he was just a young man unmarried. William married Hannah Guard and reared a large family some of whom went to Ohio while Dave and Samuel went to Cloud County, Kansas. I know nothing further about the

children of Alexander and I suppose you would not be interested in the family of William. I might tell you however, that William also served through the Revolution and was given a grant of land, one thousand acres, in the Cherokee Nation in what is now Overton County, Tennessee. He reared a family of twelve sons and two daughters, Mary and Elizabeth. Silas and Ambrose, twins, the youngest children of William Doran were the first to use steam in industry west of the mountains. My father, Marion, was the oldest son of Silas and will be ninety-three his next birthday. He is living now in retirement; he was a doctor by profession and was also an ordained minister in the Presbyterian Church, the ancestral church of the Dorans."

Letter from Rev. Paul E. Doran, Sparta, Tennessee, dated December 7, 1938

Alexander Doran was the son of James Doran who was born in Doran Castle in County Donegal, Ireland, and the third son of the Earl of Donegal. He came to New Jersey in 1741 and two years later settled in the western part of Virginia at a place called Wolf Hills, now Abingdon. His son, Alexander Doran, may have been born before he left Ireland. Alexander became a man of prominence and at his death had an estate of ten thousand acres at Abingdon. Alexander had a very large family. Somewhere I have the names of his children but I cannot now find it. He and his son, William, my great grandfather, served throughout the Revolution. At least one other son served for awhile and was wounded in the Battle of Kings Mountain. There is a story in our family of how Mary Doran and her mother worked a day and night getting bullets and powder ready and of how Mary hitched the old gray mare to the sled and took her load through the line of fire to her brother during the battle.. Before the fight was over her sweetheart was dead and her brother badly wounded and so she took them both to her home in Abingdon on the sled. This Mary was a daughter of Alexander Doran. Later,

she married Coloned Carter for whom Carter County was named, and lies buried near Elizabethton, Tennessee.

"Colonel Carter died leaving one son, and Mary married later a man named Lowery.

"At the death of Alexander Doran his children had some quarrel over the settlement of the estate and they all left Virginia. William got a grant of one thousand acres of land in Overton County, Tennessee, and moved there in 1796. John also came to Tennessee but I know very little of his family. George went to Philadelphia and his descendants are now in Pennsylvania and New York. Alexander went to Ohio where Columbus now is and many of them have been prominent there. One Doran was a member of Con-

gress from that district until has death a few years ago. Alexander Doran, a surgeon in Columbus, and I used to correspond but I have not heard from him in a long time. Others went farther west and the family is numerous in San Francisco now...."

NOTE: Rev. Paul E. Doran's notes do not entirely agree with mine, but I have the family Bible records and wills to prove my line of descent. [signed] R.W.L.

THE INGLES FAMILY and INDIAN DEPREDATIONS

In 1973 Miss Eleanor McAdoo Wiley of Shanondale, 801 Vanosdale, Knoxville, Tennessee 37919, and her sister, Miss May Wiley, had in their possession a manuscript, part of which was dated 13 August 1854. It was written by an ancestress who indicated she was the daughter of William Ingles and his wife, a woman who had been captured by Indians and lived through the following ordeal.

The first part was published in Vol. XIV, Number 2, and this second and final installment deals with the indian depredations concerning the author's brothers. The manuscript, considering the age, was in good condition except for a few passages which are indicated by ellipsis [....]. In the interest of better readability, paragraphing has been added. —Ed.

[Part II]

I now return to give a narration of the life and occurrences which happened to the two infant children who were taken captive with my mother. Shortly they were separated from my mother at the nation when she was taken on the Big Bone Lick, the youngest brother, George, died in the nation. And the other one, Thomas, continued with them 13 years and was so trained up in their savage state that he became accustomed to their manner and as much an Indian as any of them. I can well recollect of several occurrences which happened while he was with them and which I think deserve notice.

One was that while he was still small his Indian father and mother Indian, as was their custom, went off some distance from the nation to hunt and procure meat and his old father took him with them. After being some days in the woods, Thos.' Indian father took sick. The other Indian provided some wood and fixed it so that he could make fire for his sick father and gave him some directions - bringing him water, etc., and started to the nation some 50 or 60 miles to get help to carry the sick man home. However, the very night after the men left the old father died. It also happened that a very deep snow fell and there he was alone with the dead Indian and it would take several days for the other to perform his journey and return. However,

Thos. had learned how to keep up his fire and cook his provisions, and at night he would lie close up to the dead Indian's back and cover himself up with his blanket so as to keep comfortable, though it was so long before the Indian returned that the dead one began to smell and the wolves being very plenty were likely to attack him and would frequently come so near that he would have to get up and threw chunks of fire at them to keep them off the camp; the Indian's

gun was there, but he had never attempted to shoot any. However, he thought he would try and one morning after the wolves had been very troublesome, he got the old Indian's gun and ammunition, and as he had taken some notice of the manner they loaded, he put in a small charge the first time, and there being a

great many wild pigeons about the camp, he tried several times and killed some of them. He then thought he would watch for the wolves that

Right and loaded his gun, but not being strong enough to support it without something to rest on, he got the old Indian's tomahawk and cut a forked stick and drove his fork into the ground so he could rest his gun right in the direction of a

path he had made to the spring and which path the wolves always came to attack him. Immediately when night came, the wolves began to gather and howl around his camp. He got his gun and placed it in his forked stick. Presently the wolves came howling along the path nearly up to the fire; he fired his gun and one fell dead and the alarm of the gun drove off the others,

by that means saving the dead body of the Indian and his own life until the other Indian came to his relief.

Another circumstance which happened while he was with them proved somewhat injurious to him. It was a custom with the Indians to shoot with a bow and arrow. One day while trying to shoot a woodpecker off a tree which was near a large fire the Indians had built for the purpose of barbecuing some meat, in watching the wood-pecker and going backwards, he went into the hot embers and fire and burnt his feet so much that they never grew to their natural size. These are the only events I remember of hearing

him relate.

My father tried many means to recover him, but failed in all until a man named Thos. Baker, who had been prisoner in the same nation with my brother, was redeemed and came home. My father employed Baker to go to the nation and purchase my brother, it being a time when they were at peace with the whites. Baker undertook the business and went to the town where my brother lived and made a purchase of him from his Indian father for something like 100 or 150 dollars, and started with him for hame, having him somewhat confined for fear of his running away, but having to pass through several Indian villages, the squaws got a chance to talk to him and persuaded him to run away from Baker. However, Baker kept him confined until within 40 or 50 miles from any Indian village; then thinking him entirely safe, let him loose, and at night when they lay down to sleep, took little Thomas in his arms, thinking that if he moved he would wake; but behold, when Baker awoke, the little fellow was gone. Baker returned to the village, but could not get him, the squaws keeping him concealed, and was obliged to leave him and return home. However, my father still anxious to release his son from this savage state of life, a year or two after Baker's first effort, hired him again to accompany him. Having made all the necessary preparations for this journey, they started and had to go by the way of Winchester, thence on by Pittsburg and down on the other side of the Ohio River and through several Indian towns, this being the only way that could be traveled with any degree of safety, as it was an entire wilderness nearly from where my father lived to the nation, and entirely unexplored by white men. They pursued on til they got to Pittsburg and found that the Indians had broke out in war against the frontier settlements and were driving all the settlers before them. My father again returned without accomplishing hie purpose and had to wait til the war had subsided.

They again started, and my father thinking it would be a good article and one that might aid in purchasing his son, though a very impudent one, took several small kegs of whiskey - when getting among the Indians their thirst for the rum induced my father to give them some - not thin, lng of the consequences of their getting drunk. They tried to kill him and would certainly have effected their purpose had not the squaws hid him and kept him kid until they got sober. They went on, however, through many other difficulties, til they got to the town where my brother was, which was at the mouth of the Sciota. When they got there they found that my brother had gone with his Indian father to Detroit, and his only chance was

to wait until they returned. This situation was a very dangerous eno but he finally determined to wait, as Baker had several acquaintances with the nation, having been there so long, and also my father having a very good natural turn of pleasing those he was among, The Indians became very friendly and, after waiting 13 days, my father had the pleasure of meeting his son. On learning who my father was, my brother took an attachment to him and was perfectly willing to come home with him.

After paying his old Indian father another pretty round price for him, my father started toward home, the little fellow never showing any disposition to leave him, and becoming more and more attached to him til he got home. It is hard for me to express the feelings of a tender mother on once more receiving to her arms her affectionate child that had been absent 13 years.

Little Thomas, as he might be justly called, for although 17 years old at that time, was much under the common size of boys of his age and an entire Indian in manners and appearance, and could not speak one word of English, and although he was restored to his relatives and friends, his customs were so different that he began to be restless and uneasy, and it was with considerable difficulty he could be reconciled to stay. My father and mother both used every means of reconciling him, but he would take fits at times and would start off and be gone 2 or 3 days at a time, which would occasion great uneasiness for fear he would not return. However, by indulging and humouring him in all his little fits, he became more and more reconciled. It was difficult to get him to change his Indian custom of wearing his cloth and shooting with his bow and arrow and such amusements as he had been accustomed to, but by using a good deal of paine to improve him and to learn him to speak the English language, he became somewhat civilized.

My father then sent him to Albermarl to school to Dr. Walker's; after being there come time, he improved very much in manners and also in learning, and became a very good English scholar, but never got entirely broke of some of his little Indian actions. After remaining with Dr. Walker 3 or 4 years, he returned home quite civilized. Not long after his return, he engaged in the campaign which was going out against the Indians under Gen. Charles Lewis who fought the battle with the Indians at Point Pleasant at the mouth of the great Kanawba. Thomas Ingles was in the detachment which was under Col. Nm. Christian, which was a little in the rear of the main army and was not present at the engagement but got up to the place the same night after the action. He was one of the troops who were stationed there on

the following winter, and when the treaty of peace was confirmed and the Indians came to the point, he fell in with a great many of his old acquaintances and went home with them and staid some time.

The season following, the troops at the point were discharged, and he returned home, and soon after married Miss Elenor Grills. He then settled on a creek called Wolf Creek, a branch of New River. After living there a few years, he moved to a valuable tract of land his father gave him on the head of Bluestone, another branch of New River, and continued there 1 or 2 years, but finding his family so much exposed to the perpetual depredations of the Indians and being the most frontier settler and on a place where the Indians passed repeatedly to kill and plunder, not considering his family safe, he moved 15 or 20 miles more into the heart of the settlement to a place called Burks Garden. It was a situation in which there was settlements all around but none in 10 or 12 miles.

This Burks Garden is a large tract of land entirely surrounded by a large mountain, and no other family living in the place but his own, except an old bachelor and a negro boy of the name of Joseph Nix that lived about 2 miles from him. The situation might have been thought to have been safe as to the excursions of the Indians, being so locally situated and settlements all around and more exposed. However, after living there several years, in the spring of 1782, in April a party of Indians found their way into Burks Garden, and one morning when my brother had gone out into his plantation where a negro boy was plowing, he was alarmed by hearing an unusual noise toward his house. He ran toward the house and when he got in sight, found it surrounded by a party of Indians, and having no chance tO render any relief to his family, returned to where the negro was plowing, out loose the horses and each mounting them, took off for the nearest settlement on the head of the north fork of Holston to what is called the Rich Valley. It so happened that there was & Capt.had called a number of men on that day to muster. He got to the musterground a little artier the middle of the day, being nearly 20 miles from where he started, and on giving the alarm there were 15 or 20 men volunteered to go in pursuit of the Indians. However, as each man had to go hame to get the necessary equipments for the tour, it was night before they could meet to pursue. There was 12 or 15 men started, but it was soma time in the morning of the next day before they could get to the place. When my brother got back home he could not find any appearance of his family, and his house burnt up and all in it except what the Indians carried away. He was then in hopes that they had not killed any of his family but had taken them all prisoners.

The men then agreed to pursue them. The Indians had taken his wife and three children, and a negro man and woman. My brother's eldest child was a little girl five years old called Mary, a little son three years old called William, and a little 6 or ? months old at mother's breast. The Indians, after taking all they needed or could carry, set fire to the house and burnt it up, then packed the two negroes with what they could carry, each taking what he could, and started off with their prisoners. It happened that at the very time the Indians attacked the house, the old man, Mr. Nix and his negro, who lived in about 2 miles off, were going to the house, but on casing in sight of it, discovered the Indians. He immediately took back and both he and the negro boy were on foot; the old man run on. however, across the mountain another direction from the one my brother went. He went to another settlement and gave the alarm, and 5 or 6 men came back with him and got to the place shortly after my Brother's party arrived there and they all Joined in pursuit. They were all men well trained in following Indian trails. The Indians, being somewhat suspicious that they might be pursued, took every precaution to leave no signs that they could prevent, and having to pass through a settlement called Clinch settlement, they moved on very cautiously and slowly. The white men got their trail and pursued it on to the settlement of Clinch. It so happened that there was at that time a company of militia stationed on the frontier as a guard to the settlers and when my brother and his party got to Clinch, there was more men Joined his party and strengthened it to about 20 men, and getting some more supplies in provisions, etc., they pursued on. After the Indians got clear of the settlements entirely and not being pursued as they thought, they became more negligent about putting out their signs. However, the pursuing party used all diligence, and after five days pursuit, discovered they were gaining upon the Indians. They then pursued with much caution, and the Indians thinking themselves out of danger, became more and more careless. However, on the 6th or 7th day, two spies who kept ahead discovered the Indians. In the evening when the Indians had camped, they returned to the party and gave the information. The company concluded that they would lag back and try to ascertain the situation of the ground and encampment that night and not to attack them til daylight. The next morning they arranged their plan, and a Capt. Maxwell who had command of the company was to crawl round in the night with one-half the men to the opposite side of the camp from where they were and bring on the attack at daylight. My Brother Thos. was to crawl round the other side and lie in wait til Maxwell attacked them on his. Unfortunately, Maxwell in trying to get to his point got lost from the camp and could not find it. My Brother and his party got up within two or three feet of the camp under the bank and were waiting every moment for Maxwell to fall on them.

Daylight beginning to break, the Indians began to wake up and move about; the Indians at length discovered the men, took the alarm and began to tomahawk the prisoners. My brother's party jumped upon them as quick as possible. My brother jumped in the camp and got hold of his wife while the Indians were trying to tomahawk her. It was a most unlucky circumstance that although my brother was well aware that on their being discovered that their first effort would be to kill the prisoners, and mentioned it to the men that they might be prepared; with all their exertions the Indians accomplished their purpose. They tomahawked his wife and two of his children - the two oldest - the one at the breast escaped, also the two negroes. His little son was so badly wounded that he died before they left the ground; his little daughter lived 3 or 4 days. His wife was very badly cut in two or three places on her head, but recovered after extracting 13 pieces of her skull. It is astonishing to think that although the men Jumped into the camp immediately when they found that they were discovered and shot several guns at them, the Indians all escaped and with most of their arms. Another unfortunate circumstance was that Maxwell's party had got a half a mile off at the time, and the Indians in making their escape run right through them, and Maxwell, having on a white hunting shirt, one of the Indians shot him through the body and killed him. It was always thought by some of the party that they had killed some of the Indians, but if they did, they got off and so secreted themselves that they could not be found. The party were obliged to continue on the ground until late in the day, on account of my Brother's little son dying and Maxwell's being killed, to try and bury them in some manner; and while they were detained they frequently heard some noise which sounded as a person groaning in the agonies of death, and still searched to find them, thinking it to be one of the Indians who was shot, but the sorrel and brush was so thick that they could not find them. After getting all fixed, they started for the nearest settlement of Clinch which took them about 4 days to perform on account of my Brother's wife and little daughter, being so badly wounded and weak. After the time they got to Clinch, they met my father who had gone on there from New River and luckily took a doctor with him, but my Brother's little daughter's skull was so fractured with the tomahawk that she died next day after they returned to the settlement.

However, the Dr. did my Brother's wife infinite service, and after proper application for a few days rendered her able to travel, and the family that was then left started for New River, and in the course of a few months my Brother's wife got entirely well.

My Brother continued on New River that season with his family, though at that time the Holston country (now the Eastern part of Tennessee) was fast settling, and my Brother Thos, still inclining to be on the frontier on account of range and raising stock, moved to Tennessee and settled on the War, ga, a branch of the Holston river. There was but a few settlers in that country and a good deal exposed to the Cherokees who frequently committed depredations on the frontiers and killed the settlers. He continued to live there 5 or 6 years until he got tolerably fixed so as to live in plenty. The people began to settle tolerably thick around him; he began to get uneasy and restless to get farther on to the West where he could have more room, sold out and moved about 50 miles lower down the Holston river and settled on a creek called Mossy Creek, then an almost satire frontier in a country affording a delightful summer range and plenty of corn for winter range, but laboured under the same difficulty as to the dangerous situation of his family exposed to the depredations of the Indians, though he continued unmolested and improved another very good plantation and very comfortably fixed. But the settlers still following him and settling thick all around him, and as usual, he began to get restless and uneasy, and about that time there was a parcel troops sent down the Holston river and built a fort at the place where Knoxville now is, then called Fort Knox, for the purpose of having some check on the Indians in committing depredations on the frontier; and not long after Fort Knox was erected my Brother sold out his possessions on Mossy Creek and moved farther down in the neighborhood of Fort Knox and settled again entirely exposed to the depredations of the Indians.

Although there was frequently hostile parties of Indians passing and committing depredations on the settlements, his family escaped, and the country soon became settled and the town of Knoxville began to improve. However, my Brother Thos. continued on the place which he settled near Knoxville and improved it and as usual got himself comfortably fixed again, and procured several older tracts of land in that neighborhood and had got his family pretty well raised up, and one of his daughters married and seemed to be settled for the remainder of his life, but hearing of a man who was owing him a considerable sum of money and had run off and went to Naches, and understanding that he might secure the debt in

case he went there, took it into his head that he would go and see him at any rate, and as it was a long and tedious Journey by land and mostly through an Indian country, though friendly (the Chickasaws), he concluded rather to run the risk of going by water, and although there was frequently boats running fram Knoxville to Naches, and Orleans, he concluded it would expedite his journey to go on a small boat, and procured a boat for the purpose. There was two or three other men to accompany him on a trading expedition. They got all ready and started and went on very well til they got to the Muscle Shoals in the Tennessee River. They attempted to pass them without a pilot. The shoals being more difficult and rougher than they expected, and after going nearly through them, the boat upset and threw the men and all their plunder into the river, and all their chance for their lives was to swim or hold to the boat, and the current still buffeting him about near on to the bench, at length got so near that by the assistance of same friendly Indians which they were in view, aiding him. they stopped the boat and him. But what was most remarkable was that when the boat upset, my Brother,s saddle bags which had all his clothes and what money he had with him in them, somehow or cipher in the scuffle, caught in his arms and he held to them with one arm and with the other to the boat til they got to the shore, which was everything that was saved.

Their situation was truly a distressing one - several hundred miles from home and right in the midst cf Indians - all of their clothes, provisions and everything lost, except what my Brother saved by holding to his saddle bags. They were at a considerable stop to know what to do. However, the Indians were friendly and agreed to furnish them with provisions and some other things that they stood in need of, and they finally concluded to pursue their Journey; made the necessary preparations and started again and performed their Journey. On my Brother's getting to Naches, he made some inquiries for his man that he went after, and at length found him, but he was utterly unable to....him so his Journey at the risk of his life was made for nothing. My Brother, after viewing the country, became so pleased with it that he determined to move his family to it, and on returning home, immediately sold off all his property at a considerable sacrifice to get to another new country as he had formerly done, and moved his family and settled near Naches. This last narrative was related to me by my Brother himself on his return from that country, and before he moved his family. After his moving I have had little or no knowledge of what became of him except from hearsay.

...Ye, Ye is not a word? It is "the." This usage is a carry-over from the ancient Anglo-Saxon letter, thorn, which looked similar to a Y and had the TH sound. Other words beginning with the same sound were also thus written: yen, yere, yis, yat, etc. From Val D. Greenwood, The Researcher's Guide to American Genealogy. 3rd Edition (Baltimore: Genealogical Publishing Company, Inc., 2000), p. 25.

...Folio is a whole leaf of a book? In the old records it was customary to number leaves rather than pages; hence a folio would be both sides of a leaf, or two pages. [Greenwood, p. 320]

...messuage is a dwelling house?

...a relict is a surviving spouse when one has died, whether it be husband or wife?

...a consort, as sometimes seen on tombstones, is used to denote a deceased wife of a still living person?

...that in North Carolina, less than 2500 marriage bonds have been preserved for the entire State of North Carolina for the 1741-1778 period? Approximately 7500 marriage bonds (75% of all issued 1741-1778) have been lost or destroyed or are missing. Since only one-third of the marriages performed in North Carolina 1741-1778 were by license and bond (the other two-thirds were by banns), and since three-fourths of the marriage bonds are lost, this total of 2500 marriage bonds that have been preserved represents less than 10% of all marriages performed between 1741 and 1778. Supplement of the INDEX to TENNESSEE CONFEDERATE PENSION APPLICATIONS An Index to the Pension Applications by County of Residence

Contributed by the Tennessee State Library and Archives

INTRODUCTION

In 1964 the Confederate Pension Applications were indexed and published in book form by the Tennessee State Library and Archives. Long out of print and noting additions and errors were found, Chuck Sherrill, Director of Public Services at the State Library, approached Sam Sistler about updating and reprinting the book. Sam consulted microfilm and original applications when necessary to confirm information, and prepared a computer data base. From this file, a new book was issued. It is an alphabetical state-wide listing entitled *Index to Tennessee Confederate Pension Applications*, transcribed and edited by Samuel Sistler (1994), and is available from the Byron Sistler & Associates, P.O. Box 120934, Nashville, TN 87212.

After publication of this 1994 book, the Archives asked Sam to resort the data base by counties and the one copy of this listing was bound and placed in Archives under the call E548.S57, 1995 Suppl. It is part of this unpublished supplemental that is being presented in the Journal.

The Confederate Veteran Pension applications, numbering over 16,000, are on microfilm in the Tennessee State Library and Archives, Nashville, Tennessee. (e-mail: reference@mail.state.tn.us) While most of the Confederate veterans pensioned under Tennessee law served in a Tennessee unit, one must be aware that Confederate pensions were granted by the state in which the veteran lived at the time of application regardless of the state in which the soldier enlisted. Some applications contain information about service, as well as personal history. In questionnaire form, other information may be included such as place of birth, number of children, and value of property owned by the veteran.

Sarah Slaughter by her next friend James Hodge vs. Robert Smith Slaughter

[on Petition for Divorce]

On 17 Nov. 1801, Sarah Slaughter, by her next friend James Hodge, exhibited her petition to the Judges against Robert Smith Slaughter.

Petition

Sarah Slaughter of the County of Davidson, wife of Robert Smith Slaughter, late of the same County, by her next friend and brother, James Hodges, says: that on 19 March 1792, petitioner was lawfully married to the said Robert Smith Slaughter at the county aforesaid...that two years since said Robert deserted your petitioner, that he departed unto places unknown to your petitioner without making any provision for the support to Sarah or her children and that he hath not since returned or contributed in any way to the maintenance of his said family.

Sarah (X) Slaughter

Personally appeared before me, John Nichols, one of the Justices of the Peace for the County of Davidson...

16 Nov. 1801 John Nichols, J.P.

May Term 1802-shff of Davidson County said Robert was not found. John Dickinson, appeared as attorney for Sarah Slaughter.

Decree

Shff has reported that Robert Smith Slaughter has not been found...proclamation having been made for three days ...affidavit of Benjamin J. Bradford that notice has been given in *The Tennessee Gazette* for four weeks...ordered that the bonds of matrimony be dissolved and that said marriage be from henceforth null and void and further decreed that all the property both real and personal heretofore belonging to the said Robert Smith Slaughter in the State of Tennessee be transferred to and vested in Sarah Slaughter, her heirs, and that Sarah Slaughter pay the costs of this petition.

Lytle Creek or Old Brown Graveyard, Maury County, Tennessee

In 1938 when this cemetery was read by Mrs. Annie Hackney and Mrs. Annie McKibbon, the graveyard "was located three and one-fourth miles south of Columbia, Tennessee, on Lytle Creek" and was said to be one of the "first burying grounds south of the Duck River. It is situated near the Mooreville pike one half mile across the creek from the road on a high hill in a wood lot." The 1938 introduction continues: "The land was once the property of Colonel Joseph Brown, noted Indian Scout and Cumberland Presbyterian Minister, and is now owned by the McLemore family. On the grave of Salina W. Hanes is a large oak tree growing from the tomb, which is almost one hudred years old. Many of the tombstones are broken and fallen on the ground, and many are unreadable. From appearance there have been more than a hundred graves."

"To the inscriptions copied by Mrs. Hackney and Mrs. McKibbon, are added three taken from a scrapbook compiled by Miss Susie Gentry, Franklin, Tennessee, now in the Tennessee State Library, which were copied many years ago from the tomb of Mrs. Jane Brown, Indian captive, and wife of Colonel James Brown, and her daughter, Mrs. Ann Anderson and Mrs. Anderson's husband, Captain William Anderson, Revolutionary Soldier." [end of the 1938 introduction]

BOOK REVIEWS

Earliest Tennessee Land Records & Earliest Tennessee Land History by Irene M. Griffey. Softback 6" x 9", 506 pp., appendix, maps, c2000. \$45 from Clearfield Company, Inc., 200 E. Eager Street, Baltimore, MD 21202 plus \$3.50 postage. MD residents add 5% sales tax.

At last a comprehensive index to Tennessee's early land grants has been published! The first portion of the book is devoted to a lengthy and well documented discourse on Tennessee's early land history, explaining how, when and why those early land grants in Tennessee were issued by the State of North Carolina.

Working from the index used by the North Carolina Land Office, Griffey has created an alphabetical listing of some 16,000 claimants providing file number, assignee if any, county, acres, grant number, grant date, entry number, entry date, book and page number from the North Carolina grant books, location (normally the creek or river where the land was located) and whether or not it was a military grant.

There is a separate alphabetical listing for assignees that provides the name of the claimant and the file number. Also included is a time line for legislative acts, information on Indian treaties and some helpful maps.

The ten years of work that went into this monumental publication are evident. It is a genealogical reference book chock full of good information that is certain to become a standard in its field. It is a "must" for anyone doing early land research in Tennessee.

Scotch-Irish Origins of General James Robertson by Sarah Foster Kelley. Softback 51/2" x 81/2", 129 pp., bibliography, endnotes, index, c2000. \$35 plus \$3 postage from E. S. Kelley Jr., 8225 Haley Lane, College Grove, TN 37046. TN residents add 8.25% sales tax.

This book is divided into three chapters with endnotes at the end of each. "Tracing The Scot-

tish Forefathers" deals with the early history of Scotland, the lineages of Scottish kings and the politics of the era.

"Religious Wars And The Stuart Dynasty" addresses those two topics and ends as the two Robertson brothers, John and Charles, were immigrating to America in their youth circa 1735.

"Destined From the Family Cradle" begins with the birth of James Robertson on 28 June 1742 in Brunswick County, Virginia to John Randolph and Mary (Gower) Robertson and retreats in time to include much of the family genealogy including data on the Gower and Randolph families.

As a direct descendant of General James Robertson, Kelley has used the information that has descended through the family to add to the documentation located in Ireland and Scotland by a hired researcher.

The every name index is a welcome and valuable addition to the book, although a magnifying glass may be needed to read the print.

Members of the Middle Tennessee Genealogical Society will be delighted to learn that this long awaited book is now available. Prepared like its predecessor, the *Index to the 1880 Census of East Tennessee*, it lists the head of the household, age, race, sex where otherwise in question, county and page number in the census for each household.

Only households with children aged 10 and under were listed in the 1880 soundex. Thus, this book may be the answer to your genealogical prayers since it lists all heads of households and includes those

persons living in households where the head had a different surname.

The Sistlers are to be commended for undertaking this enormous project and are encouraged to continue with a similar publication for West Tennessee.

Index to the 1880 Census of Middle Tennessee is certain to be a valuable and enduring tool for Middle Tennessee research and is well worth its price tag.
