Sometimes wills were contested. This meant that the heirs were frequently in and out of court for years after the death of their loved one. Therefore, the researcher should search the records for several years after the filing of the will to see if this was the case.

Most often, guardians were appointed for children who had not reached their majority. If these children were willed slaves, many times the slaves were hired out while the conditions of the will were being met or until the child came of age. The income from their hire had to be reported to the courts. The names of the slaves and the amount that they earned will be in the probate court records.

An inventory of the estate might also list the names as well as the ages of the slaves. Sometimes a brief description accompanies the entry. For example, "Jeff, scarification of face." "Yellow Mary." "Tom, an idiot." Old Dicey. "Their purchase, if sold, or their draw by the slave owners' family members will thereby create a document listing the slaves by name.

The researcher should check to see if Emeline was listed in any family member's will as part of a family group. For example: "1st family of Negroes: Big Jeff and wife Mary, children Peter, Jincy, Jimmy, Emeline, Gus." There is a strong likelihood that the researcher just identified Emeline's sisters and brothers. Further research would be needed to prove it, however.

EARNING THE NAMES AND LOCATIONS Iof the slave owners' parents, his sisters and brothers, and learning who intermarried with whom also serve as clues. Information presented in this diary indicates that J.H. Bills had a brother, Dr. Bills, who lived near Frankfort, Kentucky. Bills' mother lived in Maury County. Did J.H. Bills' father die in Maury County? Did he leave a will? If so, are slaves mentioned? Were the slave families divided amongst the heirs or were they sold in order to settle the estate? Many times slave families were separated by wills. At other times they were hired out to family members. Having this information allows the researcher to look into the records created for those individuals to see if a family member might be there. The whole idea is to locate as many ancestral generations as possible, so having answers to these questions is vital.

The following list had no heading, but it appears to be a list of slaves living on one of the plantations owned by J.H. Bills, along with their values. Information of this type was needed for tax records.

The reader can make several assumptions about the individuals in the list based on their valuations. Those with lower prices were usually young children or were individuals who were too old to work in the fields. Older women served as caregivers to the children of the field hands, cooks for the field workers, or they performed other tasks that didn't require much physical labor.

#### Friday, Mar. 1, 1848

"Richard, son of Andrew and Lavenia born this day."

#### Thurs., Mar. 1, 1849

"Paul T. Jones is married to my daughter in law, Miss Jane Margaret Wood."

(This clue serves to inform the researcher of another place to look. Was a slave given as a wedding gift? Check deeds for this time period to see. Deeds of gift as well as bills of sale can be found in deeds.)

"My servant, Lucinda was born unto her son."

#### Friday, Oct. 13, 1854

"Line, alias Emeline at the Hickory Valley farm is delivered of a son Paul."

#### Monday, Oct. 30, 1854

"The girl Marcha, wife of Willis, is delivered of a daughter this morning... Her mother says, 'She makes quick of it' and seems distr??? to comfort her by telling her such things often happen with the first born, but never afterward."

#### Monday, April 14, 1856

"My woman Lucinda has a fine boy this morning. It is her seventh son living. She has brought forth eight sons — never had daughters."

The information above suggests several things. First, that the slaves were allowed to have some farming activities of their own, and that they sold some of their goods to their master. Secondly, it informs the researcher of the names of some of the slaves who were on the plantation in 1856.

#### Sept. 26, 1857

"Wilson has been sick 4 weeks today and is not able to walk..."

#### Saturday 24, 1857 (month not indicated)

"Gave out shares to Negroes at Hickory Valley for sizes in back of this book"

Note: A list is in the diary but due to space restraints, it will not be presented here.

#### Dec. 15, 1857

"Our favorite woman, Sarah, beyond hope."

#### Dec. 16, 1857

"Sarah died last night at midnight precisely. She was a faithful servant, has been in my family upwards of 20 years and contributed to the raising of all my children. She is much lamented by all of us, esteeming her as one of the family."

"She has had no children and died suddenly from effects of cold, or we think."

#### Sat., June 19 (year not indicated)

"My man Sam is admitted a member of the church and baptised (sic) by sprinkling." (Presbyterian)

#### Sat., 28 (month nor year is given)

"Coleman and Sarah have a daughter born today, which makes my present number of slaves 80—all I have given my children."

#### Dreadful Death.

"Nashville Clarion. July 5, 1814.

Charles Baker in perfect health died on Trace Creek in Williamson County on Sunday last. He was a profane wicked man, of turbulent passion, and much given to blasphemy. On the morning of his death he attempted to make a calf suckle a cow that was not willing to do it. In scuffling to do it, the calf escaped, and he, as was usual with him, pursued the calf with the most blasphemous language, and all at once fell down dead. As he fell, he exclaimed, 'Lord have mercy on me,' and died as soon as if shot through the head. In a short time, the corpse was as black as a hat."

#### Insurance Records of Nashville and Other Middle Tennessee Inhabitants, 1850s, Part II

The Metro/Davidson County Archives has a rare book used by insurance agents in the years immediately preceeding the Civil War, showing buildings, wares, locations and values for Nashville and surrounding areas of Middle Tennessee. The material gives us the name of owner, exact location and description of the building, contents and use of the structure.

A related map, also located in the Nashville/Davidson County Archives, is printed at the beginning of the first part of this article, Vol. XV, No. 1, p. 24.-Ed.

No. 68.... D. G. RUMSEY................. Nashville....... 10 March 1857 \$1500 on his stock of Groceries, Wine & Liquors contained in the lower story of the two story Brick building with shingle roof, situate on the East side of North Market street, operated as a Family Grocery and the other story by E. Richards as a Boarding House.

No. 69 .... Abram L. DEMOSS ...... Nashville...... 7 March 1857 \$1000 on his two story Brick building with shingle roof and Ell attached of same materials, situate on the West side of South Market street, occupied at present by the Protection Ins. Co.

No. 70 .... Charles B. HALL.....Nashville.......... 14 March 1857 \$2000 on his stock of Boots, shoes, hats, caps & trunks contained in the three story Brick building with shingle roof, situate on the South side of the Public Square, known as #18, occupied as a shoe store.

No. 71 .... QUICK & MEADE ......Nashville..... 14 March 1857 \$2000 on their stock of flour, grain, feed and country produce, contained in the two story Brick building with shingle roof, situate on the East side of South College street; the upper story occupied as a dwelling, the lower story partly by Hamilton as a shoe store and partly by the assured as a Flour & Feed store.

No. 73.... W. Y. ERSKIN............Nashville...........24 March 1857 \$1000 on wines & Liquors in barrels & packages, contained in an apartment (opening on College street) in A. Hamilton's Brick warehouse.

No. 74....A. Crooker................Nashville..........27 March 1857 \$2000 on his stock of millinary & dress goods contained in the three story Brick building with tinned roof, situate on the North side of Union street, known as #30, occupied by the Assured as a Millinery Store & Dwelling.

No. 75..... G. W. DONNIGAN ...... Nashville...... 4 April 1857 \$2000 on his stock of Jewelry, watches, silver & plated ware and other goods in the line of Jewelers, contained in the three story Brick building with metal roof, situate at the NE corner of College & Union streets; occupied by the assured as a Jewelry store, except the 2nd story which is used at present as a Daugerian gallery. [Tenn. M. & Y. Ins. Co.]

No. 77..... Geo. D. HAMLET..... Nashville ........... 8 April 1857 \$400 on his two story frame building with shingle roof, situate on the East side of Vine street, just beyond Damumbrane street, as a family residence.

\$3000 on steam engine, horse powers? and other machinery contained in their Brick warehouses, covered partly with shingles and partly with metal, forming an Ell and fronting on Broad & Water streets; occupied as a wholesale Grocery, storage & Commission House.

#### About to Leave My Home: Jesse D. Bond's Trip to California

"I Jesse D. Bond being about to leave my home in Sumner County for a time with intention to go to California do nominate and appoint by these presents James Padgitt my Attorney in fact and general Agent to transact all my business in the State of Tennessee in my absence of every Kind and description to attend to all my Collections, carry on my farm, buy and sell and do all other matters and things for me and in my name to give acquittances and whatever he may consider best and necessary for my interest and that of my family hereby ratifying and confirming whatever may be done by him lawfully for me in my name as fully as if I were personally present doing the Same myself and my Said Agent & Attorney is further authorized and empowered to employ other attorney & agents under him for any of the purposes aforesaid Witness my hand & seal this 9<sup>th</sup> day of April 1850."

[Signed by J. D. Bond; Registered in Sumner County, TN, 8 May 1850]

Why was Bond planning to go to California? Could he be one of the 49ers, a friend asked? The index of Walter T. Durham's book Volunteer Forty-Niners listed a Jesse D. Bond. Could this be the same man, we wondered; indeed it was the Sumner Countian who had made the Power of Attorney appointment above. Bond and John J. Hibbett, also of Sumner County, had organized a stock company to "acquire gold or money... in California." Bond, who was named manager, would be accompanied by his son, Thomas, Hibbett's son, James L., and three other men. John J. Hibbett remained at home. <sup>2</sup>

From Middle Tennessee to California in 1850, whether overland or by sea, was a long and arduous trip, and frequently the adventurers did not make it. Fortunately a lawsuit found in the loose record collection at Sumner County Archives confirmed that Bond reached California and had returned to Sumner County. The lawsuit was filed against him by John J. Hibbett 22 December 1851. According to Hibbett, Bond owed him \$832.50 by note, excluding interest but including \$120.50 that James L. Hibbett had advanced to him while they were in California. Hibbett told the judge that Bond had sold his "valuable tract of land on Rocky Creek3...and advertised his personal property except slaves for sale this next Saturday and is making every preparation to move to Texas." Hibbett asked the court to order attachment of Bond's property. An order was issued to Sheriff D.P. Hart 23 December 1851 authorizing him to attach Bond's property. On 25 December 1851, Sheriff Hart seized the slaves owned by Bond. In response to this lawsuit, a replevin bond "in the sum of \$2,000" was signed by Jesse D. Bond and Ransom L. Winne and filed with the court 24 December 1851, Bond was to appear at the next term of the Chancery Court "in April next [1852]." Apparently he made an appearance and settled his debt. The following notation appears on the filed document: "Dismissed April 5th 1852 by Complts."4

Although Jesse and his son, Thomas, left Tennessee in the spring of 1850, the census record dated 6 September 1850 included him and his son as follows:


Jesse D. Bond, a farmer, age 45, who was born in Virginia; his wife, Sarah, 44, born in Tennessee, and Thomas, 18, born in Tennessee. The value of their real estate located in District 2 was estimated to be \$2,000. 5 Jesse, Sarah, and Thomas Bond do not appear in the Sumner County census after 1850.

Did they go to Texas? A search of the 1860 census records of Texas was inconclusive. The index of the 1860 Federal Census for Texas listed several Bonds including a Jesse Bond in Brown County and a J.D. Bond in Harris County. The microfilm for those two counties was read. Jesse Bond of Brown County was only 34 and born in Mississippi. He was not the Sumner Countian we were looking for. The page of the Harris County census on which J.D. Bond should have been listed was unreadable, therefore we are left wondering where Jesse and Sarah Bond were living after the spring of 1852.

Although the family's new location could not be confirmed, it does seem clear that Jesse D. Bond, like the majority of the 49ers, left California without the wealth anticipated as he prepared for the trip in the spring of 1850.

#### A FRANKLIN COUNTY, TENNESSEE, TITLE ABSTRACT

This title abstract was found in the loose court papers of Coffee County, being an exhibit to the lawsuit of Arthur Crownover vs Planters Bank and Trust Co., et al, which was heard in the Chancery Court of Coffee County, Tennessee on 27 Nov 1916. This is the abstract of the title of Mrs. Lou G. Pattie. Notes made by the attorneys and abstractor are included in parentheses as found. Any notation by the compiler is set in brackets. A note at the beginning of this title states that this tract of land was part of two grants, to wit: From the State of Tennessee to Edward Harris, Grant No. 477 and second, the State of Tennessee to Absolom Tatum, Grant No. 64. These grants came down to Joseph Acklen.—BMM

STATE OF TENNESSEE TO EDWARD HARRIS. GRANT NO. 477. Dated Sept. 14, 1808, Recorded in Book "A", page 45, Register's office, Winchester. For military service, land warrant No. 2018 to William Meeks and assigned to Edward Harris for the following described tract of land: 228 acres lying in Franklin County, Tennessee in the 2nd District, 8th Range and 2nd Section on the waters of Boiling Fork of Elk River, beginning at a black oak and a double hickory on the east boundary line of said section 30 poles north of the northwest corner of Robert Mckaney's Occupant Claim of 200 acres, running thencewest 160 poles to a stake and pointers; thence north 228 poles to a black jack standing on a high point; thence east 180 poles to a black oak, post oak and hickory in the said section line; thence with the same 228 poles to the beginning. Surveyed on March 18, 1808.

EDWARD HARRIS To JOHN STROTHER. POWER OF ATTORNEY. Dated June 8th, 1808, No consideration, Proven in open court Davidson County, Tennessee, October session, 1810. Registered in Book "C", page 251, appointing said Strother attorney in fact, with general power to sell the lands belonging to said Harris in the State of Tennessee.

EDWARD HARRIS, BY JOHN STROTHER, ATTORNEY IN FACT TO WILLIAM JENNINGS. Warranty Deed, Dated Jany. 27, 1809, Proven in open Court at April Term, 1809, before A. Russell, Clerk. Registered on April 26, 1809 in Book "A", page 27, consideration \$684.00 cash. Conveying the above described 228 acres by metes and bounds, with exactly the same description as set out in the grant.

WILLIAM JENNINGS & WIFE, MRS. MARY JENNINGS To JAMES H. SHROPSHIRE. Warranty Deed, Dated Jan. 28, 1814, Acknowledged in Open Court, April 9, 1814, before E. Russell, Clerk, Registered Dec. 6, 1814, in Deed Book "B", page 232, Consideration \$520.00 cash. Wife signs and acknowledges

deed, but her name does not appear in the body of the deed. Acknowledgment regular, conveying 150 acres of the above described tract, to wit: "On the waters of Boiling Fork of Elk River, beginning at a stake and pointer on William Jennings' west line of 228 acres and being a part of said tract, running west 105 poles to a post oak; thence north 228 poles to a black jack standing on a high point, thence east 105 poles to a hickory; thence south 228 poles to the beginning."

(Note:-At this date [1915] it is immaterial whether the wife joined in the deed at all, as the title was not in her and all she could have claimed was homestead and dower, which has long since ceased to exist.)

JAMES H. SHROPSHIRE & WIFE, BETSY SHROP-SHIRE, To ALEXANDER YOUNG. Warranty Deed, Dated Dec. 21, 1818, Acknowledged in open court February Term, 1819, before John Spyker, clerk. Registered in Book "F", page 12, Consideration \$1650.00 cash, Date of registration not given. Wife's name does not appear in body of deed or in the acknowledgment certificate, but her name is subscribed to the deed, conveying the above described 152 acres and the description is identical with the foregoing deed. (Note:-It is not necessary for the wife to have joined in the deed at all as she only owned homestead and dower interest which have long since ceased to exist.)

ALEXANDER YOUNG To JOSEPH ACKLIN. Warranty Deed, Dated March 15, 1821, Acknowledged in open court November Term, 1822, before E. Russell, clerk. Recorded in Book "D", page 132. No date of registration, Consideration \$1650.00 cash. 152 acres described as above. (Note:- His wife did not join in this deed, but it is not necessary as she has no interest at this date.)

STATE OF TENNESSEE To ABSOLOM TATUM. Grant No. 64, Dated Feby. 24, 1808, entered August 12, 1807, Recorded in Book "A", page 58, at Winchester, Tennessee. Containing 2000 acres, lying in White County, 2nd District, Range 8 and Section 1, on the waters of Boiling Fork of Elk River, beginning at the northwest corner of said section on 3 black oaks and a post oak, running south crossing a creek, the waters of Dry Fork of Boiling Fork 800 poles to a white oak and elm; thence east 400 poles to a black locust and black ash about 20 poles east of Dry Fork of Boiling Fork; thence north crossing said Dry Fork several times 800 poles to a large post oak and hickory standing on the north boundary line of said section; thence west 400 poles crossing the said Dry Fork at 110 poles to the beginning. Surveyed on September 11th, 1807. (Note:- It will be observed that the grant states that this land is in White County. This was true at that time. All of the land in this section was at one time in Rutherford County: later on it was divided and this section was put into White County, and then later on it was divided again and this immediate section was made into Franklin County.)

ABNER TATUM To JOSEPH ACKLIN. Warranty Deed, Dated Sept. 17, 1812, Proven in Open court May session, 1813, before A. Russell, clerk. Registered June 11, 1813 in Book "B", page 164. Consideration \$1605.00 cash. "On the waters of Boiling Fork of Elk River containing 302 1/2 acres, more or less, beginning on Munford's line on a hickory 135 poles north of the southwest corner of a tract granted to Absolom Tatum of 2000 acres; thence north with Munford's line and the line of the original tract 22 poles to a black oak on said line; thence ease 220 poles to a black oak; thence south 220 poles to a stake; thence west 220 poles to the beginning."

JOSEPH ACKLIN To HIS CHILDREN. Will, dated March 25, 1841, Probated July 6, 1841, will Book No. 1, page 193. "I, Joseph Acklin of Franklin County in the State of Tennessee do make this my last will and testament: Item 1st; I direct that all my just debts be paid out of my personal estate in such manner as my executors may think most [beneficial] for the interest of my estate real and personal. Item 2nd: I leave my wife Sarah Acklin during her lifetime or widowhood three negroes- Dick, Dinah, and Malinda with the use of such a part of the personal property as may be necessary for the support and comfort of her and her children together with their education. Item 3rd: I give my daughter Kezia-Syras, Nance and Julia. Item 4th: I give my daughter Elizabeth-Tom, Clarissa and Manah. Item 5th: I give my daughter Mildred-Wesley, Luther, Theodora, and Parolee. Item 6th: I give my son Joseph-James, Paulina and David. All the residue of my property I direct to be equally divided between my four children above named. I hereby constitute and appoint Thomas Wilson and James Sharp of Winchester, Tenn. executors of this my last will and testament. In testimony whereof I have hereunto set my hand and seal, this 25 th of March 1841.

"The above mentioned negroes are to remain on my plantation for the general Benefit and good of my family until some one of the children marry after which they receive their portion

"Joseph Acklin (Seal)

"Signed and sealed in presence of P.S. Decherd, Ira Kinningham and David Decherd 1st Apr 1841. The foregoing is a true copy of the last will and testament of Joseph Acklin dec'd as appears on file now in my possession. Witness my hand at office this 6th day of July 1841. "Isaac Estill, Clerk"

Power, formerly Elizabeth A. Acklin and Thornton S. Pattie and Wife Mildred V. Pattie formerly Mildred V. Acklin, have title to and now hold undivided interests in a tract or tracts of land lying in the State of Tennessee, Franklin County, District No. 10, it being the tract of land on which Joseph Acklin, deceased, lived many years prior to his death and bounded as follows:

"Beginning at a stake the beginning corner of Lot No. 1 aforesaid—thence east along the lane the line of Lot No. 1 aforesaid dividing the spring 126 poles to a stake the southeast corner of Lot No. 1, thence north 26 poles to a stake in the line and one of the corners of the whole tract—thence east 20 poles to a black jack in the line between the whole tract and Wm. 

#### EARLY SETTLERS IN SEQUATCHIE VALLEY, TENNESSEE

By Dorothy Williams Potter

URING THE COURSE OF SETTLEMENT IN WHAT IS NOW TENNESSEE, MANY WHITES—in their eagerness to obtain choice land-sometimes "intruded" on Indian-held land. This brought much consternation to both the state and national government officials charged with keeping the peace on the frontiers.

Lists were obtained of these citizens "that settled themselves on Indian Lands, secured by treaty to the Cherokees..." for the purpose of removing them—with or without military aid. As one can see from the varying years given, this operation of removal was not always successful. Presented here is a group of people seated on Indian land that was partly in the southeastern section of Middle Tennessee. The spelling is given as written on the list.

In the 1809 report of Return Jonathan Meigs, he states that "Sequachee Valley" was 25 miles from the South West Point Garrison, (now Kingsport, Tennessee).



# Revolutionary War Soldiers with Montgomery County, Tennessee, Ties: Elisha Battle, Reuben Chapman, Samuel Northington, Sr., Samuel Northington, Jr., Samuel R. Smith, and John Turnley



In 1937 and 1938, WPA workers were sent out into the counties to record historical information in many forms,: bible records, cemeteries, and personal papers - just to name a few types. In Montgomery County, Tennessee, this included visits by Grace Spencer and Mrs. Johnnie Watson to women who apparently were current members of the DAR. Although available elsewhere in a different form, this information is more complete for it includes generations prior to the Revolutionary War, and therefore important to persons trying to piece together these early families. However, remember the scholarship available in 1937 may not measure up to current standards.

All of the following data is transcribed from these WPA reports. The typescript is called *Tennessee*, *Records of Montgomery*, *Historical Records Project No. 465-44-3-115*, and is housed in the Tennessee State Library and Archives in open stacks with a call "MT." —Ed.

#### **ELISHA BATTLE**

Ancestor of Mrs. Julia Howse (Battle) Powers, Wife of Douglas Bell Powers, 518 College Street, Clarksville, Tenn.

Elisha Battle was born in Virginia (Nansemond Co., N. C.) the 7th day of Jan. 1723 and died in North Carolina, Edgecombe Co., the 6th day of March, 1799. His place of residence during the Revolution was Edgecombe County, N. C.

I was born in Nashville, Davidson County, Tennessee. I am the daughter of Frank Battle, born 1841, died 1917, and his wife Sarah Elizabeth Howse, born 1842, died 1924, married 1866.

The said Frank Battle was the child of Joel Allen Battle, born 1811, died 1872 and his wife Adelane Saunders Mosely born 1814, died 1883, married 1836.

Elisha Battle assisted in establishing American independence, while acting in the capacity of Member of the Provincial Congress of North Carolina, \_\_\_\_, 1776 to Nov. 1776, and State Senator 1777, 1778, 1779, 1780-1783.

#### ANCESTOR'S SERVICES

Elisha Battle's in assisting in the establishment of American Independence during the War of the Revolution were as follows: He was a member of State Congress of North Carolina which met at Hillsboro April 1778 and voted to empower our delegates to vote for Independence, the first of the "Original Thirteen States." He was on a committee and voted for troops and supplies. He was a delegate to State Congress which met at Halifax, N. C. Nov. 1776 and which adopted the Constitution of free North Carolina. He was State Senator from Edgecombe Co. 1777 to 1783, (inclusive, except 1782) and voted for heavy taxation and the raising of troops.

Member Com. of Safety, Edgecombe Co.; member Gen. Assembly, serving 20 years; member, Provincial Congress, Halifax, N. C.; member Congress forming State Constitution. Delegate Constitutional Convention serving as Chairman Com. of Whole. State Senator. (See DAR. Nat. No. 75,527 & Nat. No. 160,808)

resident of Granville Co., N.C. born on East Side of West Brush Creek, Warren Co. N.C.

It is stated that he was married when he enlisted the second time, name of wife not given & it is not stated whether there were any children.

Samuel R. Smith is buried near the border line of Christian Co. Ky. and Montgomery Co. Tenn. in the Smith family burying ground. The marble slab which marks his grave states that he was a soldier in the Revolutionary War.

Supreme Court Records, Box 38, Middle Tennessee, 1826

Standley Johnston by his attorney James Scott vs.
Jacob Johnston
(Original Bill heard in Perry County)

On 26th day of April in 1826 Standly Johnston by James Scott his attorney filed...an original bill against Jacob Johnston, to wit: Orator Standly Johnston a citizen of the County of Perry, that on 8th December 1823 one William Johnston then of Perry County but since deceased sold to your orator for \$136.00 one half of Lot #12 in the Town of Perryville being the half nearest the Tennessee River....

#### William Brackin vs. Andrew Jackson and William Martin (Original Bill heard in Sumner County)

Your Orator Wm. Brackin of the County of Sumner and Sate of Tennessee begs leave to represent to your honor that some time prior to the 5th day of October 1796 perhaps in the month of April 1796 one Andrew Jackson executed to one Jacob Pyrtle a bond for \$150.00 as he is informed and believes to convey to the said Pyrtle by deed in fee simple 160 acres of land so soon...as the sd. Pyrtle should make choice of the same out of a 1,000 acre tract of land which the said Jackson owned and

was granted by the State of North Carolina to John Rice, Abraham Preston and Elisha Rice assignees of the heirs of Domini[?] Dominey[?] by patent 13th June 1787...

State of Tennessee, Sumner County. Court April Term 1813

The within deed of bargain and sale between Andrew Jackson of the one part and William Brackin of the other part for 160 acres of land was duly proved in open court by the oaths of George Crockett and Thomas Culbert subscribing witnesses thereto and ordered to be registered...

I Andrew Jackson of Davidson County and State of Tennessee am held and firmly bound unto Jacob Pyrtle of Stokes or Rockingham County and State of North Carolina in the penal sum of \$300.00...this 25 April 1796. [signed] Andrew Jackson

Byrne, Extr. of Steinbeck vs. Lorimier & Rutherford

(Original Bill heard in Humphreys County)

Know all men by these presents that I William Lorimier of Reynoldsburg, Humphreys County, State of Tennessee for \$500 paid by Dl. F. Steinbeck of Cape Girardeau County State of Missouri ... have sold unto the said Daniel F. Steinbeck the following slaves, to wit, James a negro man about 28 years of age and Cheyne a negro girl about 14 years old to have and to hold...forever, provided nevertheless that if the above mentioned William Lorimier...shall and do pay...unto the said Dl. F. Steinbeck...the aforesaid debt or sum of \$500 on the fourth day of July 1822....

The answer of Henry Rutherford to the bill of complaint of Daniel F. Steinbeck against William Lorimier ... says that in June 1823 he purchased from Robert Armstrong of Nashville a judgment on James Rutherford of Humphreys County, that in July following at Reynoldsburg he let the said James Rutherford have the judgment for the following consideration, to wit, a negro girl named Cheyne at \$400 a horse at \$50 and his note of hand for \$50. At the time said James had the negro in possession and told this defendant that he had purchased her from William Lorimier but had not taken a bill of sale and that Lorimier would make him one to which this defendant agreed to; accordingly took one without any knowledge of any other person having any claim to said negro girl...[signed] H. Rutherford

Know all men...that we William
Lorimier, James Lankford and Jno. C.
Morrison all of County of Humphreys
are bound unto Daniel F. Steinbeck
in the penal sum of \$1,000.00....

Edward Gwin, Sr. vs. James Adams, Solomon Rosel, Samuel Woods & Edward Bucy (Original Bill heard in Circuit

(Original Bill heard in Circuit Court of Carroll County)

Humbly complaining...your orator Edward Gwin, Senior of the County of Carroll and State of Tennessee that sometime in the year 1797 a certain James Adams of the state of South Carolina put into the hands of your orator a mili-

tary warrant containing 640 acres belonging to him the said James Adams, that it was agreed between your orator and said James Adams that your orator was to locate said warrant and superintend the surveying of the land upon which said warrant should be located for which services your orator was to have from the said James Adams onefourth part of the land so located which agreement between your orator and the said James Adams was reduced to writing and placed in the hands of a certain Peter Lemmons, dec'd. of Sumner County and State of Tennessee...That in pursuance of said agreement between your orator and the said James Adams, your orator went on located and obtained a grant therein from the State of North Carolina and your orator further sheweth that sometime after the issuance of said grant that a certain Solomon Rosel now of the county of Henderson and State of Tennessee came to your orator and represented himself as the agent of said James Adams to divide and set apart to your orator his portion of the said 640 acres of land...

The land was located and granted upon Station Camp in Smith County. About 1804 Adams sold to Rosel, and he to James Turner. Rosel was to settle the interest of Gwyn for locating by giving him 1/4 the land—203 acres were laid off to him of the poorer part of the tract, but no conveyance made. Still the partition was evidenced by writing between Rosel & Gwyn. Afterwards, (when does not appear) 453 acres of the grant was taken by an older grant of Anthony Hart; about the first of the year 1820, Gwyn drew the warrant for the interference of 453 acres in the name of James Adams the grantee, which on the 24th July 1821 he caused to be located in Carroll County.

John Gwyn was the locator of the Entry of 1821. Woods applied to him to buy the locating interest, Gywn told him that Edwd. Gwyn was the owner of the interest in part of the Entry, and stated to him all the circumstances of Ed. Gwyn's claim.

Woods presently sent an agent to So. Carolina and purchased the 453 acre for \$280.00 and immediately turned about and sold it to the deft. Bucy for \$800.00....

> Lee vs. Jugg (Original Bill heard in Humphreys County)

And now at our September Term, to wit, Sept. 19th 1827 -Priscilla Sugg vs. Anthony Lee. Trespass.

This day came the parties aforesaid by their attornies and thereupon came a jury of good and lawful men, to wit, Peter Black, Hosea Roberts, Timothy Anderson, Alford Evans, John Johnson, Samuel H. Burton, Burwell Lashlee, William Prince, Charles Winsted, Edmund Wildridge, Lewis Barker and Hillory Capps who...do say that they find that the plaintiff Priscilla Jugg is not a slave the property of the sd. Defendant as in pleading he hath alledged, but that she is a free woman and they assess the plaintiff damages by reason of the trespass aforesaid to fifty cents besides her costs....

Be it remembered on the trial of this cause the plaintiff produced in evidence the following depositions, to wit, the deposition of William Ezell, Richard Stone, Joseph Colson, Humphrey Nelson & Elizabeth Russell. The plaintiff then introduced Samuel Jordon who proved that he was raised in Brunswick County, Virginia and raised in the neighborhood of Josiah Floyd and whilst a boy 12 or 15 years old he was in the habit of visiting his grandmother who resided about 21/2 miles from Floyd and also his uncle Winfield who resided about two miles from said Floy and that he became acquainted with Priscilla Jugg the present plaintiff at this uncle Winfield's and that she had been placed there by Floyd as a nurse and appeared to be then ten or twelve years of age, that he frequently saw her there and she was then reputed to be of a free race of people and to have been descended from Indian ancestors, and that her grand mother Nany Jugg was reputed to be an Indian and that she had remained among the white people when the Indians were driven frm that part of the country, that he frequently saw Franky Jugg the mother of Priscilla Jugg at his uncle Winfield's and at his grandmother's and at no other time than on Sunday and visiting her daughter Priscilla, and at one time he saw Judy Jugg the sister of Franky Jugg with the said Franky at his uncle's visiting the said Priscilla, that they were yellow complected but does not recollect anything of their eyes or hair, and that they were generally reputed to be of a free race of people.

Said Priscilla Jugg was afterwards reputed to have been sold by Floyd to one Daniel Shelton a Tailor residing in the neighbourhood two or three miles from said Floyd's and by said Shelton she was sold to one Ezzel residing ten or twelve miles from said Floyd's, and that after the this time the said witness heard of a suit having been instituted in Brunswick by a brother of the said Franky Jugg and an uncle of the said Priscilla claiming his freedom, and that he died before the termination of the suit, and that the said Ezzel as it was generally reported ran the said girl Priscilla off to North Carolina to prevent her getting her freedom, that in the year 1817 the said Jordon removed to Montgomery County in the State of Tennessee and shortly after that time said Priscilla Jugg came to see him and that they then had much conversation as to her relations and that he was satisfied that the said Priscilla was the same girl that he had been formerly acquainted with in Brunswick County, and thinks

that he should have known her from her resemblance to the family. Jordon also proved that he resided seven or eight miles from Floyd's, that he never saw Priscilla or her mother going about the neighborhood in which he lived. Jordon also proved that when he left Virginia in 1817 the Jugg family were all run off from that section of the state as he understood, and that most of the Floyd family had removed to other sections of the country....

## Henry Rutherford vs. John Wheaton

(Original Bill heard in Williamson County)

Humbly complaining your orator Henry Rutherford of Madison County in State of Tennessee that in the year 1785 he was employed as a deputy surveyor under William T. Lewis principal surveyor of the Western District of the State of North Carolina to make surveys in that section of country and amongst others he made surveys of 97,000 acres of land in the name of Benja. Smith plats and certificates of which surveys were regularly made out and returned to the Secretary's office of the State of North Carolina and grants issued thereon, for which services your orator was entitled to receive \$248.00 being half fees the other half his principal was entitled to but no part of which was ever paid of said lands there. Surveyed for and granted to Benjamin Smith were eleven tracts of 5.000 acres each lying on the South Fork of Forked Deer River and its waters and within the jurisdiction of this court, numbers of grants 400, 401. 402, 403, 407, 410, 411, 412, 413, 414 & 415 which on the \_\_\_[blank] day of [blank] were conveyed by said

The Indian title to that section of country where said lands are situated

Smith to Daniel Wheaton...

was not extinguished until the year 1819 before which very little was known respecting that part of the country and still less of the locality of the surveys which had been made in consequence of which much difficulty existed in establishing the surveys. Indeed without the information of your orator aided by his field notes many of the tracts could never have been established. Your orator would state that said Daniel Wheaton in whom the title of said eleven tracts of 5.000 acres each was vested many years ago departed this life intestate leaving Sterling Wheaton and John Lord Wheaton his heirs at law of whom William Wilkerson of Williamson County was their guardian....

#### Robert Nelson's lessee vs. William Griffin & others

(Original Bill heard in Williamson County)

This cause came on to be tried before a court and jury when the plaintiff to maintain the issue on his part proved that the land described in the plaintiff's declaration had been granted to his father Alexander Nelson, and that he was his only son and heir as will more particularly appear by the facts agreed, which are contained in the paper hereto annexed... The defendant to shew the title out of the lessor of the plaintiff offered in evidence the record of the suit Russell Gower vs Alexander Nelson and the administrator of said Alexander and the judgment upon the Scire Facias against Robert Nelson heir of said Alexander, which is hereto annexed...and also read a copy of the Sheriff's amended return to the execution and the clerk's certificate of and the appointment of a guardian and the guardian bond hereto annexed....

John Den Lessee of Thomas T. Bouldin executor of David Ross and others, Pltffs. Vs William Crockett, Pharoah B. Cobb, Jas. Hatfield, Frederick R. Cobb Elizabeth Cobb, Mary Cobb, Sarah Cobb and Barsheba Cobb, Defts. Ejectment.

...on 13th May 1818, William Crockett a citizen of the State of Tennessee was attached to answer John Den Lessee of Thomas T. Bouldin, Executor of the last will and testament of David Ross, dec'd., Jacob Myers and Elizabeth his wife John Duffield and Amanda his wife David Ross and Frederick A. Ross all citizens of the State of Virginia in a plea wherefore with force and arms he broke and entered the close of said John Den and ejected him therefrom to his damage of \$500.00....

# Supplement of the INDEX to TENNESSEE CONFEDERATE PENSION APPLICATIONS An Index to the Pension Applications by County of Residence

Contributed by the Tennessee State Library and Archives

#### INTRODUCTION

In 1964 the Confederate Pension Applications were indexed and published in book form by the Tennessee State Library and Archives. Long out of print and noting additions and errors were found, Chuck Sherrill, Director of Public Services at the State Library, approached Sam Sistler about updating and reprinting the book. Sam consulted microfilm and original applications when necessary to confirm information, and prepared a computer data base. From this file, a new book was issued. It is an alphabetical state-wide listing entitled *Index to Tennessee Confederate Pension Applications*, transcribed and edited by Samuel Sistler (1994), and is available from the Byron Sistler & Associates, P.O. Box 120934, Nashville, TN 37212.

After publication of this 1994 book, the Archives asked Sam to resort the data base by counties and the one copy of this listing was bound and placed in Archives under the call E548.S57, 1995 Suppl. It is part of this unpublished supplemental that is being presented in the Journal.

The Confederate Veteran Pension applications, numbering over 16,000, are on microfilm in the Tennessee State Library and Archives, Nashville, Tennessee. (e-mail: reference@mail.state.tn.us) While most of the Confederate veterans pensioned under Tennessee law served in a Tennessee unit, one must be aware that Confederate pensions were granted by the state in which the veteran lived at the time of application regardless of the state in which the soldier enlisted. Some applications contain information about service, as well as personal history. In questionnaire form, other information may be included such as place of birth, number of children, and value of property owned by the veteran.

To His Excellency, the Governor of Alabama, Montgomery, Ala.

Sir: -

I herewith enclose you a requisition for W.R. Patty, a fugitive from justice of this state, which I respectfully request that you grant and forward the requisition, together with the commission from the Governor of this State to Mr. B.H. Dudly, Ft. Payne, Ala. If there are any fees accruing in the State of Alabama, your secretary can either send the papers by express, C.O.D. to Mr. Dudley, or send a statement of the fees to Mr. H.M. Templeton, Winchester, Tennessee, who will pay them.

#### JACK RAINES RETURNS

Pulaski Man Pays Fines and Costs at Huntsville, Ala.

Huntsville, Ala., Feb. 8 – (Special) – Jack Raines, who eloped from Pulaski not long since with Miss Ella Hays, of that place, is again in the city, and has paid off the fines and court costs held against him in Pulaski, which are about \$2,000. He says he will never return to his home.

Flournoy River, Counselor at Law Pulaski, Tenn. Feby 10<sup>th</sup> 1901

Hon. Thos. D. Samford Governor of Alabama Montgomery, Ala.

Dear Sir:

The enclosed clipping is [certain?] Raines has returned to Huntsville where it seems he practically defies the law. The Sheriff of this County goes there today to try to arrest him. The forfeiture proceedings against his bond there are set for tomorrow.

As far as he could do so Raines has bought off his wife for \$300 but the prosecution for abduction – the only real matter except divorce – is pending here.

When our Sheriff arrests Raines [illegible] you will be telegraphed to that all proceedings here have been dismissed. Hence I write you at the request of Robert Hayes the father of the girl. He is the prosecutor and he asks me to say to you that he has dismissed nothing and intends to prosecute Raines to the fullest extent and that nobody has tried to dismiss anything for him because that is impossible. He hopes you will have Raines extradited. Raines will ask you to revoke your warrant. Hayes asks you not to do so. I am also authorized by Dist. Atty. Boyd who is at Waynesboro to ask you to give your aid to extradite Raines and not to revoke your warrant.

#### **BOOK REVIEWS**

Passports of Southeastern Pioneers, 1770-1823. Indian, Spanish and Other Land Passports for Tennessee, Kentucky, Georgia, Mississippi, Virginia, North and South Carolina by Dorothy Williams Potter. Softback 6 x 9, 449 pp., bibliography, footnotes, illustrations, index, c2001. \$37.50 plus \$3.50 shipping and handling from Genealogical Publishing Company, 1001 N. Calvert St., Baltimore, MD 21202. 1-800-296-6687. Item #CF-4683.

Although it seems unusual to associate passports with travel within what is now the United States, these passports authorized passage through Indian or foreign-held territory east of the Mississippi River during the period 1770 to 1823. The earliest passports were given to persons entering the Indian nations to trade, collect debts, recover stolen horses and slaves, remove the property of white intruders or just to pass through for a multitude of reasons. Sometimes depositions for passports or letters requesting them survived while the passports did not. The sources are cited for the various collections where the passports were located.

This is a comprehensive collection of unique records spanning a time period in the southeast when records are sparse. Originally published in 1982, the many reprints of this book are an indication of its value to researchers.

Confederate Settlements in British Honduras by Donald C. Simmons, Jr. Softback 6 x 9, 176 pp., footnotes, appendix, c2001. \$27.50 plus \$4 first book .75 each additional from McFarland & Company, Inc., Box 611, Jefferson, NC 28640. NC residents add 6% sales tax.

During and immediately after the Civil War, Confederate sympathizers and former soldiers sought exile in other lands. Evidence suggests that more went to British Honduras (now known as Belize) than any other single site. The majority of these settlers came from Louisiana and the surrounding gulf states.

Simmons looks at the settlements established by former Confederates, what the trip was like, what life was like for the immigrants in the various settlements and the many problems they faced. Many of the immigrants, although not all, eventually returned to their own countries.

Included are lists of arrivals at the hotels and passenger lists from the ships that will help to locate Confederate ancestors. Some provide name, age, sex, profession and country and state of origin.
